

1 - Introduction

Inspection Profile:

on January 18, 2018, Industry Operations Investigator (IOI) initiated firearms compliance inspection at the licensed premises of Jeffrey D. Miller t/a Clear Spring Gun Shop, located at 14036 National Pike, Clear Spring, MD 21722. During the inspection, IOI (b)(6) interviewed Mr. Jeffrey Miller, owner. Mr. Miller provided a valid Maryland Driver's Licenses for identification. The inspection period was January 18, 2017 to January 18, 2018. On January 31, 2018, IOI (b)(6) held a closing conference with Mr. Miller. Advanced notification was not given prior to the initial visit.

Business Profile:

Clear Spring Gun Shop is a full service gun shop offering new and used pistols, revolvers, rifles, shotguns, lower receivers, ammunition and accessories to the general public. Mr. Miller also holds a separate ATF license as a Manufacturer of Firearms Other Than Destructive Devices (FFL: 8-52-043-07-9B-05678), which was being inspected by IOI (b)(6) concurrently. It should be noted that the licensee has not yet begun operations under the manufacturer's license. (See UI: 761025-2018-0103)

The business premises is a commercially zoned storefront structure in suburban Washington County. The unit has a sales area with a glass display counter for handguns and a rack to display long guns. The licensee also has two gun safes in the store to secure inventory.

In the last 12 months, the licensee acquired firearms, and disposed of during the same period. A breakdown of handguns verses long guns is as follows:

- Handguns: approximately (b)(4) acquired and (b)(4) disposed.
- Long guns: approximately (b)(4) acquired and (b)(4) disposed.

Approximately (b)(4) of the firearms transferred by the licensee were new and approximately (b)(4) were used. (b)(4) of the licensee's sales activity is retail sales. The licensee's primary suppliers are (b) (4)

Clear Spring Gun Shop has held the subject ATF license since February 24, 2012. The licensee did not conduct business at guns shows during the inspection period, and does not intend to do so in the future. Clear Spring Gun Shop advertises the business through the company website at www.clearspringgunshop.com and offers firearms for sale over the Internet; however, firearms are only shipped to other licensees for customer pickup. No unrelated business is conducted by the licensee or at the licensed premises. The business is in compliance with State and local law, including zoning.

In addition to the two ATF licenses, the licensee holds the following State and local licenses:

- Maryland Regulated Dealer's License
- Maryland Sales & Use Certificate
- Maryland State Trader's License

All firearms are maintained at the licensed premises. The licensee does not have off-site storage for firearms.

Ownership and Control:

Mr. Jeffrey Miller is registered with the state of Maryland as a sole proprietor under Department ID: L14510069. The business currently operates under the trade name Clear Spring Gun Shop, which is actively registered under Department ID: L06280523. Mr. Miller is correctly listed in FLS as the sole responsible person on the license. There have been no changes in ownership or control since the license was issued. Hidden ownership is not suspected.

The licensee does not have any variances and none were requested.

4 - Acquisition & Disposition (A&D) Record - Inventory

At the time of inspection, the licensee's physical inventory consisted of 100 firearms, and the number of open dispositions in the acquisition and disposition (A&D) records was also 100. There was a difference of zero firearms. A full inventory was conducted by IOI (b)(6) and no discrepancies were found.

The licensee reported theft during the inspection period, which occurred on September 23, 2017. At that time, a burglary occurred in which two subjects broke into the shop after hours, while the business was closed. The burglary resulted firearms being stolen from the licensed premises. IOI (b)(6) conducted a full inventory at the time the incident was reported to confirm that missing firearms were properly reported to authorities and closed out of the licensee's records. (See UI: 761025-2017-0429). of the firearms have been recovered as of January 31, 2018; however, the licensee has not yet received either of them. The licensee maintains bound paper records. The A&D records were in the proper format. The entries were found to be accurate and timely made. IOI (b)(6) did not trace any firearms through the required records. No firearms with obliterated serial numbers and no illegal firearms were discovered. No indication of trafficking was found.

IOI (b)(6) reviewed the licensee's standard operating procedures relevant to A&D records and inventory with Mr. Miller. Mr. Miller has two employees that assist him in operating the business on a day-to-day basis. His son, Jeremy Miller is one of the two employees and manages the shop when he is not there. According to Mr. Miller, the staff is training to properly record acquisitions and dispositions in the A&D records and does a good job making sure the records are properly updated every day.

5 - ATF Forms 4473 – NICS & Other Dispositions

The licensee executed a total of ATF Forms 4473 during the inspection period. IOI (b)(6) reviewed all forms, which is 100% of the forms on file for the past year. The Forms 4473 are filed chronologically by disposition, and in order by transaction serial number, which is assigned in succession by the licensee. During the review of the forms, the following was discovered:

• The licensee failed to ensure proper completion of forms as prescribed by the headings on the ATF F 4473 and the instructions on or pertaining to the form. This occurred in (b)(6) instance. Reference Violation 1 and Worksheet 2.

- The licensee failed to ensure proper completion of ATF Form 4473 prior to making an over-the-counter transfer of a firearm to an unlicensed individual. This was reflected in firearms transactions. **Reference Violation 2 and Worksheet 2**.
- The licensee properly verify identity of the transferee by examining a valid identification document presented, and accurately noting on the Form 4473 the type of identification used. This occurred in instances. **Reference Violation 3 Worksheet 2**.
- The licensee to comply with requirements of 478.102 and properly record the date on which NICS was contacted, as well as any responses provided by the system. This occurred in system. Reference Violation 4 and Worksheet 2.

Forms indicating denials were reviewed by IOI(b)(6) and found to be filed properly. The licensee frequently transfers firearms to other licensees and IOI (b)(6) determined that such transfers were conducted properly. The licensee sold a small number of firearms to police officers for official use during the inspection period and such transfers were determined to be properly executed.

An FFL Audit Log Report for transactions involving (Maryland) non-regulated firearms and regulated firearms was requested for a 60-day time period. A total of 86 responses were provided. Of the 86 responses, 84 were proceed/not-disapproved and the remaining two were denied/disapproved responses. IOI (b)(6) compared the NICS Transaction Numbers (NTNs) on the audit log to the NTNs recorded on the corresponding ATF Forms 4473 and no discrepancies found.

IOI (b)(6) reviewed the standard operating procedures relative to ATF Form 4473 completion and other dispositions with the licensee. Mr. Miller indicated that his staff is trained to be able to execute the ATF Form 4473, including the background check with customers to complete over-the-counter transfers of firearms. He further indicated that staff members review the completed form with customers during a transaction to ensure proper completion, then once again before filing the forms. IOI (b)(6) reminded the licensee to pay closer attention to the forms to ensure that the errors found during the inspection are not repeated. Mr. Miller stated that he tries to conduct a second review of the completed forms before he files them away, but will be more consistent in the future.

6 - Multiple Sales

During the inspection period, the licensees records indicated that nine multiple handgun sales occurred; however, according to Violent Crime Analysis Branch (VCAB), no multiple sales were reported to ATF. Upon discovery, IOI (b)(6) asked the licensee if he was aware of the multiple sales requirement, and the licensee indicated that he was not. The results of the inspection indicated that the licensee failed to report the multiple sale of a handgun in instances, involving handguns. Reference Violation 5, Exhibit 1 and Worksheet 2

7 - Suspicious/Prohibited Purchasers

During the review of ATF Forms 4473 for the past year, no possible traffickers, straw purchasers, prohibited persons or other suspicious purchasers were identified. Open Fox criminal background checks were conducted on a total of purchasers. purchasers were chosen at random and the remaining purchaser was chosen because he answered "yes" to prohibiting questions on the ATF Form 4473. There were no hits as a result of this effort.

8 - Trace Activity

In the last 12 months, the licensee was associated with firearm traces.

of the firearms were successfully traced through the licensee's records. The remaining traces were prompted after firearms, previously reported stolen by the licensee on September 23, 2017 were recovered by authorities.

The licensee acquired and transferred approximately used firearms in the last 12 months. A total of 10 used firearms were selected by IOI (b)(6) to conduct secondary market analysis. There were no hits as a result of this effort.

9 - NFA/Importer/Collector/Manufacturer

Clear Springs Gun Shop does not deal in NFA firearms under the subject FFL; however, Mr. Miller is an active Special Occupational Tax payer as a Class 2 manufacturer under the Type 07 FFL. The licensee does not manufacture, import or collect firearms under the subject license.

No referrals were generated as a result of this inspection.

After the assignment was originally submitted, Area Supervisor (b)(6) discovered an error in the original Report of Violations (ROV), so on March 19, 2018 an amended ROV was emailed to Mr. Miller, who then signed and returned it to IOI (b)(6) on April 6, 2018.

12 - Closing Actions

On January 31, 2018, IOI (b)(6) conducted a closing conference with Mr. Miller, owner. At that time, a regulatory review was conducted, which included a review the Acknowledgement of the Federal Firearms Regulations form that was signed by IOI (b)(6) and Mr. Miller. Reference Exhibit 2. On that date, IOI (b)(6) issued a Report of Violations, which was also signed by both parties.

All materials referenced during the review were provided to the licensee, along with a list of ATF phone numbers and instructions on how to access the 2014 Federal Firearms Regulations Reference Guide electronically. In addition, IOI (b)(6) provided Mr. Miller a thumb drive with additional pertinent materials for industry members.


