1 - Introduction

Inspection Profile:

On February 21, 2018, Senior Industry Operations Investigator (b) (6) initiated an unannounced Firearms Compliance Inspection at the above stated location. The following Keystone Sporting Goods' personnel were interviewed, identified via Maryland driver's license and assisted during the inspection: Mr. Timothy Stahl, Secretary. The period of inspection was February 21, 2017 to February 21, 2018. Closing conference on this inspection was completed on March 16, 2018.

Business Profile:

Keystone Sporting Goods, Inc. is licensed as a Type 01 - Dealer in Firearms. The business is a medium volume dealer specializing in both new & used firearms (long guns and handguns) hunting equipment, fishing, and archery accessories. The business premise is a commercial stand-alone building in the rural area of Washington County and has been operating since 1993.

The licensee sells new long guns and handguns and during the inspection period (February 21, 2017 to February 21, 2018), he acquired (b) (4) irearms (b) (4) long guns and (b) (4) handguns) and disposed of (b) (4) irearms (b) (4) long guns, (b) (4) handguns and (b) (4) other). His primary supplier is (b) (4) Mr. Stahl currently did not have any firearms in for repair. Mr. Stahl stated that he does not participate in gun shows. The business does Internet sales and has the following website: www.keystone.sports.com. The business is not involved with black powder, consignment or NFA sales. All firearms are stored on the business premise. There was no off site storage location disclosed. The business does not have any government contracts.

The business premise is commercially zoned within Washington County, of which, he presented a zoning permit for the premises. IOI (b) (6) queried the address on the Real Property Search function of the Maryland State Department of Assessments and Taxation (SDAT) website. No other business is conducted within his business premise.

The licensee does not possess any other ATF licenses. The licensee also possess a Maryland Regulated Firearms Dealers License #064721, and a Trader's License #06829643. The FFL is compliant with State and local laws. This license is appropriate for this business activities.

4 - Acquisition & Disposition (A&D) Record - Inventory

A full physical inventory was conducted during this inspection period. A total of three discrepancies were found during the inventory and A&D book review (See attached Inventory and A&D Review Worksheets (3)). The A& D record was in proper format. There were 110 firearms found in inventory, and the books of the blank dispositions found in the A&D books. The licensee maintains three books: one for handguns and two for long guns. The licensee was put on notice to try and reconcile the firearms were still not accounted for. These firearms ultimately

could not be accounted for, and were listed on an ATF F 3310.11, Theft/Loss form which was submitted to ATF on 2/23/18 (See Exhibit 1). The firearms were logged out of the A&D Record and the ATF incident number was recorded on the disposition line, and the local police were notified of the theft/loss. These guns represented .07% of the total inventory. The licensee was cited for 27 CFR 478.125(e) for the above Inventory and A&D record violations, and issued an ATF F 5030.5, Report of Violations (See Violation #1 on the attached Report of Violations). A total of 15 firearm traces from acquisition to disposition were conducted. No trafficking issues were discovered. There were no obliterated serial numbers found.

5 - ATF Forms 4473 - NICS & Other Dispositions

During the inspection period (February 21, 2017 through February 21, 2018), ATF forms were completed for the inspection period in chronologically order, which were complete and logged out timely. Approximately, (b) (4) firearms were sold during the inspection period. Mr. Stahl stated that he and his two employees try to be diligent in maintaining good paperwork. No discrepancies were found. The licensee has standard operating procedures in place, such as, reviewing ATF Form 4473 accurately after each transfer in a timely manner. There were no law enforcement sales discovered.

Prior to conducting the inspection, IOI (b) (6) requested a list of NICS Transaction Numbers (NTNs) and Maryland State Police transaction numbers for the past 60 days. NICS responded stating they had no transaction numbers on hand associated with this dealer. Maryland State Police had 13 proceed associated with this dealer, which were verified.

6 - Multiple Sales

According to The Violent Crime Analysis Branch (VCAB), for the inspection period, this business was associated with multiple handguns sales involvin irearms. No unreported sales were disclosed.

7 - Suspicious/Prohibited Purchasers

Investigator (b) (6) did not identify any possible traffickers or suspicious purchasers. No referrals were generated as a result of this inspection.

8 - Trace Activity

According to The Violent Crime Analysis Branch (VCAB), for the inspection period, this business was associated with successful firearm trace requests and no unsuccessful traces were reported within the last 12 months.

9 - <u>NFA/Importer/Collector/Manufacturer</u>

This business is not engaged with any NFA, Importer, Collector or Manufacturing activities.

10 - Referrals

No referrals were generated as a result of this inspection.

11 - Other

GPS coordinates (N39.68732/W077.72048) were obtained for the area office file. No derogatory information was disclosed. Mr. Stahl had all required licenses posted. The business was in compliant with the Youth Handgun Safety Act and the secure gun storage or safety devices requirement.

12 - Closing Actions

A closing conference was held on March 16, 2018. Present at the closing conference were Mr. Timothy Stahl, Secretary and Investigator (b) (6) A Report of Violations was issued for this inspection period and Mr. Stahl understood and signed the Report of Violations (ROV). Acknowledgement of Federal Firearms Regulations Checklist was reviewed with Mr. Stahl (See Exhibit 2). A copy was given to Mr. Stahl as a reference, to assure no repeated occurrences. An Important Telephone Numbers list was provided.

13 - Violations


