1 - Introduction

Inspection Profile:

On 02/14/18, Industry Operations Investigator (IOI) (b)(6) initiated an unannounced Federal Firearms Compliance Inspection at the licensed business premises of George C. Eckhoff Jr. dba George's Barber Shop, at 200 N. Locust St., Wright City, MO 63390. The inspection began 02/14/18 and ended 02/15/18. The scope of the inspection was 02/14/17-02/13/2018. On the first day of the inspection, IOI (b)(6) was unable to complete a full inventory due to some records not being on premise. IOI (b)(6) completed the inspection the following day once licensee brought all the records back to the business. Licensee stated he took the records home because he was updating his books (this was the same situation from previous inspection).

George Eckhoff (owner/responsible person) was available for inspection; positive identification verified.

Business Profile:

The business operates as a store front located inside of licensee's barber shop located in suburban Wright City, Mo. The licensee is in the business of selling and buying primarily new handguns and long guns. During the past (12) months, licensee acquired (b)(4) firearms; (b)(4) hand guns, (b)(4) guns, and (b)(4) frames. Licensee disposed of (b)(4) firearms. The business inventory consist of (b)(4) new firearms and (b)(4) used firearms. The main supplier used by the licensee is (b)(4). The licensee does not participate in gun shows. Licensee does not have any other ATF licenses.

Licensee is compliant with local and state zoning requirements to include Missouri Retail Sales license and Warren County Merchants license. The licensee has held an ATF license since 1976.

Ownership and Control:

Business is listed as individually owned, with George Eckhoff listed as owner/rp. IOI (b)(6) did not suspect any form of hidden ownership. No responsible persons added or removed from license.

4 - Acquisition & Disposition (A&D) Record - Inventory

Investigator conducted a full inventory. At the time of inspection, there were (b)(3)(12) firearms in inventory including (b)(3)(11) open dispositions, resulting in (b)(3)(11) firearm discrepancies. All firearm discrepancies were reconciled. There were (b)(3)(12) firearms traced through licensee's records during the past (12) months. There were no thefts/losses to report, no trafficking issues to report, and no firearms in business inventory containing an obliterated serial number. The licensee had some issues with the A&D books. The licensee changed A&D books once a year. When the licensee transferred firearms from one book to another book, the licensee failed to record the original acquisition date and whom the firearm was received from. Instead the licensee would write that the firearm was transferred from another A&D book with the date that it was transferred from that book. Also, the licensee had several duplicate entries. Investigator advised licensee that it was not necessary to start new books every year. Investigator talked to licensee about putting the books in the correct format. Corrections to the A&D books were made at the time of the closing conference; no violation cited. Licensee was cited for other A&D violations:

5 - ATF Forms 4473 – NICS & Other Dispositions

6 - Multiple Sales

According to the Firearms Trace History Report, the licensee was associated with [REDACTED] multiple sales of handguns involving [REDACTED] firearms. Licensee was originally cited for violation **27 CFR.126(a)** for failing to report on ATF F 3310.4, Report of Multiple Sale or Other Disposition of Pistol and Revolvers. During closing conference, licensee stated he found the original ATF F 3310.4 (**exhibit 1**). Licensee stated the form had already been completed; violation removed.

7 - Suspicious/Prohibited Purchasers

TECS/NCIC check was conducted on (3) purchasers and (4) firearms; no derogatory information.

8 - Trace Activity

A FFL History Query was obtained. There were [REDACTED] successful firearm trace requests for the past 12 months. A secondary market analysis was conducted on (6) used firearms located in the licensee's inventory. NCIC/TECS checks were conducted; no derogatory information.

Deconfliction was conducted by the Lead IOI (b)(6) through NFORCE with negative results.

Note: During the previous inspection, Investigator discussed with licensee some safety issues concerning firearms in clear view of anyone walking pass the building. Investigator also discussed with licensee the safety issue concerning unsecured ammunition stored in the waiting area of the barber shop. Since last inspection, licensee has secured the window with a covering that can move in front of the window and away from the window. The security of the ammunition had not been addressed but licensee stated he plans on addressing the issue.

Investigator conducted closing meeting on March 12, 2018 with George Eckhoff (owner/ responsible person). ATF rules and regulations were reviewed with special emphasis placed on violations cited.
