1 - Introduction

Inspection Profile:

On 4/24/2018, Industry Operations Investigator (b)(6) met with Eugene Lee, Member and Responsible Person (RP), for an onsite Disposition Emphasis firearms compliance inspection. Investigator (b)(6) identified himself as a Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) Investigator and presented his credentials. Mr. Lee provided (b)(6) Driver's License # (b)(6) , expires 8/27/2020, as identification.

Investigator (b)(6) did not provide advanced notice of the inspection. The onsite inspection was completed on 5/23/2018. The inspection covered the period from 4/24/2017 through 4/23/2018.

Business Profile:

HGS operates a retail storefront in an urban area of Honolulu, Hawaii. The licensee offers gunsmith services and sells new long guns and handguns in a retail setting. A Federal Licensing System (FLS) query disclosed that HGS does not currently hold any other ATF issued licenses or permits. In 2014, HGS LLC applied for both a Type 01 and Type 06 FFL (9-99-00772 and 9-99-00773). HGS LLC withdrew its applications in 2015 after being unable to secure property owner authorization.

The licensee maintains a website, hawaiigunshop.com, and uses social media to promote the business. Mr. Lee stated that HGS does not manufacture/import firearms, deal in NFA items, accept firearms on pawn, or sell black powder.

Investigator (b)(6) confirmed that HGS has current registration as a domestic limited liability company with the Hawaii State Department of Commerce and Affairs. HGS also holds current Honolulu Business and Occupational License # 0076092 and Hawaii State Excise Tax License # GE-164-075-3152-01.

HGS acquired firearms and sold or transferred approximately firearms during the one-year inspection period. The licensee acquires new firearms from common wholesalers and used firearms from non-licensees for gunsmith purposes. Mr. Lee stated that he typically operates the store by himself with occasional assistance from RP Roderick Hipol.

The Type 01, Dealer in Firearms Other than Destructive Devices, license is appropriate for the business.

Ownership and Control:

Mr. Lee stated that there have been no changes in ownership or control since issuance of the license in 2016. Mr. Lee stated that he is the sole member and owner of the LLC. Mr. Lee stated that Roderick Hipol is a close friend that assists him with gunsmith work, and sometimes operates the store independently if needed. FLS reflects that Eugene Lee and Roderick Hipol are both listed as responsible persons on the license.

Variance:

The licensee has not requested a variance.

2 - Recommendation

Investigator (b)(6) recommends a Warning Letter and Recall based on the licensee's failure to timely record A&D record entries during the one-year inspection period.

3 - Inspection History

Investigator (b)(6) queried the Federal Licensing System (FLS) and NSPECT and found the following inspection history.

4 - Acquisition & Disposition (A&D) Record - Inventory

At the time of the inspection, HGS was maintaining a single bound book record in the required format for all transactions. Examination of the record disclosed that Mr. Lee made the last acquisition entry on 7/12/2017. The record did contain disposition entries throughout the inspection period. Investigator (b)(6) asked Mr. Lee to explain why the record did not contain any acquisitions after 7/12/2017.

Mr. Lee stated that he decided to transition to a computer A&D record in July 2017 since the business had much higher sales volume than he anticipated. Mr. Lee stated that he was not sure which software vendor to use, so as of 4/24/2018 he had not yet created the computer record. Mr. Lee stated that he kept printouts of firearms received

from his suppliers, and invoices for gunsmith transactions, so he could enter the data in the computer record later. During the inspection, Mr. Lee stated that he would immediately begin using an Excel spreadsheet as his computer record.

Mr. Lee acknowledged that, other than making dispositions for firearms previously in the bound book, he did not make required A&D record entries for the period from 7/13/2017 through start of the inspection on 4/24/2018. Mr. Lee stated that he had all of the necessary information and would begin updating his A&D records immediately. On 5/20/2018, Mr. Lee emailed Investigator (b)(6) a copy of his computer record and indicated that he had completed all A&D entries. Refer to Exhibit 1.

A full inventory disclosed that there were 166 firearms in the HGS inventory at the time of the inspection. Refer to Exhibit 2. Investigator (b)(6) reconciled the inventory to the bound book record (which only contained acquisitions through 7/12/2017) and found that firearms were not logged into the A&D record. Investigator (b)(6) confirmed that the new computer record contains entries for these firearms, as well as inventory items acquired within seven days of the inspection.

Investigator (b)(6) cited the licensee on a Report of Violations (ROV) for failing to comply with 27 CFR 478.125(e) as follows: On occasions, the licensee failed to timely record the acquisition of a firearm. On occasions, the licensee failed to timely record the acquisition and disposition of firearm. Refer to Violation 1. All violations are included on Worksheet 1 and supported by the licensee's recreated computer record included as Exhibit 1.

Mr. Lee acknowledged the violations and stated that he regretted mishandling the transition to a computer record from a bound book record.

The licensee reported firearm missing from inventory during the inspection period, (b)(3) - 112 Public Law 55 125 Stat 552. E-Trace reflects that Mr. Lee reported the theft on 12/12/2017, and indicated at the time that he threw away the firearm by mistake. During the inspection, Mr. Lee again stated that he believes he mistakenly discarded the firearm in into a dumpster near the premises.

Mr. Lee stated that he believes the firearm was in a box that he thought was empty at the time. Mr. Lee stated that by the time he realized the firearm was missing, the dumpster containing the box had been emptied. Investigator (b)(6) located entries for the firearm in the HGS recreated computer record and found that the disposition reflects the date of the loss and ATF incident number. E-Trace indicates that the firearm has not been recovered. An Open Fox query for the firearm was positive, and indicated that a Federal firearms licensee mistakenly placed the firearm in a trash receptacle. Refer to Exhibit 2, incident #

5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee had 409 ATF Forms 4473 on file for the one-year period preceding the inspection. HGS assigns a sequential number to each form and maintains the forms in numerical order. HGS had no denied or cancelled forms on file, but Mr. Lee confirmed he would create a separate file. Investigator (b)(6) reviewed all 409 forms on file for the inspection period and found no violations.

Mr. Lee stated that he thoroughly reviews all ATF Forms 4473 prior to and after the transfer. Mr. Lee stated that he check all forms for errors and omissions, and verifies that each purchaser has obtained a valid Permit to Acquire from the local police department per State of Hawaii requirements.

FFLs in the State of Hawaii do not conduct background checks since purchasers are required to obtain a Permit to Acquire (PTA) from the county police department before purchasing a firearm. The police department conducts background checks on purchasers, and the Hawaii PTA qualifies as an exemption to NICS. Purchasers must present the PTA to firearms dealers at the time of transfer and dealers record the permit details in item 23 of ATF Form 4473.

Permits for handguns are valid for 10 days from issuance and each PTA is issued for a specific handgun. Purchasers must obtain a separate PTA for each handgun purchase.

Permits for long guns are valid for a 12-month period and allow multiple acquisitions under the same PTA. The local police department conducts a background check at the time the long gun PTA is issued, but no additional background check is conducted at the time of transfer, which could be as long as 12 months later. Purchasers are required to register long guns with the local police after making an acquisition, and a second background check is conducted at that time.

Investigator (b)(6) selected six long gun purchasers for a NICS background re-check. The transactions involved long gun purchases where the date of transfer was more than one month after issuance of the long gun PTA. Four checks resulted in a "proceed" response from NICS, and two checks resulted in a "delayed" response. Investigator (b)(6) queried Open Fox for the two delayed purchasers and found that the purchasers do not appear to be prohibited from possessing a firearm. Investigator (b)(6) will continue to monitor the delays until NICS provides a final response.

6 - Multiple Sales

Investigator (b)(6) requested an FFL History Report from the Violent Crime Analysis Branch (VCAB) for the period from 12/27/2016 (issuance of the license) through 4/24/2018. Refer to **Exhibit 4.** The VCAB indicated that HGS has filed multiple sale

reports involving firearms. Investigator (b)(6) examined the ATF Forms 4473 on file for the inspection period and found no unreported multiple sales.

7 - Suspicious/Prohibited Purchasers

No suspicious or prohibited purchasers were identified.

8 - Trace Activity

Investigator (b)(6) requested an FFL History Report from the VCAB for the period from 12/27/2016 through 4/24/2018. Refer to **Exhibit 4.** The VCAB indicated that HGS is not associated with any firearms traces.

9 - NFA/Importer/Collector/Manufacturer

The licensee is not engaged in these activities.

10 - Referrals

No referrals were made.

11 - Other

Investigator (b)(6) queried NFORCE prior to the inspection and found that the HGS RPs are not associated with any ATF criminal investigations. Open Fox queries disclosed no indication that any of the HGS RPs are prohibited.

An FLS query disclosed that HGS does not currently hold any other ATF issued licenses or permits. In 2014, HGS applied for a Type 01 and Type 06 FFL (9-99-00772 and 9-99-00773). HGS withdrew its applications in 2015 after being unable to secure property owner authorization.

Investigator (b)(6) obtained the following GPS coordinates for the premises during the inspection: 21.34061, -157.89798.

The HGS premises is not located within 1000 feet of a school. Moanalua Elementary is the closest school at a distance of approximately 3400 feet from the premises.

12 - Closing Actions

Investigator (b)(6) completed the onsite inspection and held a closing conference with Mr. Lee on 5/23/2018. Investigator (b)(6) discussed the inspection findings and reviewed the ROV with Mr. Lee. Investigator (b)(6) explained the violations and

discussed corrective actions with the licensee. Mr. Lee signed the ROV and Investigator (b)(6) provided him with a copy.

Investigator (b)(6) also reviewed the Acknowledgement of Federal Firearms Regulations with Mr. Lee on 5/23/2018. Mr. Lee signed the acknowledgement and Investigator (b)(6) provided him with a copy. Refer to Exhibit 5.

Investigator (b)(6) provided Mr. Lee with his contact information and encouraged him to contact ATF with any questions related to his firearms business.

13 - Violations


