1 - Introduction

Inspection Profile:

On May 17, 2018, Industry Operations Investigator (IOI) (b)(6), conducted a full scope SWB-DE (Manufacturer) compliance inspection, of Sam DiCarlo (Licensee), doing business as Sammy D's Discount Arms, a Type 07 Manufacturing FFL expiring November 1, 2020. IOI (b)(6) provided advance notice of the inspection, as the Licensee was not home on the first contact attempt.

The inspection covered October 13, 2017 to May 17, 2018. IOI(b)(6) conducted the Closing Action on May 25, 2018.

IOI (b)(6) met the Licensee, who was identified by his Arizona Drivers' License (b)(6) expiring 08/26/2028. The Licensee obtained his FFL in October of 2017 when (in response to ATF CE contact) it was determined that he was potentially dealing without a license.

This compliance inspection is in response to an ATF CE investigation of a possible trafficking situation that the Licensee alerted them to (785115-18-0122).

Business Profile:

The Licensee operates as a FFL part time from his owned home in suburban Glendale, AZ. The Licensee provides internet transfer services and conducts retails sales over the internet using backpage.com and armslist.com. With the closure of backpage.com, the Licensee is consolidating his internet sales on armslist.com. Additionally, the Licensee also sells AR receivers and assembles AR rifles. The Licensee has held this FFL since October of 2017 (6 months).

4 - Acquisition & Disposition (A&D) Record - Inventory

The Licensee maintains his A&D records manually using commercially obtained books with timely made entries that meet the regulation requirements. IOI (b)(6) conducted a 100% physical inventory, comparing the A&D records to inventory and inventory to the A&D records, resulting in the following:

- Twenty seven open entries in the A&D records
- Twenty seven firearms in inventory

After review of the A&D records, matching inventory to the records and open dispositions to the inventory, IOI (b) (6) did not note any discrepancies.

IOI(b)(6) checked 60 firearms obtained from Sierra Auction through disposition with no discrepancies found. IOI(b)(6) found all verified dispositions, from Sierra Auction to the Licensee, in the Licensee's A&D record.

A&D SOP

The Licensee is the sold author/custodian of the required A&D records. IOI (b)(6) recommended to the Licensee that he tag his inventory and tie it to each specific firearm's A&D entry. IOI (b)(6) also instructed the Licensee not to use white out for changes and to conduct a regular gun-to-book inventory.

The Licensee protects his premises with standard residential locking hardware with electronic protection provided by a non-monitored alarm system. All firearms are stored in a gun safe.



IOI(b)(6) noted that the Licensee was assembling AR style rifles. Due to confusion on the Licensee's part regarding marking and record keeping annotations, IOI(b)(6) provided the Licensee with specific guidance on how to accurately and correctly record receivers vs completed rifles and when the Licensee's assembled rifles met the definition of "manufactured", how to properly mark said firearms.

IOI (b)(6) also informed the Licensee that if he wished to continue assembling rifles, he could use another FFL under a marking variance to mark on his behalf.

IOI (b)(6) noted that the Licensee did not produce any raw manufactured firearms during the six-month inspection period.

Since receiving his FFL, the Licensee has correctly and timely filed one AFMER report.


