

#### 1 - Introduction

#### **Inspection Profile:**

On May 3, 2018, ATF Industry Operations Investigators (IOI) (b) (and ATF Senior Industry Operations Investigator (b) (b) (c) attempted an unannounced Federal Firearms License (FFL) compliance inspection at the licensed premises of Wilson's Auction Sales, Inc. Since both responsible persons associated with the FFL were unavailable, IOIs scheduled the compliance inspection for May 4, 2018. The licensee currently possesses an ATF Type-01 FFL, Dealer in Firearms Other Than Destructive Devices (FFL# 8-52-00408).

The inspection period was May 3, 2017 through May 3, 2018. IOIs (b)(6) and (b)(6) interviewed Mr. David Lee Wilson, President and Mrs. Carolyn Diane Wilson, Secretary. Both individuals possess a valid Delaware Driver's License which was verified. The on-site inspection concluded on May 8, 2018.

#### **Business Profile:**

Wilson's Auction Sales, Inc. operates from a storefront (auction house) located in the suburban, commercially zoned area of Lincoln, Delaware. In addition to the 100% retail sales and auctions of firearms, the business conducts estate and consignment auctions of vehicles, furniture, clothing, electronics, and collectables. The licensee does not conduct any wholesaling of firearms or offer gunsmithing services. On occasion, it participates in local Sussex County gun shows; i.e. Delmarva Outdoors Expo. Mrs. Wilson stated the company prefers not to conduct internet or private-party transfers. Wilson's Auction Sales, Inc. advertises its appraisal and auction business online at <a href="https://www.wilsonsauction.com">www.wilsonsauction.com</a>. The website does not allow customers to purchase or bid on firearms online. All transactions and bids must take place in person at the licensed premises.

All firearms for sale are displayed in showcases or on gun racks at the time of an auction. Customers place bids on the firearms and are stored in a large gun safe until the transfer occurs. The gun safe is located in the office area which is monitored by an alarm system and security cameras. There are no off-site storage of firearms. No other businesses are conducted on the premises nor is the licensee associated with any other businesses.

The licensee has possessed an ATF license since September 9, 2010, and has no other ATF licenses. In addition to the Type-01 FFL, the licensee has the following Delaware State issued licenses: Delaware Deadly Weapons Dealer License, Delaware Auction-Resident License, Delaware Commercial Lessor License, and a Delaware Motor Vehicle License. **Reference Exhibit #1**. The licensee was found to be in compliance with all Delaware State, local and zoning laws.

During the inspection period, the licensee acquired approximately (b)(4) firearms (b)(4) handguns / (b)(4) long guns (b)(4) receivers) and disposed of approximately (b)(4) firearms (b)(4) handguns / (b)(4) long guns, zero receivers). The licensee deals approximately (b)(4) used firearms and (b)(4) new firearms. The licensee does not utilize any primary supplier of new firearms. The majority of firearms sold are acquired from individuals and estates.

### Ownership and Control:

Wilson's Auction Sales, Inc. is a Delaware registered corporation formed on February 20, 1976. IOI(b)(6) utilized the Delaware Division of Corporations database to confirm registration and good standing (File# 821456).

The following corporate officers are listed: Mr. David Wilson, President and Mrs. Carolyn Wilson, Secretary. Both are correctly listed as responsible persons in the Federal Licensing System (FLS). There are no unreported changes to control or ownership nor is hidden ownership suspected. After reviewing the FLS document with Mrs. Wilson, the following amendments to FLS were requested:

On May 8, 2018, IOI(b)(6) emailed ATF Legal Instruments Examiner(b)(6) (b)(6) in order to relay the RP's request. No further requests to update the FLS system were made during the inspection.

### 4 - Acquisition & Disposition (A&D) Record - Inventory

Wilson's Auction Sales, Inc. maintains its Acquisition & Disposition (A&D) records in handwritten, bound book form as per 27 CFR 478.125(e). IOI(b)(6) reviewed the licensee's A&D records and found them to be kept in the proper format; however, there were five A&D record discrepancies found as described below.

IOI(b)(6) conducted a full inventory of firearms; no firearms with obliterated serial numbers, nor illegal firearms were found. No trafficking indicators were found. At the time of inspection, the licensee had 14 firearms in inventory. The A&D record contained nine open entries. While conducting the inventory and reviewing the A&D record, IOIs discovered that the licensee incorrectly logged out firearms in the A&D record when it was found in inventory. Specifically, the licensee was recording the prospective transferee's name and address in the disposition record before the firearm was transferred to the customer. The licensee was cited in violation of 27 CFR 478.125(e). **Reference Worksheet #1 and Violation #3.** No thefts or losses were reported nor were there any reported as a result of the inspection.

IOI(b)(6) selected 25 firearms from the A&D records with dispositions recorded and found the corresponding ATF Form 4473 on file documenting the disposition. No discrepancies were found.

The licensee's standard operating procedures relevant to the A&D record are as follows: Mrs. Wilson stated once the firearm arrives to the auction house, the box is opened and the serial number is verified. The firearm is then recorded into the A&D record on the same day of receipt. Mrs. Wilson records all entries into the A&D record herself. No other employees at the auction house engage in the record keeping process. Yearly inventories of firearms are conducted to ensure there are no thefts or losses.

#### 5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee had ATF Forms 4473 on file for the inspection period. The ATF Forms 4473 were found to be at the licensed premises and were filed numerically by

transaction serial number. IOIs reviewed each of the ATF Forms 4473 on file and documented the following discrepancies. IOIs discovered that contained violations. Reference Worksheet #2 and Violations #1 and #2.

An FFL Audit Report for firearm transactions was requested through the FBI NICS Section. IOI(b)(6) compared three NICS transaction number to the corresponding ATF Forms 4473. No discrepancies were found.

IOI(b)(6) also ensured that the licensee receives a certified copy of FFLs prior to transferring a firearm to another licensee. Wilson's Auction Sales, Inc. completed FFL to FFL transfers during the inspection period. All of the transfers were completed legally and correctly. The licensee did not conduct any transfers to law enforcement officers for on-duty purposes during the inspection period. IOI(b)(6) explained the regulation requirements in accordance with 27 CFR 478.134 concerning transfers for on-duty law enforcement purposes.

IOI(b)(6) reviewed the licensee's standard operating procedures relevant to the ATF Form 4473 completion and other dispositions with the licensee. Mrs. Wilson stated that she completes the ATF Forms 4473 on behalf of the company and reviews them to ensure accuracy and completion. She further stated that a secondary reviewer will begin examining each form upon completion in order to prevent future errors. The licensee conducts all NICS checks online through the electronic system.

#### 6 - Multiple Sales

Analysis Branch revealed multiple sales involving firearms reported during the inspection period. During the review of the licensee's required records, IOIs discovered the licensee failed to report multiple sales of hand guns involving firearms. The licensee was cited in violation of 27 CFR 478.126a. **Reference Worksheet #2 and Violation #4.** 

#### 7 - Suspicious/Prohibited Purchasers

During the review of the licensee's Acquisition and Disposition Records and ATF Forms 4473 on file for the inspection period, IOI(b)(6) did not identify any possible traffickers, straw purchasers or other suspicious purchasers. The majority of the purchasers were repeat customers who were familiar to the licensee.

Furthermore, IOI (b)(6) conducted five criminal history queries in OpenFox to include Mr. and Mrs. Wilson and three purchasers. These particular transferees were selected because the firearm was transferred after the 25 day delay with no resolution to background checks. The queries did not appear to reveal any firearms prohibitors.

#### 8 - Trace Activity

Per the Violent Crime Analysis Branch (VCAB), the licensee was associated with zero trace requests during the inspection period; there were no unsuccessful traces.

The licensee acquired approximately used firearms and disposed of approximately used firearms during the inspection period. IOI (b)(6) queried 11 used firearms found in inventory through NCIC. The query yielded negative results. No further investigation was warranted.

### 9 - NFA/Importer/Collector/Manufacturer

The licensee does not conduct NFA, Importer, Collector, or Manufacturer activities nor does it pay SOT.

#### 10 - Referrals

No referrals were generated as a result of the inspection.

#### 11 - Other

IOI (b)(6) verified Mrs. Wilson was enrolled to receive ATF Industry Newsletters. During the inspection, IOI(b)(6) verified the licensee had secure gun storage/safety devices available for customers. The licensee was also found to be compliant with the Youth Handgun Safety Act poster and brochures.

#### 12 - Closing Actions

On May 8, 2018, IOI (b)(6) Id a closing conference with Mrs. Carolyn Wilson, Secretary. (b)(6)

a Report of Violations (ROV) and reviewed the Acknowledgement of Federal Firearms Regulations with the licensee. Reference ROV. Both the ROV and the Acknowledgement of Federal Firearms Regulations were signed by Mrs. Wilson and copies were provided to her for the licensee's records. Reference Exhibit #2. All materials referenced during the review were provided to the licensee, along with a list of ATF phone numbers and instructions on how to access the 2014 Federal Firearms Regulations Reference Guide electronically. Mrs. Wilson stated she attended the recent ATF seminar in order to discuss the new ATF Form 4473 (2016 version).

The licensee will ensure to receive an accurately completed ATF Form 4473 from the customer prior to the transfer of a firearm. IOI(b)(6) explained the importance of having the customer fill out the form completely and accurately.


