

#### 1 - Introduction

#### **Inspection Profile:**

On January 17, 2018, Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) Industry Operations Investigator (IOI) (b)(6) began an onsite DE FRONTLINE Full Scope Firearms Compliance Inspection of Robert Shrider, dba Ronan Sports & Western (herein referred to as the *licensee* throughout this report). IOI (b)(6) erified the identity of owner and sole Responsible Person (RP) Robert Shrider by checking his Montana State-issued driver's license. His information is as follows:



The onsite beginning date was January 17, 2018 and end date was February 12, 2018. Advance notice was not provided. The inspection period was January 17, 2017 through January 17, 2018.

#### **Business Profile:**

The licensee holds a Type 02, *Pawnbroker in Firearms Other Than Destructive Devices*, Federal Firearms License (FFL). The licensee sells new and used firearms and has several customers who pawn their firearms on a regular (monthly) basis. Primary customers are the general public.

The business premises is owned by the licensee. The address is 63298 US Highway 93, Ronan, MT 59864 located in Lake County. GPS Coordinates are N - 47.31389 and W - 114.05487.

The licensee does not have a website and uses the email address RSandW@Ronan.net.

Firearm transfers are either conducted at the business premises or through another FFL. The licensee does not attend gun shows. All firearms are stored at the business premises, there is no off-site storage. All ammunition is stored next to the firearms in the firearm sales area of the premises. (b)(4)

During the inspection period, the licensee acquired  ${}^{(b)(4)}$  firearms and disposed  ${}^{(b)(4)}$  firearms. Mr. Shrider stated that they transfer approximately  ${}^{(b)(4)}$  new long guns,  ${}^{\circ}$ % pawned firearms and  ${}^{(b)(4)}$  new handguns.

IOI(b)(6) observed the Federal Firearms License was posted as required.

### **Ownership and Control:**

Robert Shrider is the owner and sole Responsible Person (RP) of Ronan Sports & Western. On February 2, 2018, IOI (b)(6) conducted a business entity search on the Montana Secretary of State website, this search revealed Ronan Sports & Western to be active and in good standing as a Domestic Profit Corporation (Exhibit 1).

During the inspection, IOI (b)(6) asked Mr. Shrider if there were any other persons to add to the RP list, Mr. Shrider stated that there were no other persons he wanted added.

Mr. Shrider is responsible for logging in and out all firearms and takes responsibility for all ATF 4473s. Due to the high number of errors during the inspection, IOI (b)(6) discussed delegating some of the workload with other employees but the RP was not interested. IOI(b)(6) found the staff of this business to be very competent and willing to help the owner in any way. Their knowledge base was very impressive and IOI(b)(6) believes that there would be fewer violations if Mr. Shrider were to allow assistance from his staff.

IOI (b)(6) conducted an NCIC check on sole RP, Mr. Robert Shrider on January 05, 2018 and February 02, 2018; there were no prohibiting information discovered. Query of the RP list in N-Force and FLS did not reveal involvement in a criminal investigation or association with a separate FFL that was the subject of administrative action.

### 4 - Acquisition & Disposition (A&D) Record - Inventory

IOI(b)(6) conducted a full physical inventory of all firearms found at the business premises. There were 434 firearms in inventory and the open entries in the Acquisition and Disposition (A&D) Record. Of the pen entries and firearms were not recorded as acquisitions and firearms were not recorded as dispositions. The licensee was instructed to research their records and determine the disposition of each of the firearms.

The licensee requested three weeks to conduct the research of the firearms that were not logged out of the A&D Record. The licensee was unable to determine the disposition firearms and filed a Theft/Loss Report (ATF Form 3310.11) on January 30, 2018 for those firearms unaccounted for **(Exhibit 2).** The licensee provided completed ATF Forms 4473 corresponding firearms that were not logged out of the A&D Records.

IOI (b)(6) reviewed the A&D Record to verify all required information was recorded and accurate. On two acquisition entries all information was not recorded. On instances, the licensee failed to document the disposition of a firearm.

Due to the licensee's failure to record required acquisition and disposition information in the A&D Record, the licensee was cited with violating 27 CFR 478.125(e) instances. See Worksheet 1 – Inventory and A&D Record, **Exhibit 3** – A&D Record (random sampling), and ATF Form 5030.5 – Report of Violations.

The licensee was instructed to correct all acquisition and disposition information in the A&D Record. On February 12, 2018, IOI (b)(6) verified all required information was recorded.

### 5 - ATF Forms 4473 - NICS & Other Dispositions

IOI (b) (6) obtained the FFL Audit Log for background checks completed for the time period October 26, 2017 through January 4, 2018. Eighty (80) transactions were generated and the numbers were compared to ATF Forms 4473 on file for the time period. There were no discrepancies noted.


There were no transfers of firearms to law enforcement during the inspection period.

### 6 - <u>Multiple Sales</u>

IOI (b)(6) obtained an FFL Master Query for the licensee from the Violent Crime Analysis Branch (VCAB) for the time period January 17, 2017 through January 17, 2018. The query results showed multiple sales involving firearms reported. IOI (b)(6) compared this report to the ATF Forms 4473 on file and discovered firearms were transferred without the licensee filing a Multiple Sale of Handgun Form. The licensee filed the Multiple Sales Form (ATF Form 3310.4) on January 19, 2018. As such; the licensee was cited for violating 27 CFR 478.126a for failing to ensure Multiple Sale of Handgun form was filed and submitted to ATF within five consecutive business days instance). Reference Worksheet 2 – ATF Form 4473, Exhibit 11 – ATF Form 4473.

### 7 - Suspicious/Prohibited Purchasers

On January 30, 2018, IOI (b)(6) contacted via email correspondence (Exhibit 12), (b)(6) , FBI NICS Section, ATF Liaison to seek clarification on an ATF Form



and the third business day would have been Tuesday, February 28, 2017 and Wednesday, March 1, 2017 would have been the day the FFL could transfer the firearm (if NICS did not provide a response sooner). IOI (b)(6) questioned the licensee about the error in dates and was told that the purchaser must have written the wrong date in section 15 (Certification Date) and the employee copied the date. Other than the

incorrect dates written on the ATF Form 4473, there were no other suspicious findings. On March 13, 2018, IOI(b)(6) ran a background check using OpenFox. The results showed two felony arrests but no convictions.

Upon review of the ATF Forms 4473, IOI (b) (6) discovered that a firearm was transferred to (b)(3) - 112 Public Law 55 125 Stat 552, (b)(6) There was no documented identification noted on the ATF Form 4473 so a background check was conducted on February 28, 2018 using OpenFox. There were no findings prohibiting this purchaser.

Upon review of the ATF Forms 4473, IOI(b)(6) iscovered that a firearm was transferred (b)(3) - 112 Public Law 55 125 Stat 552, (b)(6) . A background check using OpenFox was conducted revealing two felony arrests (see section 10 - Referrals). A referral was submitted on March 21, 2018.

IOI(b)(6) conducted a total of 12 background checks using OpenFox, 11 purchasers were not prohibited, one was prohibited and referral generated.

The inspection did not reveal any suspected traffickers or straw purchasers. The licensee was cited for violating 27 CFR 478.124(c)(1) and 478.124(c)(3)(iv). These violations are mentioned in Section 5 - ATF Forms 4473 - NICS & Other Dispositions of this report.

#### 11 - <u>Other</u>

IOI (b)(6) found the licensee to be compliant with the Youth Handgun Safety Act (YHSA) poster and notice requirements. The YHSA notice is provided whenever a firearm is transferred to a non-licensee. Secure gun storage/safety devices are available to customers and included in the package with new handguns.

### 12 - Closing Actions

On February 12, 2018, IOI (b)(6) returned to the business premises to review ATF Forms 4473 related to ATF Forms 4473 corresponding firearms that were not logged out of the A&D Records and to conduct a closing conference with Mr. Shrider. The licensee showed IOI(b)(6) that the firearms were properly logged out of the A&D Record.

IOI(b)(6) issued and explained the Report of Violations (ROV) and answered all questions to the satisfaction of the licensee (Exhibit 13). Mr. Shrider signed and dated the ROV and was given a copy for the licensee's records.






