1 - Introduction

Inspection Profile:

On March 24-25, 2015, Industry Operations Investigators (IOI) (b)(6) conducted a Firearms Disposition Emphasis compliance inspection and special instructions as noted on ATF EF 5700.14. Mr. Stravos (Steven) Papathanasiou, owner was notified by Store Manager James A. (Tony) Cooper upon IOI (b)(6) arrival that a compliance inspection would be conducted. Manager Cooper was available during the inspection. The closing conference was held on March 31, 2015 with Mr. Papathanasiou at his Norcross, Georgia pawnshop. The inspection covered the period March 24, 2014 through March 23, 2015.

A query of the Federal Licensing System (FLS) disclosed no Special Attention Flags (SAF) or ATF investigations. IOI (b)(6) conducted a NCIC check on Stavros M. Papathanasious on April 2, 2015 resulting in no prohibiting factors.

Business Profile:

The licensed premises are in a commercially zoned area in Lawrenceville, Georgia. During the past 12 months, the licensee acquired the firearms. They disposed of the firearms. All of the firearms in inventory are pawned firearms. The suppliers during this period were individuals. I Deal Jewelry & Pawn accepts firearms on pawn and facilitates internet firearms transactions. Any firearms not picked up out of pawn are offered for sale over the internet. The licensee does not purchase new firearms for retail sale or participate in gunshows. The business operates online at Gunbroker.com and

www.IdealJewelryAndPawn.com. The LLC has held this Federal Firearms License (FFL) 1-58-135-02-08835 since February 7, 2013. Mr. Papathanasiou is also the sole responsible person on two additional FFLs: 1-58-135-02-6D-08833, I Deal Pawn & Cycle, LLC, d/b/a I Deal Pawn & Cycle, Snellville, Georgia and 1-58-121-02-6C-08834, I Deal Jewelry & Pawn, Inc., d/b/a I Deal Jewelry & Pawn Norcross, Georgia. According to the website, I Deal Jewelry & Pawn also operates as a pawn shop at 3593 Northcrest Road, Doraville, Georgia. Information on file in the Federal Licensing System (FLS) shows 3008 Roswell, LLC, d/b/a I Deal Jewlery & Pawn holds FFL 1-58-089-02-5M-08584 with licensed premises at 3593 Northcrest Road, Doraville, Georgia. Mr. Papathanasiou is not shown as a responsible person on the Doraville license. Alan Zager is shown as the sole owner for the Doraville license. I Deal Brokerage, Inc. has a business license with the City of Lawrenceville. The licensee utilizes no off-site storage.

Ownership and Control:

Stravos (Steve) Papathanasiou is the sole officer of I Deal Brokerage, Inc. He confirmed that he is the sole officer and director and responsible person on the license and that there have been no changes to the business structure since this license was issued. FLS accurately reflects this information.

Variance:

The licensee does not have any approved variances and Mr. Papathanasiou did not request any during this inspection. The licensee uses computerized records.

4 - Acquisition & Disposition (A&D) Record - Inventory

The licensee maintains computerized A&D records. The FFL had never printed an A&D record for this license before the commencement of this inspection. The A&D record shows open entries; however, there were 24 firearms in physical inventory on March 25, 2015 for a difference of the provide of the firearms were transferred to other FFLs but were not showing as dispositions in the A&D record. Exhibit B p1-148. The provide of the firearms were transferred on ATF Forms 4473 dated to but were not showing as dispositions on the A&D record. Exhibit B p1-4, 16-19 and Exhibit A p17-23. The licensee was cited in violation of 27 CFR 478.125(e) for failure to record the disposition of the firearms. Reference Worksheet 1, Exhibit B, Exhibit A p17-23 and ROV 7.

There were no theft/loss reports submitted by the licensee during this inspection period. The A&D record was printed in the proper format. There were first firearms on ATF Forms 4473 on file that were traced to the disposition information in the A&D record. There were first firearms were not recorded as dispositions in the A&D record. There were first firearms on sales receipts transferring the firearm to another FFL. The disposition information for the firearms was not shown in the A&D

IOI(b)(6) identified no trafficking, obliterated serial numbers, or illegal firearms. All employees are trained on how to accurately complete a firearm sale or redemption.

On Form 4473, the transferee failed to sign and date the certification in Section A and on an additional Form 4473, the transferee failed to date the certification in item 17 in violation of 27 CFR 478.124(c)(1). Reference Worksheet 2, Exhibit A p 4-9, and ROV 2. The licensee failed to obtain sufficient identification to verify the transferee's identity and form in violation of 27 CFR 478.124(c)(3)(i). Reference residence address on Worksheet 2, Exhibit A p13-16, and ROV 3. On form, the licensee failed to complete the description of the firearm being transferred in items 26-30 of Section D in violation of 27 CFR 478.124(c)(4). Reference Worksheet 2, Exhibit A p 10-12, and form, the licensee failed to sign and date the Transferor's ROV 4. On Certification in items 34 and 36, and on form, he failed to date item 36 in violation of 27 CFR 478.124(c)(5). Reference Worksheet 2, Exhibit A p 1-3 and 10-12, and **ROV 5.** The licensee was cited in violation of 27 CFR 478.99(c)(1) when the licensee failed to stop the transfer of a firearm when the licensee had reason to believe the transferee is a prohibited person when the transferee answered he had been convicted of a felony. Reference Worksheet 2, Exhibit A p 17 - 23, and ROV 6. IOI Forrester received information in the form of a referral from ATF TFO(D)(6) (b) (6) and the Lawrenceville Police Department (LPD) concerning this transaction. Pawnbrokers in Lawrenceville provide information on all items pawned and the person pawning the items on a daily basis. LPD discovered that (b)(3) - 112 Public Law 55 125 Stat 552 (b)(3) - 112 Public Law 55 125 Stat 552 at this I Deal Jewelry & Pawn location and records show that (b)(6) is a prohibited person. At the time the firearm was redeemed by (b)(3) = 1/2 Public Law 55 125 Stat 552 he was still in possession of a Georgia Firearms Carry License but he did answer on the Form 4473 that he had been convicted of a felony.

Both signed the report as evidence of Mr. Papathanasiou receiving the document.

IOI(b)(6) provided Manager Cooper with an updated Important ATF Phone Numbers list, and a fresh ATF I 5300.1, Youth Handgun Safety Act Poster.

Licensee's response: Mr. Papathanasiou stated that it appeared his employees at the Lawrenceville store had a problem with completing the forms correctly. He asked if ATF could provide some training for the management of his three stores in order to try to eliminate some of these errors in the future.

<u>Corrective action</u>: IOI(b)(6) directed the licensee to review all ATF Forms 4473 more carefully prior to the disposition of a firearm. When possible have a second person review the form for accuracy.

During this conference, the violations cited during the inspection covering the period March 24, 2014 to March 23, 2015, and the necessary corrective action to prevent the violations from recurring were discussed.

You were given the opportunity to comment on the violations and what specific action you have taken to ensure that the violations will not recur.

<u>Regarding Violations # 1, 2, 4, 5</u>, where you failed to obtain complete and accurate information on the ATF Forms 4473 in accordance with the instructions on the form. You stated that you will be reviewing the forms several times before the purchaser leaves the store and before the forms are filed to ensure they have been completed. Additionally you stated that the forms will be reviewed several times a month.

<u>Regarding Violation #3</u> where you failed to obtain sufficient identification to properly verify the transferee's identity and residence address. You stated that you will be obtaining additional documentation to verify the current address and identity of the purchaser.

<u>Regarding Violation # 6</u> where you failed to prevent the transfer of a firearm to a person who appeared to be prohibited at the time of transfer when the transferee answered he had been convicted of a felony, and was later determined to be a prohibited person. You stated that you will stop the transfer of a firearm when persons answer yes to any of the prohibiting questions in section 11 of the ATF Form 4473.

1 - Introduction

Inspection Profile:

On March 24-25, 2015, Industry Operations Investigators (IOI) (b)(6) conducted a Firearms Disposition Emphasis compliance inspection and special instructions as noted on ATF EF 5700.14. Mr. Stravos (Steven) Papathanasiou, owner was notified by Store Manager (b) (6) upon IOI (b)(6) arrival that a compliance inspection would be conducted. Manager (b) (6) was available during the inspection. The closing conference was held on March 31, 2015 with Mr. Papathanasiou at his Norcross, Georgia pawnshop. The inspection covered the period March 24, 2014 through March 23, 2015.

A query of the Federal Licensing System (FLS) disclosed no Special Attention Flags (SAF) or ATF investigations. IOI (b)(6) conducted a NCIC check on Stavros M. Papathanasious on April 2, 2015 resulting in no prohibiting factors.

Business Profile:

The licensed premises are in a commercially zoned area in Lawrenceville, Georgia. During the past 12 months, the licensee acquired (0)(4) firearms. They disposed of ^{(b)(4)} firearms. All of the firearms in inventory are pawned firearms. The suppliers during this period were individuals. I Deal Jewelry & Pawn accepts firearms on pawn and facilitates internet firearms transactions. Any firearms not picked up out of pawn are offered for sale over the internet. The licensee does not purchase new firearms for retail sale or participate in gunshows. The business operates online at Gunbroker.com and www.IdealJewelryAndPawn.com. The LLC has held this Federal Firearms License (FFL) 1-58-135-02-08835 since February 7, 2013. Mr. Papathanasiou is also the sole responsible person on two additional FFLs: 1-58-135-02-6D-08833, I Deal Pawn & Cycle, LLC, d/b/a I Deal Pawn & Cycle, Snellville, Georgia and 1-58-121-02-6C-08834, I Deal Jewelry & Pawn, Inc., d/b/a I Deal Jewelry & Pawn Norcross, Georgia. There were 109 firearms on ATF Forms 4473 on file that were traced to the disposition information in the A&D record. firearms of the 109 firearms were not recorded as dispositions in the A&D record. There were firearms on sales receipts transferring the firearm to another FFL. The disposition information for the firearms was not shown in the A&D

IOI (b)(6) identified no trafficking, obliterated serial numbers, or illegal firearms. All employees are trained on how to accurately complete a firearm sale or redemption.

On form, the licensee failed to provide information required in items 30 a&b - 33, and 35 in violation of 27 CFR 478.21(a). Reference Worksheet 2, Exhibit A p 10-12, and ROV 1. On Form 4473, the transferee failed to sign and date the certification in Section A and on an additional Form 4473, the transferee failed to date the certification in item 17 in violation of 27 CFR 478.124(c)(1). Reference Worksheet 2, Exhibit A p 4-9, and ROV 2. The licensee failed to obtain sufficient identification to verify the transferee's identity and residence address on form in violation of 27 CFR 478.124(c)(3)(i). Reference Worksheet 2, Exhibit A p13-16, and ROV 3. On form, the licensee failed to complete the description of the firearm being transferred in items 26-30 of Section D in violation of 27 CFR 478.124(c)(4). Reference Worksheet 2, Exhibit A p 10-12, and ROV 4. On form, the licensee failed to sign and date the Transferor's Certification in items 34 and 36, and on form, he failed to date item 36 in violation of 27 CFR 478.124(c)(5). Reference Worksheet 2, Exhibit A p 1-3 and 10-12, and **ROV 5**. The licensee was cited in violation of 27 CFR 478.99(c)(1) when the licensee failed to stop the transfer of a firearm when the licensee had reason to believe the transferee is a prohibited person when the transferee answered he had been convicted of a felony. Reference Worksheet 2, Exhibit A p 17 - 23, and ROV 6. IOI (b)(6) received information in the form of a referral from ATF TFO (b) (6) and the Lawrenceville Police Department (LPD) concerning this transaction. Pawnbrokers in Lawrenceville provide information on all items pawned and the person pawning the items on a daily basis. LPD discovered that (b) (6) pawned a rifle on 1/26/2015 at this I Deal Jewelry & Pawn location and records show that (b)(3) - 112 Public Law 55 125 Stat 552 (b)(6)

The FFL audit log showed two denied transactions for the period of November 30, 1998 to March 23, 2015; and 13 proceed, no delayed, no open, and no cancelled or non-denied under appeal transactions for the period January 22, 2015 to March 23, 2015. All fifteen transactions were verified with ATF Forms 4473 on file.

11 - Other

According to the Administrative Action Chart, transferring a firearm to a prohibited person knowing or having reason to believe that the transferee is a prohibited person, might be considered justification for revocation of the Federal Firearms License. I Deal Jewelry and Pawn's employee released a rifle to a pawn customer, (b) (6) (6) on February 9, 2015, after the customer answered in certification question 11c that he had been convicted of a felony. This licensee has held this FFL for approximately two years. During the past twelve months, the FFL has transferred firearms on ATF Forms 4473. Only firearm transfer was to a prohibited person who was redeeming a rifle from pawn and presented a Georgia Carry Permit in lieu of going through a NICS check. In the area where this licensee is located, the local law enforcement office conducts background checks on individuals pawning firearms. It was during one of the local law enforcement office's routine background checks when it was discovered that (b) (6) is a prohibited person. Currently, there is a local (b)(6), (b)(7)(C)

Since this is the first compliance inspection conducted on this license and the prohibited person is no longer in possession of the firearm, IOI (b)(6) recommends the licensee be required to attend a warning conference with the Director of Industry Operations in lieu of revocation of license.

This letter is a follow-up to the warning conference held with you on July 14, 2015 at the Atlanta Field Division's Office located at 2600 Century Parkway, NE Atlanta, Georgia 30345. During this conference, the violations cited during the inspection covering the period March 24, 2014 to March 23, 2015, and the necessary corrective action to prevent the violations from recurring were discussed.

You were given the opportunity to comment on the violations and what specific action you have taken to ensure that the violations will not recur.

<u>Regarding Violations # 1, 2, 4, 5</u>, where you failed to obtain complete and accurate information on the ATF Forms 4473 in accordance with the instructions on the form. You stated that you will be reviewing the forms several times before the purchaser leaves the store and before the forms are filed to ensure they have been completed. Additionally you stated that the forms will be reviewed several times a month.

<u>Regarding Violation # 3</u> where you failed to obtain sufficient identification to properly verify the transferee's identity and residence address. You stated that you will be obtaining additional documentation to verify the current address and identity of the purchaser.

<u>Regarding Violation # 6</u> where you failed to prevent the transfer of a firearm to a person who appeared to be prohibited at the time of transfer when the transferee answered he had been convicted of a felony, and was later determined to be a prohibited person. You stated that you will stop the transfer of a firearm when persons answer yes to any of the prohibiting questions in section 11 of the ATF Form 4473.

<u>Regarding Violation # 7</u> where you failed to record the date of disposition for firearms in the Acquisition & Disposition record book. The violations for which you were cited could adversely impact law enforcement's ability to reduce violent crime and protect the public. You are reminded that future violations, repeat or otherwise, could be viewed as willful and may result in the revocation of your license. You may anticipate further inspections to ensure your compliance.
