



1 - Introduction

Inspection Profile:

On January 5, 2016, Industry Operations Investigators (IOIs) (b) (6) and (b)(6) commenced the onsite portion of a Southwest Border full scope compliance inspection at the listed business premises for Academy, LTD doing business as January 1, 2015 to January 4, 2016. IOI (b)(6) interviewed Christopher Kuykendall (Store Director). Mr. Kuykendall identified himself with Texas Drivers License (b)(6)

IOI(b)(6) presented her Federal ATF-issued credentials and informed Mr. Kuykendall about the nature, purpose and scope of the inspection.

IOI (b)(6) queried the responsible persons in OpenFox and did not find any prohibiting factors.

IOI (b)(6) queried NFORCE for any open investigations on the premises or the responsible persons; the query did not reveal any open investigations.

Special Instructions were to verify and collect information regarding a NICs check.

Advanced notice was not given for this inspection. On January 8, 2016, Industry Operations Intelligence Specialist (IOIS) (b)(6) assisted with the review of ATF Forms 4473. No other Federal, State, or Local agency participated with the inspection.

Business Profile:

Mr. Kuykendall stated that the business activities consist of sales of new firearms and various other sporting goods. The licensee does not currently offer gunsmith services. The licensee does not make consignment sales and does not offer a layaway program.

The licensee conducts business at a retail storefront located in an urban commercial area of North Richland Hills, Texas. The licensee has maintained a Federal Firearms license (FFL) since February 16, 2000.

During the inspection period, the licensee acquired approximately (b)(4) firearms and disposed of approximately (b)(4) firearms. Approximately percent of the firearms transferred are new and are obtained from the licensee's primary supplier which is (b)(4)

Approximately percent of firearms transferred are used and are obtained from other FFLs for FFL transfers. The licensee does not currently transfer firearms at gun shows. The licensee does not sell firearms on the Internet; however, the licensee does maintain a website, www.academy.com.

No other businesses are located at the premises. The licensee has multiple business locations and each location holds an ATF Federal Firearms License (FFL).

IOI (b)(6) reviewed the City of North Richland Hills Code of Ordinances and did not identify any restrictions that prohibit the transfer of firearms from the premises.

The licensee does not currently utilize any off-site storage locations.

Ownership and Control:

IOI (b)(6) queried Academy, LTD through the Texas Secretary of State (TXSOS) online database. Academy, LTD is a domestic limited partnership formed on September 3, 1970 and filed under #12960410 with the TXSOS. The TXSOS currently lists the status of Academy, LTD as "In Existence." TXSOS lists Academy Managing Co., LLC. as the sole general partner. IOI (b)(6) queried the Texas Comptroller of Public Accounts online database and verified that the Texas Sales and Use Tax Permit (b)(3) - 26 USC 6103, for Academy, LTD, is currently active. Academy, LTD utilizes (b)(3) - 26 USC 6103.

Mr. Kuykendall is responsible for all decisions in regards to operations, policies, and procedures for the firearms business for this license. IOI (b)(6) did not observe or discover any indications or evidence of hidden ownership. No hidden ownership is suspected.

Mr. Kuykendall is the only responsible person for the license. The Federal Licensing System (FLS) License Registration Report lists Russell Lesikar as an additional responsible person. Mr. Kuykendall stated that Mr. Lesikar no longer works at this store. IOI (b)(6) spoke with Mylinda Jones, Sr. Manager – Compliance, with Academy, LTD regarding (b)(6) . Ms. Jones stated that Academy, LTD had notified ATF to remove (b)(6) . from the license on April 16, 2015. On February 3, 2016, (b)(6) . Compliance Coordinator, sent an email to (b)(6) . ATF Legal Instruments Examiner – Corporate Accounts, to ensure that (b)(6) received the information to remove

4 - Acquisition & Disposition (A&D) Record - Inventory

IOIs (b)(6) and (b)(6) conducted a full inventory. The A&D Record contained open entries and the licensee had 650 firearms in inventory. Every firearm in the physical inventory was compared to the A & D record and from the A & D record to the firearms with no discrepancies disclosed. The licensee did not submit any theft/loss reports during the inspection period. The licensee did not submit an inventory theft/loss report as a result of this inspection.

The A & D record was found to be in the proper format including all required information on completed entries and entries were found to be made timely in all instances. IOI(b)(6) traced 25 firearms through the licensee's required records from acquisition through disposition and did not discover any discrepancies. IOI(b)(6) did not discover any trafficking issues related to the acquisition and disposition of

firearms while reviewing the A&D record. The IOIs did not discover any firearms with obliterated serial numbers or any illegal firearms while conducting the inventory.

Mr. Kuykendall and the other employees of the store are responsible for recording acquisitions and dispositions in the computerized A&D record. The acquisitions are recorded in the A&D record on the day the firearm is received and dispositions are recorded on the day the firearm transaction occurs.


5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee had ATF Forms 4473 on file for this inspection period. IOIs (b)(6), and IOIS (b)(6) reviewed all of the forms and seven (7) discrepancies were noted, see Section 6 – Multiple Sales and Section 13 – Violations.

Transfers to other licensees were conducted properly and copies of each license were retained. The licensee did not make any sales to law enforcement officers. IOI (b)(6) reviewed the correct procedures to transfer firearms to law enforcement officers with Mr. Kuykendall.

The ATF Forms 4473 were reviewed for commonly recovered crime guns, weapons of choice, and suspicious purchasers. IOI (b)(6) identified one (1) suspicious purchaser during the review, see Section 7 – Suspicious/Prohibited Purchasers. No other discrepancies were noted.

No trafficking issues related to purchasers of firearms were identified. The IOIs and IOIS conducted an FFL audit log verification of 977 (916 proceeds, 19 open, 4 delay, 12, cancelled, and 26 denied) NICS transaction numbers and did not identify any discrepancies. The licensee had 26 NICS denials during the inspection period. The licensee applied the proper procedures for filing and maintaining denied transactions.

secondary NTN and response and to record the initial NTN as "cancelled." IOI (b)(6) explained to the licensee that whenever NICs gives a response of "cancelled" that the licensee cannot transfer the firearm to the transferee and that a new ATF Form 4473 would need to be completed, as is instructed on the ATF Form 4473. IOI (b)(6) reviewed this information with Mr. Kuykendall during the closing conference. Mr. Kuykendall stated that he understood.

Mr. Kuykendall and the other employees of the store are responsible for insuring the ATF Forms 4473 are completed correctly. The store also has a form review system that consists of: a manager reviews the form prior to the firearm being transferred, the department manager reviews all forms at the end of the day, a senior team lead reviews all forms for the previous week, and the operations manager reviews all of the forms for the previous month. IOI (b)(6) reviewed the ATF Forms 4473 with Mr. Kuykendall as requested, and provided guidance for his specific questions. IOI (b)(6) also encouraged the licensee to reference the instructions for the ATF Forms 4473 for further clarification in the future.


6 - Multiple Sales

The Violent Crime Analysis Branch FFL Master Query reported that the licensee had multiple sales involving firearms for the inspection period. The IOIs and IOIS discovered unreported multiple sales involving handguns and long guns during the inspection period. IOIs (b)(6) and (b)(6) also discovered untimely submitted multiple sales involving handguns during the inspection period. A report of violations was issued for the unreported and untimely submitted multiple sales. See Section 13 – Violations 5 & 6. The licensee submitted reports of multiple sales for the unreported multiple sales on January 21 & 27, 2016. IOI (b)(6) verified that the multiple sales had been received by the National Tracing Center (NTC) on February 5, 2016. See Exhibits #7 & 8.

7 - Suspicious/Prohibited Purchasers

IOI (b)(6) did not identify any traffickers, straw purchasers, or prohibited persons during this inspection period.

IOI (b)(6) queried five (5) individuals in OpenFox and E-Trace who purchased large volumes of firearms. None of the individuals were prohibited and four of the individuals did not have any suspicious purchase history in e-Trace.

The Violent Crime Analysis Branch FFL Master Query reported (b) (c) successful traces for the inspection period. IOI (b)(6) queried 65 firearms through OpenFox which were associated with large volume purchasers. IOI (b)(6) queried three (3) firearms through OpenFox which were purchased by a resident of California. No discrepancies were noted.

9 - NFA/Importer/Collector/Manufacturer

The licensee does not import, collect or manufacture firearms and does not deal in NFA weapons.

10 - Referrals



11 - Other

The licensee is in compliance with the Youth Handgun Safety Act, IOI (b)(6) observed that the poster was posted at the premises and observed that the licensee has pamphlets ready for distribution. The licensee has secure gun storage and/or safety devices on the premises for customers to purchase. Mr. Kuykendall confirmed that a child safety lock is provided when handguns are transferred. The business premises are monitored by a monitored security system and video surveillance system. Firearms are kept in locked display cases and gun safes.






