Inspection Profile:

On June 23, 2015 ATF Industry Operations Investigators (b)(6) and (b)(6) conducted a SW Border inspection at the subject business.

Investigator (b)(6) interviewed Gene Lawson, responsible person/store manager. The investigator presented identification and Mr. Lawson presented positive identification recorded as, Oklahoma drivers license (b)(6) , DOB (b)(6) . The inspection covered the period June 23, 2014 – June 22, 2015.

No advance notification was given and no other State, local or federal offices participated in this inspection.

Business Profile:

Dwyte Palmer operates Buck's Pawn Shop as a 02 – Pawnbroker. The licensee sells used firearms as well as takes firearms in as pawns. The licensee also sells a variety of other products in the pawn shop.

Buck's Pawn Shop acquired approximately long guns) and disposed of approximately long guns) and disposed of approximately long guns) during the previous 12 months.

Mr. Lawson stated that Buck's Pawn Shop does not conduct business at gun shows. The business premises are commercially zoned and are in compliance with all zoning requirements.

Mr. Lawson stated that they do not have any off-site storage.

Ownership and Control:

Dwyte Palmer operates Buck's Pawn Shop as a sole proprietor. Investigator (b)(6) conducted a check of the Federal Firearms Licensing System (FLS) which listed Dwyte Palmer, owner, and Gene Lawson, responsible person. No additional responsible persons were added or identified during the inspection.

Investigator (b)(6) did not review any documents or observe any activities, and the licensee did not make any statements during the inspection, that indicated the possibility of hidden ownership, a change in control or a change in ownership.

4 - Acquisition & Disposition (A&D) Record - Inventory

Investigators (b)(6) and (b)(6) reviewed the licensee's A&D book and conducted a full inventory reconciliation. There were 153 firearms in inventory and open dispositions. The licensee was able to locate six ATF Form 4473 for the firearms still open in the A&D Book. {Exhibit 1} This violation is discussed in detail in Section 13 – Violations.

The licensee did not report any thefts or losses during the inspection period.

Investigators (b)(6) and (b)(6) traced 30 firearms from the A&D Book to the ATF Form 4473 with no discrepancies noted.

The A&D Book is kept in the proper format. The investigator did not disclose any trafficking issues not were any obliterated serial numbers discovered during the inspection. The investigators also did not disclose any illegal firearms in inventory.

Mr. Lawson stated the firearms are logged into the A&D Book the day they are delivered to the store. The firearms are then either placed on the shelf for display/sale or they are placed in a locked room.

5 - ATF Forms 4473 - NICS & Other Dispositions

Investigators (b)(6) and (b)(6) reviewed all ATF Forms 4473 on file for the inspection period. The investigators compared with no discrepancies.

Review of the forms resulted in forms with a total of errors: forms violated 478.124(c)(1), forms violated 478.124(c)(3)(i), form violated 478.21(a), forms violated 478.124(c)(3)(iv), form violated 478.102(a), form violated 478.99(c) and forms violated 478.124(c)(5). The violations are discussed in detail in section 14-VIOLATIONS.

During the inspection period, Investigators (b)(6) and (b)(6) found no sales to law enforcement officers utilizing the provisions of 27 CFR § 478.134.

Mr. Lawson stated the ATF Form 4473 is completed by the customer and generally reviewed by the employee conducting the sale prior to completing the transaction. The A&D Book is updated as soon as the purchase is completed.

7 – Suspicious/Prohibited Purchasers

During the review of the ATF Forms 4473, the investigators discovered one form with an expired NICS transaction number and one form where the purchaser checked "yes" in all the prohibited questions.

Investigator (b)(6) conducted criminal history checks using Open Fox for these individual as well as the responsible persons with no prohibiting information disclosed.

No potential traffickers were identified from this review.

8 – Trace Activity

Investigator (b)(6) requested an FFL History Report from the Violent Crime Analysis Branch (VCAB) for the inspection period, resulting in no successful and no unsuccessful trace for this licensee during the inspection period.

The trace history did not identify any firearms traced to Mexico.

9 - NFA/Importer/Collector/Manufacturer

This licensee is not an importer, collector, manufacturer and does not deal in NFA firearms.

10 - Referrals

No referrals were submitted as a result of this inspection.

11 - Other

Investigator (b)(6) observed the Youth Handgun Safety poster and notice properly placed on the premises. The licensee has secure gun storage and safety devices available for sale. The licensee was aware of the requirement to provide a trigger lock for any transferred handgun.

12 - Closing Actions

Investigator (b)(6) held a closing conference with Gene Lawson, responsible person/store manager on June 25, 2015 and reviewed the Report of Violations with him. The investigator went over every violation in detail and obtained a signed copy and provided Mr. Lawson with a signed copy.
