11. ATF OFFICER'S RECOMMENDATION

This is a report of an unannounced firearms compliance inspection concerning the operations of Accurate Law Enforcement - Gov Sales Inc. for the period of June 22, 2014 thru June 22, 2015. The inspection was conducted May 22nd thru June 24th, and concluded on June 26, 2015 at the licensed business premises by Industry Operations Investigator (b)(6).

Vicky Harrison, President (TNDL (b)(6)), and Joseph Harrison, Sales, (TNDL # (b)(6)) interviewed. No advance notice of the investigation was given. No other Federal, State, or local agencies were involved in the investigation.

Violations, ROV, Warning Letter and Recall Inspection

Three of the five violations disclosed included a transfer of four firearms to an individual, who was found not prohibited, without obtaining an ATF F 4473, nor a background check. The licensee was confused about the ATF F 4473 and background check as the firearms did not stay in the store overnight. As for the failure to report the sale of multiple handguns on (b)(6) occasions, the licensee had reported (b)(6) occasions involving (b)(6) handguns. Investigator (b)(6) believes that the FFL will take corrective measures and that a warning conference for this FFL is inappropriate. For these reasons stated above, Investigator (b)(6) is recommending a warning letter and recall inspection.

13. REVIEW AND ROUTING

REVIEW COMMENTS AND RECOMMENDATION

Inspection resulted in five violations being cited. Two of the violations were done due to confusion as the firearms did not stay on the premises overnight and the licensee made a statement indicating that the business transaction could have been misconstrued as a consignment. The licensee also failed to report the sale of multiple handguns on six occasions; however, the licensee had reported ^{(b)(6)} occasions involving ^{(b)(6)} handguns. This is the first time the licensee has ever been cited for these specific violations. In fact the only repeat violation does not warrant anything other than a report of violations.

The IOI is recommending a warning letter and recall. The A/S concurs with the IOI's recommendation and justification.

The licensee was confused about a couple of regulations, but lead IOI believes that the licensee now understands his responsibility in regards to being in compliance with Federal firearms law and regulations. 1 - Introduction

Inspection Profile:

This is a report of an unannounced firearms compliance inspection concerning the operations of Accurate Law Enforcement – Gov Sales Inc. for the period of June 22, 2014 thru June 22, 2015. The inspection was conducted June 22nd thru June 24th, and concluded on June 26, 2015 at the licensed business premises by Industry Operations Investigator (b)(6). Vicky Harrison, President (TNDL (b)(6)), and Joseph Harrison, Sales, (TNDL #0(b)(6)) were interviewed. No advance notice of the investigation was given. No other Federal, State, or local agencies were involved in the investigation.

Business Profile:

The licensee is an independent retail firearms dealer that sells firearms and law enforcement/first responder equipment. The licensee acquired (b)(4) firearms and disposed of (b)(4) firearms in the last 12 months. The licensee's regular business is split into approximately (b)(4) long guns and (b)(4) handguns, (b)(4) new and (b)(4) used. However, in the 12 months the licensee has twice bid on and purchased large numbers of either used duty firearms or confiscated firearms from local sheriff's offices. The duty firearms were primarily sold to the officers that used them on duty. These firearms are not included in the percentages for long gun/handgun or new/used. The licensee's primary suppliers are (b)(4) (b)(4). The licensee does not participate in gun shows. Vicky Harrison also owns Southern Belle Brass, Inc. (FFL #1-62-01266) and it is located on the same premises. This license was not inspected concurrently with the Accurate Law Enforcement compliance inspection. There are no other businesses on the premises. The licensee does maintain a website <http://www accuratelawenforcement.com/>, though purchases are unable to be made on the web-site at this time. 5 - ATF Forms 4473 – NICS & Other Dispositions

Certification letter is on file and contains the correct verbiage.

9 - NFA/Importer/Collector/Manufacturer

The licensee holds a Type 01 Dealer of Firearms FFL and a (b)(3) - 26 USC 6103 (b)(3) - 26 USC 6103. The licensee currently maintains 16 NFA weapons in inventory, 16 of the 13 weapons are silencers. The licensee also maintains three short-barreled rifles. Prior to the inspection IOI (b)(6) contacted the NFA Branch to obtain a list of NFA weapons registered to Accurate Law Enforcement Inc. A comparison of this list to the NFA weapons in inventory was completed. No discrepancies were found.

The appropriate NFA forms were completed and approved for these transfers. There were (b)(3) ATF F's 4473. No discrepancies were found.

10 - Referrals

No referrals were made.

11 - Other

The licensee stated he was aware of the Child Safety Act of 2005 and is providing a gun lock with all handgun purchases. The licensee is displaying the Youth Handgun Safety Act poster and providing all required handouts.

No additional information was disclosed during the inspection.

12 - Closing Actions

A closing conference was held with Vicky Harrison, Responsible Person and President and Joseph Harrison, son of Vicky Harrison and employee. IOI (b)(6) reviewed the Acknowledgement of Federal Firearms Regulations and Report of Violations, as well as answered all of their questions. Ms. Harrison signed the Acknowledgement of Federal Firearms Regulations. The licensee stated she understands the importance of proper record keeping. Ms. Harrison, Responsible Person and President, has attended a Firearms seminar in the past, but was unsure of the date. See Exhibit 16.

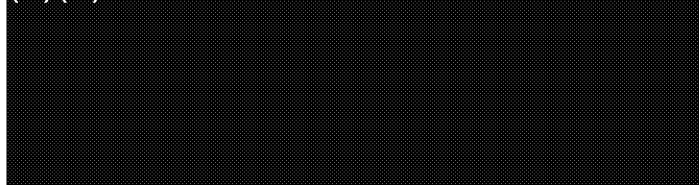
