(Exhibit 2) According to Mr. Fowler, he planned on renewing the Texas Sales and Use Tax Permit, but forgot. He also stated he would renew the Texas Sales and Use Tax Permit within the next couple of weeks.

It is recommended the Federal Firearms License for Cleveland Gun Sales/CLS is not approved for renewal upon expiration until the Texas Sales and Use Tax Permit has been restored.



1 - Introduction

Inspection Profile:

Industry Operations Investigator (IOI) (b)(6) of the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) met with Dale Fowler, Owner, of Cleveland Gun Sales/CLS on August 28, 2015 for the purpose of conducting a disposition emphasis firearms compliance inspection, for a Type 01 Federal Firearms License (FFL). The scope of the inspection was August 28, 2014 to August 28, 2015. The on-site inspection commenced on August 28, 2015 and was completed on September 17, 2015. Advanced notification was given prior to arrival due to a previous trip made to the premises.

Business Profile:

Cleveland Gun Sales/CLS is licensed as a Type 01, Dealer of firearms. Cleveland Gun Sales/CLS acquired a total of (b)(4) firearms, and disposed a total of (b)(4) firearms during the inspection period. Cleveland Gun Sales/CLS takes special orders from family and friends. Cleveland Gun Sales/CLS currently advertises via word of mouth. Cleveland Gun Sales/CLS does not have his own website. Cleveland Gun Sales/CLS conducts business at gun shows.

The business premises are located in Liberty County, Texas. Liberty County, Texas has no zoning restrictions in place which would prohibit the business activity being conducted. The business premises are located in a suburban area. The business premises are suitable.

According to the Liberty County Appraisal District, Dale Fowler is the owner of the premises. (*Exhibit 1*) According to Mr. David Fowler, no other business is conducted from the premises.

Mr. Fowler has a valid assumed name certificate for "Cleveland Gun Sales/CLS", which expires March 2, 2021. A copy is in the area office file.

Mr. Fowler was reminded by IOI (b)(6) of ATF's right to enter the premises to inspect records and inventory. No firearms will be stored off-site.

Mr. Fowler does not hold any other ATF licenses, or any applicable state or local firearms-related licenses.

Cleveland Gun Sales/CLS operates as a sole proprietorship. Mr. Fowler stated there had been no changes in ownership.

At the time of inspection, Cleveland Gun Sales/CLS was not in possession of a valid Texas Sales and Use Tax Permit. According the State of Texas Comptroller's office, the Texas Sales and Use Tax Permit (b)(3) - 26 USC 6103 has expired. This was verified by IOI (b)(6). (*Exhibit 2*) According to Mr. Fowler, he planned on renewing the Texas Sales and Use Tax Permit, but forgot. He also stated he would renew the Texas Sales and Use Tax Permit within the next couple of weeks.

The current Federal Licensing System registration report (FLS) lists Dale Fowler as the only Responsible person/Owner for the business. There were no signs of hidden ownership detected. NCIC/NLETS criminal history queries were conducted with no disabling hits found.

4 - Acquisition & Disposition (A&D) Record – Inventory

A physical inventory was conducted by IOI (b)(6). Mr. Fowler had a total of (b)(6) firearms in business inventory which coincided with (b)(6) open entries in the A&D book. At the time of inspection, Cleveland Gun Sales/CLS utilized two manual A&D books, (gunsmith activities and firearms sales) which kept information in the proper format as required by ATF guidelines. A total of 25 firearms were tracked through the licensee's book from acquisition to disposition with no discovered discrepancies. There were no thefts or losses reported during the inspection period, nor was there any discovery of obliterated serial numbers or illegal firearms. No trafficking indicators were found. All entries were timely made. According to the licensee, his standard operating procedures in regards to the A&D records and inventory is to immediately log all firearms into the A&D records upon receipt of the firearms, and to log firearms out of the A&D records immediately after a transfer is made.

5 - ATF Forms 4473 – NICS & Other Dispositions

There were a total of (b)(6) ATF Forms 4473 utilized during the inspection period. The forms were reviewed for accuracy and completeness. There were discrepancies. Mr. Fowler was cited for violations of **27 CFR 478.21(a)**, Failure to obtain and/or furnish all information required in each ATF Form 4473 as indicated by the headings on the form and the instructions on or pertaining to it, **27 CFR 478(c)(5)**, Failure to sign and/or date the ATF Form 4473 when the licensee does not know or have reasonable cause to believe that the transferee is disqualified by law from receiving the firearm on two known occasions, and **27 CFR 478(c)(3)(iv)**, Failure to comply with the requirements of Sec.478.102 to contact NICS after the transferee has completed "Section A" of the ATF Form 4473.

There were no sales of firearms to law enforcement. There were transfers to and from other licensees. These types of transfers were conducted correctly. IOI (b)(6) received an FFL audit log for the licensee. There were 11 NTN's to review and check for accuracy. There were no discrepancies with the FFL audit log. There were no trafficking issues noted during the inspection period.

6 – Multiple Sales

There were no reported multiple handgun sales transactions involving two or more pistols during the inspection period. There were no reported long gun sales transactions involving a total of two or more firearms during the inspection period.

Prior to inspection, IOI (b)(6) received a Firearms Trace History Report of the licensee from the Violent Crime Analysis Branch (VCAB). There were no traces of firearms to Cleveland Gun Sales/CLS during the inspection period. There were no unresolved traces since the acquisition of the firearms license.

9 - NFA/Importer/Collector/Manufacturer

Cleveland Gun Sales/CLS does not conduct any NFA, Importer, Collector, or Manufacturer operations.

10 - Referrals

No referrals were made as a result of this inspection.

11 – Other

The licensee's Type 01 FFL and Youth Handgun Safety Act poster were posted and verified by IOI (b)(6). Youth Handgun Safety Act Notice pamphlets were available for distribution.

12 - Closing Actions

On September 17, 2015, Investigator (b)(6) conducted a closing conference with Mr. Fowler, owner. The meeting took place at the licensed premises. Mr. Fowler was given the opportunity to ask questions regarding federal firearm laws and regulations. He was presented with the Report of Violations listing the violations that were discovered during the inspection. He demonstrated a clear understanding of what had been discussed.
