Please remove the trade name of Fountain Firearms on 5-76-28557.

Since 2004, the licensee has had five compliance inspections. The inspection in 2004 resulted in a recall inspection based on two violations. The inspection in 2007 resulted in a WL, based on three violations, of which, two were repeat violations. The inspection also resulted in 2009 resulted in a WC and a recall inspection based on 13 violations, of which ten were repeat violations. This inspection also resulted in 23 missing firearms after ATF inventory, reported missing on F20090001753. The inspection in 2011 resulted in a WC with a WL, and a Recall Inspection, based on seven violations, of which five were repeat violations. This inspection also resulted in 11 missing firearms after ATF inventory, reported missing on F20110000963. The inspection in 2012 resulted in a WL and a Recall Inspection based on six violations, of which, all six were all repeat violations. This inspection also resulted for 15 violations.
