Under the provisions of 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73, notice is hereby given of the revocation of the Federal firearms license specified above, in that the Director, Industry Operations, United States Department of Justice, Bureau of Alcohol, Tobacco, Firearms and Explosives ("ATF"), Chicago Field Division, has reason to believe that Craig G. Bricco, d/b/a 1st Class Firearms, 2453 Sheridan Road, Zion, Illinois 60099 ("Licensee"), a Dealer, Including Pawnbroker, in Firearms Other Than Destructive Devices, willfully violated the provisions of the Gun Control Act of 1968, as amended, 18 U.S.C. Chapter 44, and the regulations issued thereunder, 27 C.F.R. Part 478.

#### Compliance History

ATF issued a Federal firearms license to the Licensee following a qualification inspection conducted on approximately April 11, 2006. After the Licensee added the trade name 1<sup>st</sup> Class Firearms, ATF conducted an amended application inspection in approximately January of 2008. ATF also conducted a compliance inspection of the Licensee on approximately August 6, 2009 and a recall inspection on approximately June 5, 2013. Following both the compliance and the recall inspections, ATF issued a Report of Violations to the Licensee. As a result of these inspections, the Licensee, Mr. Craig G. Bricco, attended warning conferences with ATF on approximately January 28, 2010 and September 23, 2013. During the warning conferences, the Licensee discussed the cited violations and proposed corrective action with ATF. Following each warning conference, ATF sent the Licensee a letter advising that "any future violations, either repeat or otherwise, could be viewed as willful and may result in revocation of [its] license."

#### **Current Inspection**

On February 3, 2015, ATF Industry Operations Investigators ("IOI") (b)(6) and (b)(6) (b)(6) conducted a compliance inspection of the Licensee's premises that covered the period February 1, 2014 through February 3, 2015. The inspection revealed the following:

- 1. The Licensee, by and through its agents and employees, willfully failed to timely and/or accurately record the disposition of (b)(3), Public Law 112-55, 124 Stat. 552 firearms, in violation of 18 U.S.C. § 923(g)(1)(A) and 27 C.F.R. § 478.125(e). See Appendix A, ¶ 1.
- 2. The licensee, by and through its agents and employees, willfully failed to obtain a complete Form 4473 from the transferee prior to making an over-the-counter transfer of a firearm to a non-licensee on [b)(3), Public Law 112-55, 124 Stat. 552] occasions, in violation of 18 U.S.C. § 923(g)(1)(A) and 27 C.F.R. § 478.124(c)(1). See Appendix A, ¶ 2.

- 3. The licensee, by and through its agents and employees, willfully transferred a firearm to a non-licensee without recording required NICS information on the Form 4473 on (b)(3), Public Law 112-55, 124 Stat. 552 occasions, in violation of 18 U.S.C. § 923(g)(1)(A) and 27 C.F.R. § 478.124(c)(3)(iv). See Appendix A, ¶ 3.
- 4. The Licensee, by and through its agents and employees willfully failed to execute Form 4473 as indicated by the headings on the form and the instructions on or pertaining to the form on (b)(3), Public Law 112-55, 124 Stat. 552, in violation of 18 U.S.C. § 922(m) and 27 C.F.R. § 478.21(a). See Appendix A, ¶ 4.
- 5. The Licensee, by and through its agents and employees, willfully failed to timely and/or accurately record the acquisition of \$(0,0), Public Law 112-55, 124 Stat. 552 firearms, in violation of 18 U.S.C. § 923(g)(1)(A) and 27 C.F.R. § 478.125(e). See Appendix A, ¶ 5.


Firearms for Which Licensee Could Account Following Inventory Reconciliation





## Hearings

A determination has been made to deny your original or renewal application for a Federal firearms license or to revoke your existing Federal firearms license.

As indicated on the enclosed form, you have the right to request a hearing. This brochure provides general guidance and an overview of the hearing process for industry members that may assist you in making a decision to request a hearing, and to appropriately prepare for a hearing should you request one.

## Background

The Gun Control Act of 1968 and its implementing regulations specify certain licensing requirements for those intending to engage in a firearms business.

ATF is authorized to deny a license when an inspection reveals the applicant is not qualified to receive or not qualified to continue to hold the license. ATF may also revoke a license when it is determined that a

current licensee is no longer eligible to continue licensed operations.

## **Your Rights**

ATF has made one of the above determinations in your case, issuing you either a Notice of Denial or a Notice of Revocation of License. You have the right to request a hearing to review the proposed denial or revocation action found in the notice you received. This is done by submitting written notification to the Director, Industry Operations (DIO) who issued your Notice. Timeliness is important. You only have 15 days from your receipt of the Notice to request a hearing.

Although you may hire an attorney, it is not required, although it may be in your interest to do so. That is your option.

## **Hearing Overview**

If you submit a letter requesting a hearing to the DIO in time, the DIO or his/her representative will begin to make arrangements for the hearing. The date and time of the hearing will be set by ATF, but you will be consulted as to your availability. ATF will also notify you of the location of the hearing, taking into consideration convenience to you and the availability of government office space that is close to you to conduct the hearing. Once the date, time, and place are set, you will be notified in writing (via certified mail, return receipt requested).

**NOTE:** Under no circumstances will you, your representative, or witnesses be permitted to bring firearms or any other

weapons to the hearing. The hearing will not begin, or will cease, if it is determined this policy has been violated.

The hearing is generally scheduled not later than 90 days from the date of the letter notifying you of the date, time, and location of the hearing. There are, however, limited circumstances that may require the hearing to be rescheduled for good cause, as determined by the DIO.

The hearing itself is informal in nature, and adherence to civil court rules and procedures is not required. There is no sworn testimony and formal courtroom procedures are not required. The hearing is recorded via audiotape recorder. The resulting tape, along with exhibits presented at the hearing, constitute the official record of the hearing.

ATF does not videotape the hearing proceedings and you will not be allowed to videotape the hearing. You may make an audiotape recording of the proceedings, or have the proceedings recorded by a stenographer at your own expense, provided this recording is not disruptive to the proceedings. However, the ATF recording of the hearing is the official record of the proceeding.

## **Hearing Officer**

The hearing officer is designated by ATF. The selection of the hearing officer is dependent upon a number of factors, including the nature of your case. A hearing officer will be selected who has no prior knowledge of your case and has had no interactions with you or your licensed operations. In most cases, the assigned hearing officer will come from outside the

ATF field division in which your licensed business is located.

## **Conduct of the Hearing**

The hearing officer will ensure the proceedings are conducted in an orderly and professional manner. The purpose of the hearing is to allow both parties to fully present all relevant evidence and arguments regarding the denial or revocation of a license or permit. Most hearings require less than a single day to complete.

The government will be represented by an attorney and will present its evidence first. The government will generally call as a witness the ATF industry operations investigator(s) who conducted your application or compliance inspection, or other ATF employees who have relevant information concerning your case.

At the conclusion of the government's presentation, you will have the opportunity to respond. Make sure you state your case as clearly and factually as possible. The case you present will receive the same consideration by the hearing officer as the government's case. Be willing and prepared to address each violation described in the Notice you received. You may call witnesses. Your witnesses should be able to speak to the findings in the Notice, and may be, for example, the store manager, an employee, bookkeeper, or clerk. You may also present relevant evidence. Relevant evidence is evidence which tends to prove or disprove an issue at the hearing, such as whether the alleged violation occurred as stated in the Government's Notice of Denial or Revocation.

Both parties have the right to question all witnesses. The party calling a witness shall have the right to re-direct examination of the witness. You should need no legal training to state your case. The most important consideration is that both parties—you and the government—are given a chance to fully explain the findings and violations disclosed during the application inspection or compliance inspection.

When the hearing officer is satisfied all evidence and arguments have been fully presented by the parties, the hearing officer will advise you that the DIO will make a decision in the matter and will notify you of the final decision in writing.

Following completion of the hearing, the hearing officer prepares a factual report summarizing the proceedings. This report will be forwarded to the DIO, who makes the denial or revocation decision for ATF.

A license may be denied based on your failure to satisfy licensing requirements, or based on past willful violations.


Generally speaking, ATF will cite willful violations as the basis for revocation cases. Willful violations are those violations meeting the statutory requirement for denial or revocation. "Willfulness," as defined by the courts means the purposeful disregard of a known legal duty, or plain indifference to a licensee's legal obligation. ATF is not required to prove you *intended* to violate the law, only that you knew your legal obligation as a licensee, and you purposefully disregarded this obligation or were plainly indifferent to your obligation.

If, after review of the entire record, you failed to satisfy licensing requirements, or willful violations are found, the DIO may issue a final notice of denial or revocation, which will be sent to you via certified mail.

If you are not satisfied with the final decision of the DIO, you may appeal the decision to Federal district court within 60 days. The hearing proceedings may become part of the review.

If you have any questions concerning the hearing, please contact the DIO for the ATF division in which you are located.

#### 1 - Introduction

#### **Inspection Profile:**

This assignment was issued to Senior Investigator (b)(6) as a full scope recall compliance inspection of this firearms dealer who was subject to a Warning Conference after the last inspection conducted in June/July 2013. That inspection disclosed nine cited violations of the Gun Control Act's regulations.

This inspection was begun by IOIs (b)(6) on February 3, 2015 and a closing conference was held on March 5, 2015. Report of Violations was issued citing twelve violations, eight of which were repeat from previous inspections.

#### **Business Profile:**

1st Class Firearms is a retail gun shop located on a major highway in Zion, Illinois, a far northern suburb of Chicago, very near to the Wisconsin state line. The store sells handguns, long guns and receivers, as well as firearms accessories. During the 12 months prior to this inspection, 1st Class Firearms acquired (b)(4) firearms (b)(4) handguns, long guns, receivers); and took in firearms for gunsmith work (b)(4) handguns, long guns, receivers). During this same time period, the shop transferred (b)(4) firearms (not including the return of repair firearms), of which went to other FFLs. They do transfers of firearms purchased over the internet as well as provide new and used firearms to walk-in customers. This FFL is on the Demand Letter, therefore, the Used Firearms Objective (UFO) was not addressed during this inspection.

Craig Bricco also holds a Type 06-Manufacturer of Ammunition license at this same location. No inspection of that license was done at this time.

#### Ownership and Control:

This license is issued as a sole proprietor/individually owned to Craig G. Bricco. He uses the trade name of 1<sup>st</sup> Class Firearms. Mr. Bricco is a full-time employee at Naval Station Great Lakes working as a civilian in the IT department. 1<sup>st</sup> Class Firearms is run and managed on a day-to-day basis by Cristopher S. Bricco and employs at least two part time individuals. Craig Bricco is present at the shop in the late afternoons and evenings. He states he is primarily responsible for the required record keeping.

Currently the responsible persons for the license are Craig Bricco, Cristopher Bricco, Marie Corley and Ariel Rivera. Cris Bricco stated that Ariel Rivera is not often present at the shop any more due to a full-time job elsewhere.

#### Variance:

Craig Bricco currently has two approved variances (#11-0179 and #11-0179A). Both deal with the use of the eForm 4473. (See Exhibit #1) The first one allows them to use an electronic signature for the firearm purchaser. The second allows for them to enter the NICS information onto the eForm 4473 by having it autopopulated by the NICS or appropriate State agency system. This inspection disclosed that on several occasions, the NICS information was entered into the eForm 4473 prior to the form being printed and signed by the purchaser. The approved electronic signature was not used. In addition, the approval requires that the license contact FBI NICS or appropriate State agency to request authorization to transfer specific NICS data from eCheck into their computerized system. Since the noted instances were actually manually entered into the eForm 4473 by Cristopher Bricco, this is not in compliance with the approved variance. In addition, the variance approvals could not be located by Cris Bricco and he had to request copies of them from ATF Firearm Industry Programs Branch.

When asked if their computerized system (AIMI eBook by Coloseum Software Corporation) had been approved previously by ATF or any other investigator, Cris and Craig Bricco produced a letter from Chief, Firearms Program Division dated 12/9/2008, advising them that if the eForm 4473 built into the AIMI eBook application meets all basic criteria outlined in ATF Ruling 2008-3, no additional variance approval is needed. (See Exhibit #2)

This inspection, as did previous inspections, found that the eForm 4473 built into the AIMI eBook does not meet requirements, specifically due to the fact that a repeat customer's information is auto-populated into Section A by the system. The clerk merely asks the customer to verify the information is correct. It is not personally entered by the customer each and every time, as is required by instructions on the Form 4473. **Licensee was cited for this violation.** (See Report of Violations #9; Exhibit #3)

#### 2 - Recommendation

Due to the repeated and willful violations found during this inspection, Revocation of this license is recommended.

#### 4 - Acquisition & Disposition (A&D) Record - Inventory

On February 3, 2015, IOIs (b)(6) began an unannounced inspection of this licensee at the premises listed above. A complete inventory was conducted, initially using a listed printed from 1<sup>st</sup> Class Firearms website showing available firearms. When Craig Bricco arrived at the shop, he was able to print up a current inventory list from the AIMI eBook system. The inventory was eventually reconciled with firearms unaccounted for. A total of 269 firearms were on the business premises (251 business inventory, 18 repair guns). The A&D record contained open entries, resulting in unrecorded dispositions of which were in the gunsmithing A&D record; from the previous inspection) and firearms that could not be accounted for and were reported as missing from inventory. (See Report of Violations #12; Exhibit #4; Exhibit #5; Worksheet #1)

Comparison of firearms in inventory to A&D record information resulted in incorrect serial numbers, incorrect manufacturer, firearms in inventory incorrectly logged out, and firearm not logged in as an acquisition. In addition, entry contained incorrect acquisition information and entries contained incorrect disposition information. (See Report of Violations #12; Exhibit #4; Exhibit #5; Exhibit #6; Worksheet #1)

Craig Bricco provided all acquisitions and/or dispositions that occurred during the inspection period of 2/1/2014 to 2/3/2015. During the Form 4473 review, a total of dispositions were compared with A&D record entries and no discrepancies were noted.

#### 5 - ATF Forms 4473 - NICS & Other Dispositions

Craig Bricco maintains completed Forms 4473 in binders labeled by the forms serial numbers applied by the AIMI eBook system. Licensee was also filing Forms 4473 for denied NICS/FTIP checks in the same binders. However, these forms only consisted of page 1 and page 2. The third and subsequent instruction pages were not present for these denied transactions. This is contrary to criteria #7 and #11 in ATF Ruling 2008-3, and Section 478.129(b). (See Report of Violations #9, #11; Exhibit #7)

For the review period of February 1, 2014 through February 3, 2015, the licensee had Forms 4473 on file, which were closely reviewed by IOIs (b)(6) for accuracy and completion. During the review NICS/FTIP information was verified for transactions. Errors and omissions were found and cited on the Report of Violations. They included the following:

Incomplete name of purchaser
Incomplete/incorrect address of purchaser
Signatures/dates missing for both transferee and transferor
NICS information errors and omissions
Errors on Question 11a
Firearms description errors

In addition to the above, it was disclosed that the licensee transferred receivers to outof-state residents and a purchaser under the age of 21. NICS was initiated on an incorrect Illinois FOID card on one occasion, resulting in the transfer of a firearm with no background check. On five occasions, a firearm was transferred more than 30 days after the initiation of a NICS check without a subsequent check being done. (See Report of Violations #1, #2, #3; Exhibit #8; Exhibit #9; Worksheet #2)

As stated in a previous section, this licensee uses an eForm 4473 as part of the AIMI eBook system by Coloseum Software. The licensee was occasionally allowing customers to use a laptop computer station on the gun counter which was not in the "kiosk" mode. This kiosk mode requires the customer to enter information in Section A personally each and every time. The laptop on the counter would be in the "administrator" mode and would auto-populate Section A for repeat customers. During the closing conference, Craig and Cris Bricco assured IOIs (b)(6) that they would no longer allow customers to access eForm 4473 in any other mode except the "kiosk mode."

It was also disclosed, by RP Cris Bricco, that on occasion, he would initiate NICS/FTIP background checks in the evening after customers had completed Section A of the form. He would then insert the information electronically on the Form 4473 and reprint the second page. When the customer returned to pick up the firearm, he

would have them resign the newly printed page and back date it to the original date. He would then destroy the original page that was printed and signed prior to the NICS check. IOIs (b)(6) advised him that it could be viewed he was requiring his customers to "falsify" the Form 4473. He was advised to cease this practice.

During the closing conference, this situation was discussed with Craig Bricco and he denied this practice was occurring until he was told that Cris Bricco related it to the IOIs. Craig Bricco acknowledged that he had an approved variance to electronically insert the NICS information on the form, but was advised by IOIs that this should be used in conjunction with his approved variance for the electronic signature. At that point, he would have a Form 4473 completed and certified by the purchaser. Craig Bricco stated that he is still not set up with a proper signature pad to be able to use the electronic signature. He was cautioned to thoroughly read the variance approval and abide by all criteria specified in it.

#### 6 - Multiple Sales

Craig G. Bricco d/b/a 1st Class Firearms reported multiple sale transactions involving firearms, according to the Violent Crime Analysis Branch. While reviewing the Forms 4473, it was determined that instances of a multiple sale involving handguns were not shown in the VCAB report. Forms 3310.4 were present for all instances, attached to the respective Forms 4473. During the closing conference, licensee was instructed to resubmit the forms to ATF.

Also during the Form 4473 review, it was disclosed that instance of a multiple sale was not reported by the licensee, as it was not shown in the VCAB report and a Form 3310.4 was not present with the Form 4473. (See Report of Violations #10; Exhibit #10)

#### 7 - Suspicious/Prohibited Purchasers

No prohibited purchasers were disclosed during the Form 4473 review. The purchasers who had answered either "no" or failed to answer question 11a were run through eTrace and Illinois LEADS. No prohibitors or suspicious activity was disclosed. In all, individuals were run through LEADS and eTrace for additional information. No suspicious information or activity was disclosed.

A review of the traces associated with this licensee for the previous 12 months did not disclose any suspicious individuals with the exception of Senior IOI (b)(6)

# checked Illinois LEADS and verified (b)(3) Pub law 112-55 125 Stat. 552 not associated with any other firearms traces.

Of the above traces, disclosed that the firearm was recovered from someone other than the purchaser. All of these individuals were run through eTrace for additional traces. Only individuals were found to be involved in additional trace. No suspicion of trafficking was evident.

## 8 - Trace Activity

During the 12 months prior to this inspection, 1st Class Firearms was the final lice	ensee
for traced firearms. These traces were analyzed and (b)(3) Pub law 112-55 125 States	i. 552

firearms traced were recovered in the possession of someone other than the purchaser. These individuals were all run through eTrace, and they were not involved in any other traces.

## 9 - NFA/Importer/Collector/Manufacturer

Craig G. Bricco d/b/a 1<sup>st</sup> Class Firearms does not pay NFA SOT and does not deal in or possess any NFA weapons. No firearms have been imported by this licensee, and he does not possess a Type 03 collector's license.

Manufacturing vs gunsmithing activities were discussed with the licensee and employee (b)(6). They were advised of when a manufacturing license is required and when their activities are considered by ATF to be gunsmithing, i.e., assembling and/or building firearms from receivers and/or parts already owned and provided by customers. They all indicated that this is how they conduct business. They were advised that comments by their customers on the shop's Facebook page indicated the possibility that custom firearms are being ordered and assembled by Mr. Bricco and then sold to the customers. They advised that the kind of customization or "building" referred to is on already completed firearms such as Anderson Manufacturing AR-15 type rifles wherein custom scopes, etc. are attached and then sold to the customer.

The licensee was provided with a copy of ATF Ruling 2015-5 to clarify ATF Ruling 2010-10 and any misconceptions about when activities may cross over into the realm of manufacturing.

Just prior to and during the closing conference, it was disclosed by Craig Bricco that firearm he had on the display shelf for sale was actually received by him as a receiver (b)(3) Pub law 112-55 125 Stat. 552) and Craig built it into a rifle. IOI (b)(6) advised him that this was clearly within ATF's definition of manufacturing and that he should remove it from the display shelf for sale. Mr. Bricco advised that he would.

#### 10 - Referrals

No referrals were made as a result of this recall inspection.

#### 11 - Other

During the Form 4473 review, it was observed that numerous forms indicated that a firearm may have been transferred without the required state of Illinois waiting period. This was discussed with Cris Bricco who advised that they always wait the waiting period but according to the Illinois State Police website, it can begin when a customer purchases a firearm online in an auction or from an online website. By the time the firearm is shipped to and received by Bricco, the waiting would already have been met. IOIs (b)(6)

suggested that they maintain some form of documentation to prove the waiting period had been met, should the need to do so ever arise.

#### 12 - Closing Actions

On March 5, 2015, Senior IOI(b)(6) and IOI(b)(6) conducted a closing conference with Craig and Cris Bricco at the licensed premises. The Report of Violations was presented and explained in detail to both individuals. Craig Bricco was concerned that his employees were not properly trained on all aspects of the Form 4473, and he ensured that his son, Cris, would now convey all these issues to them. He advised that the one employee, (b)(6) will soon be leaving the state and will no longer work there.

It was also discussed with Mr. Bricco that his "employees" are not actual employees but are "contractors" to whom he provides a Form 1099 at the end of the year. IOIs (b)(6) explained that if employees are not actually on the payroll of the business to which the FFL is issued, they cannot be in charge of the firearms and their disposition without one of the responsible persons being present. Mr. Bricco stated he was not aware of this, but after a thorough explanation of the contents of ATF Ruling 2010-1, he indicated he understood and when replacements need to be found, they will be hired as actual employees. Until then, he stated that his son, Cris, will be present at the store.

Due to some of the issues disclosed with the AIMI eBook system, the eForm 4473 was

examined at length. IOI (b)(6) completed a test form to see if the system would stop a possible sale when certification question 11a is answered "no." This was found on at least occasions and cited in the Report of Violations. It was disclosed that the system would allow the transaction to continue and the Form 4473 to be printed. Craig Bricco emailed and telephonically contacted Coloseum Software and a representative was consulted via speaker phone in the presence of IOIs (b)(6). The representative stated that since question 11a is "an optional field," there were no safeguards to prevent a transaction from continuing. IOIs (b)(6) agreed that in rare instances, question 11a is not required to be answered (i.e., return of a repair firearm to someone other than from whom it was received). However, Craig Bricco and IOIs (b)(6) also agreed that it is an item on the Form 4473 that needs to be correct and to be verified by the transferor for each transfer.

The Acknowledgement of Federal Firearms Regulations overview form was reviewed and discussed with both Craig and Cris Bricco. Craig Bricco wanted to ensure that Cris was privy to all aspects of this closing conference and clearly understands the regulations. All questions posed were answered. Mr. Craig Bricco signed and dated the form and was provided with a copy for his records. (See Exhibit #11)

#### 13 - Violations

#### 1. 27 CFR 478.99(a) – REPEAT OF VIOLATIONS IN 2013 AND 2009

Nature of Violation: During the review of completed Forms 4473, it was disclosed that the licensee transferred receivers on occasions to purchasers who were not residents of the state of the state of Illinois. (See Forms 4473 # (D)(3) Pub law 112-55 125 Stat. 552

Licensee's Response: Craig Bricco stated he does not remember ever hearing that receivers could not be sold to out-of-state purchasers. He stated he had a problem with the wording that said "repeat of violations in 2013 and 2009." IOI (b)(6) searched the previous reports and found that it had only occurred during the 2013 inspection, so IOI (b)(6) removed the reference to the 2009 inspection.

**Corrective Action:** No corrective action is required for this violation. Licensee was provided with a copy of ATF Open Letter dated July 7, 2009, and instructed on the contents of the letter.

#### 2. **27 CFR 478.99(b)(1)**

**Nature of Violation:** During the review of completed Forms 4473, it was disclosed that the licensee transferred a receiver to purchaser who was not yet 21 years of age. (See Form 4473

**Licensee's Response:** Craig Bricco stated again that he does not remember ever hearing that receivers can only be sold to someone with his state (Illinois).

**Corrective Action:** No corrective action is required for this violation. Licensee was provided with a copy of ATF Open Letter dated July 7, 2009, and instructed on the contents of the letter.

#### 3. 27 CFR 478.102(a) – REPEAT OF VIOLATION IN 2013

Nature of Violation: During the review of completed Forms 4473, it was disclosed that on occasion, a firearm was transferred to a non-licensee and a NICS check was never initiated on this purchaser. (See Form 4473 # The FOID identification number used in the NICS check was not for the purchaser identified on Form 4473

It was also disclosed that on occasions, licensee transferred a firearm more than 30 days after the initiation of a NICS check, and a subsequent NICS check was not conducted. (See Forms 4473 (b)(3) Pub law 112-55 125 Stat. 552

Licensee's Response: Craig and Cris Bricco explained that the person with the FOID # that was used came in earlier that day and for some reason, they used that FOID # instead of the number of the actual purchaser. Cris said he does not know how that happened. Craig Bricco stated they all know better in regards to the 30 day time limitation on NICS checks. They are just not paying enough attention. IOI (b)(6) advised them the 30 days starts the day after the NIC call-in/initiation.

**Corrective Action:** No corrective action is required for this violation. Licensee was thoroughly instructed on all NICS requirements.

#### 4. 27 CFR 478.124(c)(1) – REPEAT OF VIOLATIONS IN 2013 AND 2009

**Nature of Violation:** During the review of completed Forms 4473, the following errors/omissions were found:

- forms failed to contain complete (first/middle/last) name of purchaser in block #1
- forms failed to contain complete/correct purchaser address in block #2 forms did not contain alien registration numbers in block #15 for resident alien purchasers
- forms did not contain a signature and date in certification blocks #16 & #17 forms contained incorrect certification dates in block #17

**Licensee's Response:** Craig Bricco stated that all his employees should and do know better and know how the form should be filled out.

**Corrective action:** No corrective action is required for this violation. Licensee was thoroughly advised on the proper completion and review of ATF Forms 4473.

## 5. **27 CFR 478.124(c)(3)(i)**

Was found that did not contain proper identification document information for an out-of-state purchaser. (b)(3) Pub law 112-55 125 Stat. 552

**Licensee's Response:** Cris Bricco stated the purchaser was active U. S. military and had the Washington driver's license. Both Cris and Craig Bricco indicated they did not know they needed to record the additional documentation on the Form 4473. They were advised that an active duty military member must show their PCS orders to prove residency in the state in which they are stationed. Neither indicated that these orders were presented in this transaction.

**Corrective Action:** No corrective action is required at this time. Licensee was thoroughly instructed on the proper identification required for firearms transfers and the need to properly document all identification documents used to positively identify each purchaser.

#### 6. 27 CFR 478.124(c)(3)(iv) – REPEAT OF VIOLATIONS IN 2013 AND 2009

**Nature of Violation:** During the review of completed Forms 4473, the following errors/omissions were found:

forms contained incorrect or blank date of NICS call-in in block 21a forms failed to contain correct information in block 21c regarding NICS forms failed to contain correct information in block 21d regarding NICS

**Licensee's Response:** Craig Bricco stated that his employees know better and these errors/omissions should not have happened.

**Corrective Action:** No corrective action is required for this violation. Licensee was thoroughly advised on the proper completion and review of ATF Forms 4473.

#### 7. **27 CFR 478.124(c)(4)**

Nature of Violation: During a review of completed Forms 4473, forms were

found to contain incorrect information in block #29 (type of firearm).

**Licensee's Response:** Craig Bricco stated that the type of firearm had probably been entered incorrectly into the computer system. He showed IOIs how the system had several different versions of the word "pistol" as well as the word "revolver," due to misspellings.

**Corrective Action:** No corrective action is required for this violation. Licensee was thoroughly advised on the proper completion and review of ATF Forms 4473.

#### 8. 27 CFR 478.124(c)(5) – REPEAT OF VIOLATIONS IN 2013 AND 2009

Nature of Violation: During the review of completed Forms 4473, it was disclosed that form failed to contain the signature of the transferor in block #34; and forms failed to contain the date of transfer in block #36.

**Licensee's Response:** Neither Craig nor Cris Bricco had any response for this violation, but Craig acknowledged it by nodding his head.

**Corrective Action:** No corrective action is required for this violation. However, it was suggested the licensee make a photocopy of the referenced forms and insert the required signature and date on the copies, filing them with the original Forms 4473.

#### 9. **27 CFR 478.21(a) – REPEAT OF VIOLATIONS IN 2013 AND 2009**

**Nature of Violation:** During the review of completed Forms 4473, the following errors/omissions were found:

forms contained "no" answers to question 11a; and 1 form contained blank Answer to question 11a

form contained an error in block #18 (type of firearm)

form failed to contain a signature and date in recertification blocks #24 & #25 form failed to contain a recertification date in block #25

form contained an incorrect recertification date in block #25

The review also disclosed that Forms 4473 for a NICS denial forms) only contained pages 1 and 2 (eForm), and page 3 was not present with the required information entered into blocks #33, #34, and #35, as required by instructions on the form. Use of eForm 4473 (Ruling 2008-3) requires in item #7 of the Ruling that all pages of the eForm 4473 be printed prior to the purchaser signing and dating in Section A, blocks 16 and 17. Item #11 again reiterates that all pages be printed, stapled and retained as a "complete package."

Licensee is using an electronic Form 4473which, when a repeat customer begins the process of completing the form, the system automatically populates the customer's information in blocks 1 through 10b of Section A, in violation of this section and the instructions on the form directly above Block 31 {Must be Completed Personally By Transferee (Buyer)}.

**Licensee's Response:** Craig Bricco explained that the computer might have been in management mode which may have allowed question 11a issues to be answered as "no" and the transaction to continue. After discussion with Coloseum Software, it was found that the program does not alert for this question. Craig had no excuse for the other errors. They will start printing out the complete form and enter the required information in blocks #33, #34 & #35 on denials. Also, Craig contacted the company and determined they need to have the customer use the separate kiosk terminal in order to complete the e4473. The kiosk does not allow for auto-populating of the Form 4473.

**Corrective Action:** No corrective action is required for Form 4473 errors/omissions in paragraph 1. Licensee was thoroughly advised on the proper completion and review of ATF Forms 4473.

Licensee was instructed to immediately begin printing out all Form 4473 pages for denied NICS inquiries and ensure that blocks #33, #34, and #35 are completed. Licensee was provided with a printed copy of ATF Ruling 2008-3.

#### 10. **27 CFR 478.126a – REPEAT OF VIOLATIONS IN 2013 AND 2009**

Nature of Violation: During the review of completed Forms 4473, it was disclosed that the licensee failed to complete and submit one Multiple Sale report (Form 3310.4) for the transfer of (b)(3) Pub law 112-55 125 Stat. 552, (b)(6)).

Licensee's Response: Craig Bricco had no excuse for this. He stated the system flags all multiple sales and generates the required report form. He stated he does not know why this one did not generate but verified that the report had not been created.

**Corrective Action:** Licensee is instructed to complete the required multiple sale report (Form3310.4) as soon as possible and submit it to ATF as required, but NLT 3/13/2015. On 3/30/2015, it was verified that this report had been submitted.

#### 11. **27 CFR 478.129(b)**

**Nature of Violation:** During the review of completed Forms 4473, it was disclosed that Forms 4473 on which a NICS background check had been denied were filed numerically with the completed Forms 4473 for firearm transfers, contrary to

regulation requirements.

**Licensee's Response:** Craig stated they keep a separate book for cancelled forms, but admitted there was not a separate one for the denied forms which were filed with the completed Forms 4473. He stated they will immediately begin filing them properly.

**Corrective Action:** Regulations required forms 4473 on which a NICS denial was received be filed separately from completed Forms 4473, either chronologically or alphabetically. Licensee was instructed to file all "denied NICS" Forms 4473 separately from other Forms 4473. On 3/30/2015, it was verified this had been done.

#### 12. **27 CFR 478.125(e) – REPEAT OF VIOLATIONS IN 2013 AND 2009**

**Nature of Violation:** The following errors and omissions were found in the licensee's electronic A&D records:

firearm in inventory was not logged into the A&D records as an acquisition entries contained an incorrect serial number when compared with the firearm entry contained an incorrect manufacturer when compared with the firearm entry contained incorrect acquisition information disposition was incorrectly entered for a firearm still in inventory entries contained incorrect disposition information dispositions were not entered into the A&D record for a firearm no longer in inventory in the gunsmithing record, in the main A&D record) dispositions for firearms could not be determined

**Licensee's Response:** Craig and Cris Bricco had no excuse for these omissions in the A&D book. Craig stated it should not happen. As to the fact that five of the "failures to log out" were from the previous inspection, Craig indicated his brother, who no longer works there, was responsible for the record keeping at that time.

**Corrective Action:** Licensee was instructed to immediately update the A&D record with the cited errors and omissions. On 3/30/2015, it was verified this had been done.

Licensee will immediately report the firearms as missing from inventory to ATF and the local police. On 3/30/2015, it was verified this had been done.
