The licensee knowingly and willfully made false statements as to a material fact in connection with an Application for Federal Firearms License, ATF Form 7, filed on or about November 17, 2015, by falsely listing Brandon Tactical, LLC as the applicant for such license when, in fact, the entity seeking the license was Shark Coast Tactical, LLC, in violation of 18 U.S.C. § 924(a)(1)(A) and 27 C.F.R. § 478,128(a).

FINDINGS AND CONCLUSIONS

On September 26, 2016, the Director of Industry Operations, Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), Tampa Field Division, issued to Shark Coast Tactical, LLC, 2553 Highway 60 East, Valrico, Florida 33594, a Notice to Deny Application for License, ATF E-Form 5300.43(4498), with reasons therefor attached as page 2. On that same date, ATF issued to Shark Coast Tactical, LLC, 2819 Bee Ridge Road #A, Sarasota, Florida 34239, a Notice to Revoke or Suspend License and/or Impose a Civil Fine, ATF Form 4500(5300.4), notifying the licensee of the intent to revoke Federal firearms license numbers 1-59-115-02-7B-30742 and 1-59-115-07-7B-30785, with reasons therefor attached as page 2. By letter dated October 10, 2016, the Applicant/Licensee requested a hearing on the matter by and through its counsel (b) (6) A Notice of Hearing was issued to counsel for the Applicant/Licensee on December 29, 2016, and a hearing on the matter was held on February 7, 2017 in Tampa, Florida. After considering all the relevant facts and circumstances presented at the hearing, I make the following findings and conclusions.

FINDINGS

1. Shark Coast Tactical, LLC, holds a Federal firearms license as a dealer, including pawnbroker, in firearms other than destructive devices, license number 1-59-115-02-7B-30742, and a Federal firearms license as a manufacturer of firearms other than destructive devices, license number 1-59-115-07-7B-30785.

2. Notices to Revoke or Suspend License and/or Impose a Civil Fine, ATF Form 4500(5300.4), were issued to Shark Coast Tactical, LLC, 2819 Bee Ridge Road #A, Sarasota, Florida 34239, on September 22, 2015 notifying the Licensee of ATF's intent to revoke license numbers 1-59-115-02-7B-30742 and 1-59-115-07-7B-30785, and impose a civil fine or license number 1-59-115-02-7 -30742. The notices asserted that Shark Coast Tactical, LLC, transferred a firearm to an unlicensed person on or about March 22, 2014 in violation of 18 U.S.C. § 922(d)(1) and 27 C.F.R. § 478.99(c)(1) knowing or having reason to believe such person was prohibited from receiving or possessing firearms, and without receiving prior to the transfer a unique background check identification number approving the transfer in violation of 18 U.S.C. § 922(t)(1) and 27 C.F.R. § 478.102(a); also with making a false statement in a record required to be kept by a licensee in violation of 18 U.S.C. §§ 922(m) and 924(a)(3), and 27 C.F.R. § 478.121(c) and 478.128(c), by stating that the transfer had been approved by the background check system when, in fact, the transfer had been denied. On that same date, September 22, 2015, ATF also issued a Notice to Deny Application for License, ATF Form

¹ Both licenses expired February 1, 2017. However, Shark Coast Tactical, LLC filed a timely application for renewal of both licenses with ATF. As provided in 27 C.F.R. § 478.78, where a notice of revocation has been served on the licensee and he has filed a timely request for hearing, the license in the possession of the licensee shall remain in effect even though the license has expired provided the licensee timely filed an application for renewal.

4498(5300.43), to Shark Coast Tactical, LLC at a proposed new location, 2553 SR 60 East, Valrico, Florida 33594, where it sought to expand its operations as a dealer, including pawnbroker, in firearms other than destructive devices. The denial asserted that Shark Coast Tactical, LLC was ineligible to receive a firearms license pursuant to 18 U.S.C. § 923(d)(1)(C), having willfully violated Title 18, United States Code, Chapter 44, relating to the transfer at issue in the revocation action.

3. On October 12, 2015, counsel for Shark Coast Tactical, LLC², expressed an interest in resolving the licensing matters, submitting a written offer of resolution by which Shark Coast Tactical, LLC would withdraw its pending application and not seek to open operations in Valrico; would serve a 10 day suspension of all licensed operations at the Sarasota location; and would pay the \$5,000.00 fine. In making the offer of resolution, counsel for Shark Coast Tactical, LLC expressed his belief that "Mr. Meade and his business [could] be rehabilitated" and that he expected "the DIO investigator who examines Shark Coast Tactical, LLC in November 2016 to be satisfied with what they find." In the interest of providing Shark Coast Tactical, LLC an opportunity demonstrate it could be rehabilitated, ATF accepted the proposed resolution. On October 20, 2015 Shark Coast Tactical, LLC, by and through its counsel, withdrew the application for license at the Valrico, Florida location, waived the right to request a hearing, and accepted Amended and Final Notices suspending operations under license numbers 1-59-115-02-7B-30742 and 1-59-115-07-7 -30785 from October 26, 2015 through November 4,

² Shark Coast Tactical, LLC and William Meade were not represented by their current counsel in October 2015. ATF was notified that Shark Coast Tactical, LLC had changed its legal representative to FFLGuard via a Power of Attorney signed by William Meade dated May 9, 2016.

2015, and imposing a \$5,000.00 civil fine. The Licensee did suspend operations on the agreed upon dates, and the \$5,000.00 civil fine was paid by check dated January 11, [2016].³

4. On October 16, 2015, Brandon Tactical, LLC, filed Electronic Articles of Incorporation with the Florida Department of State, Division of Corporations. The filing listed Lorrie Vogel-Avendano, the wife of Shark Coast Tactical, LLC's responsible person William Meade, as Manager of Brandon Tactical, LLC, and a principal address of 2553 Highway 60 East, Valrico, Florida 33594.(D) (6) completed an Application for Federal Firearms License, ATF E-Form 7(5310.12), in the name of Brandon Tactical, LLC on November 5, 2015 seeking a license as a dealer in firearms other than destructive devices at 2553 Highway 60 East, Valrico, Florida 33594. (D) (6) indicated in response to item 24.D. on the application that she had been an employee of a Federal firearms licensee, but did not provide a separate sheet detailing the "yes" answer as instructed by the application. During the application inspection conducted January 5, 2016. (b) (6) provided a separate sheet detailing her "yes" answer stating "[i]n regards to item 24d, [b] (6) volunteered to assist my then boyfriend now husband with gunshows and sales at the shop (SHARKCOAST TACTICAL). Duties included completing 4473s, background checks from October 2013present."

5. On or about April 7, 2016, Shark Coast Tactical, LLC posted a comment on its

Facebook page which included the following:

SHARK COAST TACTICAL BRANDON/VALRICO WILL OPEN IN A MATTER OF DAYS. AT THIE [sic] TIME, WE HAVE NOT BEEN ABLE TO OBTAIN A FFL FOR THE BRANDON/VALRICO LOCATION. SO, WE ARE GONNA OPEN ANYWAY AND SELL EVERYTHING EXCEPT GUNS!! WE WILL HOPEFULLY

³ The check is actually dated January 11, 2015, however, the year is in error, as the notice imposing the fine was not issued until October 21, 2015, and the fine was not due until 90 days after such imposition.

BE GRANTED A LICENSE IN THE FUTURE. WE NEED TO GET OPENED, SO WE ARE OPENING.

6. On or about April 8, 2016, William Meade posted a video to Shark Coast Tactical, LLC's Facebook page announcing the opening of "Shark Coast Tactical Valrico/Brandon." The video states the location hasn't opened "because we've been having trouble getting the FFL up there." William Meade goes on in the video to say "hopefully before the election or something we'll get our FFL, but for now we need to open it up ... because we've been spending money on rent since September."

7. On or about April 9, 2016, Shark Coast Tactical, LLC posted a comment to its Facebook page which stated the following, and included a picture of a retail store:

Shark Coast Tactical Brandon is open! Shark [sic] Tactical Sarasota is Open! The Brandon store will not be selling guns for the time being but we will have everything else. Ammo, knives, bags, targets, cleaning supplies, uppers, parts, stocks, optics, ammo cans, free stickers, patches, tools, rails, etc. Hope to meet all the new folks in the Tampa Bay/Brandon/Valrico area. God bless and be safe. Shark Coast Tactical Brandon: 2553 Highway 60 East Valrico FL 941-228-9051

The photo of the retail store shows a large "SHARK COAST TACTICAL" sign with a logo associated with Shark Coast Tactical, LLC hanging on the wall.

8. On April 19, 2016, ATF issued a Notice to Deny Application for License, ATF Form 4498(5300.43), to Brandon Tactical, LLC, with reasons therefor attached as page 2. The grounds for denial were that the applicant willfully made a false statement of material fact by claiming to be the entity seeking the license when, in fact, the license was being sought for Shark Coast Tactical, LLC; and that the applicant had failed to disclose material information by failing to list William Meade as a responsible person of the business. *See* 18 U.S.C. § 923(d)(1)(C) and (D). That same day. (b) (6)

application.

9. On or about May 9, 2016, Shark Coast Tactical, LLC submitted to ATF a Power of Attorney identifying its new counsel of record as FFLGuard, the same firm that represented Brandon Tactical, LLC.

10. On or about August 2, 2016, William Meade completed an Application for Federal Firearms License, ATF E-Form 7(5310.12), seeking a license as a dealer in firearms other than destructive devices on behalf of Shark Coast Tactical, LLC, E 2553 FL-60, Valrico, Florida 33594.⁴ The application lists William Meade as the sole responsible person of the business in item 22, and items 24.A through 24.C. are marked "yes" indicating the applicant, or William Meade, has held a Federal firearms license, been denied a Federal firearms license, and been an officer in a corporation holding a Federal firearms license. No separate sheet was included with the application detailing the "yes" answers contained in item 24.

CONCLUSIONS

11. As provided in 18 U.S.C. § 923(d)(1)(C) and 27 C.F.R. § 478.47(b)(3), the Attorney General shall approve an application for a Federal firearms license if, among other things, the applicant has not willfully violated any of the provisions of the Gun Control Act or any rules or regulations prescribed thereunder.

12. As provided in 18 U.S.C. § 923(e) and 27 C.F.R. § 478.73 and 478.74, after notice and opportunity for hearing, a Federal firearms license may be revoked if the holder of such license has willfully violated any provision of Title 18, United States Code, chapter 44 or any rule or regulation prescribed thereunder.

⁴ Although Mr. and Mrs. Meade used alternative street addresses on the Applications for Federal Firearms Licenses, whether listed as "SR 60 East", "Highway 60 East", or "E FL-60", the applications are all for the same physical location.

13. Based on the information presented at the hearing, I find Shark Coast Tactical, LLC willfully violated the provisions of the Gun Control Act and the regulations prescribed thereunder by willfully making false statements of a material fact in connection with the Application for Federal Firearms License, ATF E-Form 7(5310.12) completed November 5, 2015 and filed on November 17, 2015 by falsely listing Brandon Tactical, LLC as the applicant when, in fact, Shark Coast Tactical, LLC was the entity seeking the issuance of the license in violation of 18 U.S.C. § 924(a)(1)(A) and 27 C.F.R. § 478.128(a).

14. It is undisputed that Shark Coast Tactical, LLC, as part of an agreement *it* proposed to ATF to resolve violations that could have resulted in the absolute discontinuance of its business operations, withdrew its application filed July 28, 2015 for a firearms license at a new location in Valrico, Florida. As part of ATF accepting the proposed resolution, it was represented to the agency that despite "Shark Coast Tactical, LLC ha[ving] invested a substantial amount of capital and enter[ing] into a five year lease, in anticipation of the approval of the 2553 SR 60, Valrico, Florida location, ... it will not seek to open its operations there and w[ould] instead seek to sublease or assign the lease. ..." The clear import of this representation was that any business that might operate from 2553 SR 60, Valrico, Florida would be wholly unassociated with Shark Coast Tactical, LLC, as to do otherwise would make the statement regarding the capital investment by Shark Coast Tactical, LLC irrelevant, and make its statement that it would not seek to open operations specious. Shark Coast Tactical, LLC, had no intention, however, of abandoning operations at the Valrico location. Rather, in the midst of negotiations with ATF to preserve its existing licenses, Shark Coast Tactical, LLC, was devising an alternate route for obtaining a license at the Valrico location. That alternate route was having the wife of Shark Coast Tactical, LLC's responsible person, William Meade, form Brandon Tactical, LLC,

complete an application for a firearms license at the same Valrico location Shark Coast Tactical, LLC had agreed to abandon, and omit William Meade from the list of responsible persons of that business. Upon consideration of all the presentations made at the hearing, I find that Brandon Tactical, LLC was a mere straw applicant for Shark Coast Tactical, LLC, the true applicant and intended recipient of the sought after license.

15. Counsel for the Applicant/Licensee appears to suggest that ATF cannot find Shark Coast Tactical, LLC to be the true applicant of Brandon Tactical, LLC's license application absent an admission by Lorrie Meade⁵ and/or William Meade that they falsified the application to secure a license for Shark Coast Tactical, LLC. However, the events surrounding the filing of the applications for license speak for themselves, and belie the self-serving statements made by Mr. and Mrs. Meade at the hearing.

16. Mr. and Mrs. Meade would have ATF believe the following events are unrelated, completely circumstantial, coincidental or without relevance:

- On October 16, 2015 Mrs. Meade files Articles of Incorporation for Brandon Tactical, LLC, just 4 days after Shark Coast Tactical, LLC makes an offer to resolve its licensing transgressions in part by withdrawing its own pending application at the same location.
- On November 5, 2015, the day after Shark Coast Tactical, LLC, completed its 10 day suspension, an Application for Federal Firearms License is completed for Brandon Tactical, LLC by Mrs. Meade, and Brandon Tactical, LLC signs a lease agreement essentially identical to that signed by Shark Coast Tactical, LLC for the same location. According to the lease agreement, Brandon Tactical, LLC was to begin paying rent December 1, 2015.
- On January 5, 2016, during an application inspection for the license application filed in the name of Brandon Tactical, LLC, Mrs. Meade, in response to questioning, states that she has an investor in the business that she will not identify, then adds that the investor is not her husband. The application

⁵ At the hearing, Lorrie Vogel-Avendano stated that she now uses the name Lorrie Meade following her marriage to William Meade. Both names as used in this document refer to the same person.

inspection also disclosed that the security deposit for the lease for Brandon Tactical, LLC was provided by Shark Coast Tactical, LLC.

- On April 7, 2016, while the only firearms license application pending with ATF for the Valrico location was in the name of Brandon Tactical, LLC, Shark Coast Tactical, LLC posted to its Facebook page that "SHARK COAST TACTICAL BRANDON/VALRICO" would open in a matter of days, going on to say "WE WILL HOPEFULLY BE GRANTED A LICENSE IN THE FUTURE."
- The following day, April 8, 2016, a video posted on Shark Coast Tactical, LLC's Facebook page announces the opening of Shark Coast Tactical Valrico/Brandon. In the video, William Meade laments the fact that "we" have had trouble getting the FFL at the location, and "we" have been spending money on rent since September.
- On April 9, 2016, Shark Coast Tactical posts on Facebook "Shark Coast Tactical Brandon is open! Shark Tactical [sic] Sarasota is Open!". The post goes on to say "the Brandon store will not be selling guns for the time being ...".
- On April 19, 2016, ATF issues a notice to deny the application filed in the name of Brandon Tactical, LLC. On that same date, Mrs. Meade withdraws the application she filed in the name of Brandon Tactical, LLC.
- The Application for Federal Firearms License completed July 21, 2015 seeking a firearms license in the name of Shark Coast Tactical, LLC at 2553 SR 60 East, Valrico, Florida lists William Crozier Meade, IV as the sole responsible person. The Application for Federal Firearms License completed November 5, 2015 seeking a license in the name of Brandon Tactical, LLC at the same location lists
 (b) (6) as the sole responsible person. The Application for Federal Firearms License completed August 2, 2016 seeking a license in the name of Shark Coast Tactical, LLC at the same location for Federal Firearms License completed August 2, 2016 seeking a license in the name of Shark Coast Tactical, LLC at the same location lists William Crozier Meade, IV as the sole responsible person.

17. This is a matter in which actions speak louder than words. Having secured leniency

from ATF in the form of suspension of its licenses in lieu of revocation, in part by agreeing not

to open operations at the proposed Valrico store location, the day after serving its suspension,

Shark Coast Tactical, LLC, rather than legitimately subleasing or assigning the lease to another

business, merely changed the name on the lease and license application, omitted William Meade

as a responsible person, and filed an application for a firearms license in the name of Brandon

Tactical, LLC in an effort to evade the consequences of its own negotiated settlement. It should

not go unnoticed that Brandon Tactical, LLC was created only *after* it became clear that Shark Coast Tactical, LLC's July 2015 license application would be denied or withdrawn. It should also be recognized that, having consented to the withdrawal of the application on behalf of Shark Coast Tactical, LLC, the Meades deliberately attempted to conceal William Meade's role in the creation and operation of the Valrico firearms business by listing only Mrs. Meade as a responsible person. The application, completed with the advice and guidance of FFLGuard and of which William Meade was aware, was calculated to give ATF the impression that a business independent of Shark Coast Tactical, LLC would be operating from that location. As Mr. Meade testified, it was his understanding from his former counsel that Shark Coast Tactical, LLC could not reapply for a license for a period of one year, or until undergoing a successful audit, making an application that did **not** list Shark Coast Tactical, LLC as the applicant the only perceived alternative for the Meades to take advantage of the retail space for which they were already paying rent.

18. The fact that Mr. and Mrs. Meade had already begun to make rent payments at the Valrico location, and had invested a substantial amount of money in the location to prepare it for retail firearms sales, provides a financial motivation for Mr. and Mrs. Meade to falsify the November 5, 2015 firearms license application in order to receive a license to sell firearms from that location. It likely did not matter to the Meades whether the license was issued in the name of Brandon Tactical, LLC or Shark Coast Tactical, LLC, as the sole objective was to obtain a firearms license to expand their business in Sarastoa to the Valrico location. But while the Licensee/Applicant wants ATF to focus solely on the four corners of the application filed in the name of Brandon Tactical, LLC, the Meades, and their counsel, repeatedly prove that they themselves cannot delineate one business from the other.

19. The Facebook posts, Facebook video, and testimony introduced during the hearing show that there was never any true attempt by the Meades to distinguish between randon Tactical, LLC and Shark Coast Tactical, LLC, except as to the application to ATF for a license. The persistent references to "we" by the Meades, and "they" rather than "she" by the Meades' counsel, demonstrate that the Meades worked in concert in an attempt to obtain a license for the Valrico store in an effort to expand Shark Coast Tactical, LLC's business to its new desired location. Perhaps Mr. Meade said it best, and most truthfully, when he proposed an alternative version of the April 8, 2016 video:

I understand, like you, it does, you're right, it looks like we we're just tryin' to. What ah, OK, then, what do you really want me to say on the video? 'Hi. I've had problems with the ATF for four years, my wife just tried to get a license so we could use the space that we figured out. She can't get it, I can't get it, ATF hates me. We're gonna open up and sell animo.'

These statements and actions make it clear that the Brandon Tactical, LLC application was nothing more than an attempt to secure a firearms license for Shark Coast Tactical, LLC that it had agreed not to seek for itself. It is not reasonable to expect ATF to ignore the obvious and simply accept the Meades' version of events. Even counsel for the Licensee/Applicant in addressing whether the Licensee/Applicant lied on the application appears conflicted: "I can see how it might be likely, I think reasonable people could maybe even agree on it could seem likely, but that's not willfully knowingly lying, and even if it was, which it wasn't, it'd be Lorrie, but she didn't." As both Mr. Meade and counsel for the Licensee/Applicant concede, the facts of this case lend themselves to the very reasonable conclusion that Shark Coast Tactical, LLC, by and through William and Lorrie Meade, falsified the November 2015 application for license by claiming the license was for Brandon Tactical, LLC when, in fact, the license was sought to expand the operations of Shark Coast Tactical, LLC to the Valrico location where it had agreed

not to open its operations. ATF need not abandon that reasonable conclusion based solely on the Meades' self-serving denials.

20. The filing of the applications by Shark Coast Tactical, LLC and William Meade, then Brandon Tactical, LLC and Lorrie Meade, followed again by Shark Coast Tactical, LLC and William Meade, underscore the Meade's true business intentions. As explained by Mr. Meade, when Shark Coast Tactical, LLC withdrew its initial application "[Brandon Tactical, LLC] ... tried to get a license so we could use the space that we figured out. ..." however Mr. Meade was not listed as a responsible person on that application; thus there was no "we" just Mrs. Meade. However, when Brandon Tactical, LLC withdrew its application, and a subsequent application for license was filed by Shark Coast Tactical, LLC, only William Meade was listed as the sole responsible person, essentially a reversion to the "true" original applicant for the license.

21. Counsel for the Licensee/Applicant argues that the opening of the accessories business in Valrico on or about April 9, 2016 as "Shark Coast Tactical" is irrelevant, as Mrs. Meade had already decided to withdraw the application of Brandon Tactical, LLC, and no license is required to sell firearms accessories and ammunition. That argument, however, begs the question as to why Mrs. Meade, who claimed to want to run her own business, did not open Brandon Tactical, LLC as a firearms accessory and ammunition store, either prior to withdrawal of the application, or after the decision to withdraw the application. The only reasonable conclusion to be drawn is that once the Meades became aware that ATF did not intend to issue a license to Brandon Tactical, LLC, the purpose for which that LLC had been created was moot, and the Meades reverted to their true intention, operating their business as Shark Coast Tactical.

22. In addition to the reasonable conclusions drawn from the facts, I find the Applicant/Licensee's reputation for truthfulness when completing government documents to be

lacking. As noted in paragraph 2, the revocation action initiated against Shark Coast Tactical, LLC in September 2015 alleged that Shark Coast Tactical, LLC falsified an ATF Form 4473 in relation to the transfer of a firearm to a person who was prohibited from receiving or possessing firearms by noting on the record that the background check system had approved the transfer of the firearms when, in fact, the system had denied the transfer. I find it reasonable to conclude that the Licensee/Applicant, having completed a Form 4473 in a manner so as to conceal the true nature of a firearms transaction, would similarly complete an Application for Federal Firearms License in a manner so as to conceal the true applicant.

23. ATF may look past the formal corporate structure of an applicant or licensee, especially when that structure is used to circumvent statutory requirements. ATF may, therefore, look past the facade of the application filed in the name of Brandon Tactical, LLC, as Brandon Tactical, LLC's application was occasioned solely as a result of the withdrawal, in lieu of denial for willful violations, of the application filed by Shark Coast Tactical, LLC at the same location. By filing an application to extend the licensed operations of Shark Coast Tactical, LLC to the Valrico location by claiming to be Brandon Tactical, LLC, Shark Coast Tactical, LLC, by and through William and Lorrie Meade, made a false statement in applying for a firearms license in violation of 18 U.S.C. § 924(a)(1)(A), and 27 C.F.R. § 478,128(a).

24. A "willful" violation for purposes of the regulatory provisions of the Gun Control Act means a purposeful disregard of or plain indifference to the firearms laws and regulations. I find that Shark Coast Tactical, LLC, by and through William and Lorrie Meade, willfully violated 18 U.S.C. § 924(a)(1)(A), and 27 C.F.R. § 478.128(a) by filing an application in the name of Brandon Tactical, LLC with full knowledge that the license was actually being sought to expand the business operations of Shark Coast Tactical, LLC.

DECISION

On consideration of all relevant facts and circumstances presented in this matter, I find that Shark Coast Tactical, LLC, is not qualified to receive a Federal firearms license under the provisions of 18 U.S.C § 923(d)(1)(C), and 27 C.F.R. § 478.47(b)(3), as Shark Coast Tactical, LLC, by and through William and Lorrie Meade, willfully violated Title 18, United States Code, Chapter 44, and its implementing regulations, specifically 18 U.S.C. § 924(a)(1)(A) and 27 C.F.R. § 478.128(a). Thus, the Application for Federal Firearms License seeking a license at 2553 Highway 60 East, Valrico, Florida 33594, is hereby denied.

On consideration of all relevant facts and circumstances presented in this matter, I find that the firearms licenses issued to Shark Coast Tactical, LLC, license numbers 1-59-115-02 7B 30742 and 1-59-115-07-7B-30785, are subject to revocation pursuant to 18 U.S.C. § 923(e) as Shark Coast Tactical, LLC, by and through William and Lorrie Meade, willfully violated a provision of Title 18, United States Code, Chapter 44, and its implementing regulations, specifically 18 U.S.C. § 924(a)(1)(A) and 27 C.F.R. § 478.128(a). Thus, Federal firearms license numbers 1-59-115-02-7B 30742 and 1 59-115-07-7B-30785, are hereby revoked.

IOI(b)(6) determined that) ATF Forms 4473 that were cited as missing were possibly thrown the away by employees when a transfer was never completed or were possibly additional Control Numbers issued for the same transaction. IOI(b)(6) disclosed potential evidence of the trashing of ATF Forms 4473 were a transfer does not take place with the discovery in the file for ATF Forms 4473 where a transfer never took place of an ATF Form 4473 that appeared to have been crumpled and torn and then smoothed out and taped before filing. The Notice of Revocation, which was sent on 9/22/15, also included the denial of a pending application that Shark Coast Tactical, LLC filed with a location of 2553 Highway 60 East Valrico, Florida 33594. The basis for denial of the Type 02 application (1-59-32683) was for a willful violation of the Gun Control Act under Title 18 U.S.C. 923(d)(1)(C) disclosed during compliance inspections of Mr. Meade's FFLs 1-59-30742 and 1-59-30785. The licenses for Shark Coast Tactical, LLC (Type 02: 1-59-30742 and Type 07: 1-59-30785) were not revoked as an settlement was reached in which Shark Coast Tactical, LLC's licenses (1-59-30742 and 1-59-30785) were suspended from October 26, 2015 through November 4, 2015 and paid a civil fine of \$5,000.00 for a violation of 18 U.S.C 922(t)(5). In addition to the suspension and the fine, the Type 02 application submitted for Shark Coast Tactical, LLC was withdrawn on 10/20/2015. For reference purposes, the Type 07 (FFL: 1-59-32684) application was withdrawn due to zoning restrictions.

Shark Coast Tactical, LLC advertised for employees and announced an expansion of business operations to 2553 SR 60 East, Valrico, FL 33594, despite the withdrawal of the application for a FFL at 2553 SR 60 East, Valrico, FL 33594 by Shark Coast Tactical, LLC, which was a part of a Stipulated/Negotiated Settlement in Lieu of Revocation. This advertisement and announcement of an expansion of business operations to 2553 SR 60 East, Valrico, FL 33594 coincided with a pending application for a FFL at 2553 SR 60 East, Valrico, FL 33594 by Brandon Tactical, LLC, whose sole Manager and Responsible Person was (b)(6)

Shark Coast Tactical, LLC and William Crozier Meade IV knowingly made a false statement and/or representation with the willful withholding and/or misrepresented information provided in an attempt to obtain a FFL at 2553 SR 60 East, Valrico, FL 33594 after the attempted expansion of the current licensed business through the application for a FFL at 2553 SR 60 East, Valrico, FL 33594, which was withdrawn, by directing and funding the creation of a business at 2553 SR 60 East, Valrico, FL 33594 in the name of Brandon Tactical, LLC that did not identify William Crozier Meade IV and/or Shark Coast Tactical, LLC as the applicant based on the information presented above from AS (b)(6), SIOI(b)(6), and IOI(b)(6).

12 - Closing Actions

IOI(b)(6) reviewed and discussed each applicable point of the Acknowledgement of Federal Firearms Regulations, including secure gun storage and safety devices, and the ATF Important Notice – Selling Firearms AFTER Revocation, Expiration, or Surrender of an FFL with William Crozier Meade IV on June 9, 2016.

IOI (b)(6) obtained a signed Acknowledgement of Federal Firearms Regulations from William Crozier Meade IV. [Exhibit 03]

Licensee Response:

William Crozier Meade IV stated that they switched to online checks in order to eliminate any confusion about the response provided by the FDLE, however, this switch coincided with a huge increase in the amount of business and they didn't have an adjustment period giving them time to familiarize themselves with the online system. Most of the mistakes were transposed numbers or numbers left out; others were duplicated because people were looking at the wrong line. William Crozier Meade IV stated that they have started requiring employees to type in the name of the buyer in the search bar so that only the associated number shows up. They also take screen shots of the results and put them in a spreadsheet and record the number on the customer ticket so that if this issue does occur again it can be easily rectified by one of the spreadsheet or the ticket.

Corrective Action:

IOI(b)(6) conducted a National Crime Information Center (NCIC) query of the sixty six (66) firearms identified on the ATF Forms 4473 which contained incorrect and/or incomplete Control Numbers resulting in zero (0) hits.

IOI(b)(6) queried the NICS for any prohibiting information about any transferee identified on an ATF Form 4473 where a firearm was transferred that also contained an incorrect and/or incomplete Control Number. The fifty nine (59) NICS queries resulted in zero (0) hits.

IOI (b)(6) disclosed no information to indicate the licensee was falsifying Control Numbers or falsifying ATF Forms 4473. IOI (b)(6) was able to determine the correct Control Number for the contained a duplicated Control Number by taking the timestamp information provided by the FDLE for previously unverified Control Numbers and comparing the information to handwritten sales receipts for the date in question for the transferee named on the ATF Forms 4473 that contained a duplicated Control Number and through a program that the licensee utilizes to manage payment information that also contained the named transferee and timestamp information.

William Crozier Meade IV stated that due to the disorganization of the forms, that the forms with the missing numbers may be in the files somewhere but they just couldn't find them before the closing.

Corrective Action:

IOI(b)(6)disclosed no information to indicate the licensee was falsifying Control Numbers or falsifying ATF Forms 4473. IOI(b)(6) determined that) ATF Forms 4473 that were cited as missing were possibly thrown the away by employees when a transfer was never completed or were possibly additional Control Numbers issued for the same transaction. IOI(0)(6) disclosed potential evidence of the trashing of ATF Forms 4473 were a transfer does not take place with the discovery in the file for ATF Forms 4473 where a transfer never took place of an ATF Form 4473 that appeared to have been crumpled and torn and then smoothed out and taped before filing. IOI(b)(6) was advised by the licensee that the ATF Form 4473 was discovered in the trash and was then properly filed. IOI disclosed potential evidence of additional background checks for the (b)(6) same transaction with the discovery of more than one Control Number recorded on multiple ATF Forms 4473 that contained notes in Item 30a explaining that the new Control Number was issued as a result of the employees resubmitting a background check after the discovery that the information initially provided for the transferee as part of the background check was misspelled or input incorrectly.
