All violations were fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator. 1 - Introduction

Inspection Profile:

On May 22, 2017, Bureau of Alcohol, Tobacco, Firearms, and Explosives Investigator (b)(6) conducted a Disposition Emphasis (DE) compliance inspection of Federal Firearms Licensee (FFL) holder Lloyd David Haslam, dba, Crowheart Store, located in Crowheart, Wyoming. Present throughout the inspection was Owner and Responsible Person, Lloyd D. Haslam. Mr. Haslam was identified by Wyoming driver's license number (b)(6). The purpose of the inspection was to determine the licensee's level of compliance with Federal firearms laws and regulations. The inspection period covered the 12-month period immediately prior to May 22, 2017. The inspection concluded on 06/01/2017.

Business Profile:

Lloyd D. Haslam, dba, Crowheart Store maintains a Type-01, Dealer of Firearms FFL from ATF. The licensee sells new and used long guns and hand guns to business clients in the Crowheart area. The licensed premises are located in a commercial building which doubles as a gas/convenience store located in eastern Crowheart, Wyoming. According to the County of Fremont Clerk's Office, the licensee's premises are zoned for commercial business including the sale of firearms. Mr. Haslam maintains the required business license. No additional licenses or permits are required. The licensee also maintains the required State of Wyoming Sales Tax Use Permit.

During the inspection period, Mr. Haslam acquired (b)(4) firearms and disposed of (b)(4) firearms. The licensee deals in new and used long guns (approximately (b)(4)) and handguns (approximately (b)(4)). The licensee acquires firearms from various firearms dealers throughout the United States. The licensee does not maintain a website, nor does he conduct online transactions. No offsite storage is utilized. No other business is conducted at the licensed premise.

According to the Federal Licensing System (FLS), Mr. Haslam has maintained his FFL since April 19, 2001. The licensee does not hold any additional ATF licenses or permits. No additional licenses or permits were deemed necessary as a result of the inspection. Based upon the activities observed during the inspection, the Type-01 FFL held is appropriate.

Lloyd D. Haslam, dba, Crowheart Store maintains this FFL as a sole proprietor and exercises all control over the business. Mr. Haslam is the sole responsible person on the license. There have been no changes in control, name, or address and there is no indication of hidden ownership.

A Query of Mr. Haslam in NCIC/NFORCE, by Investigator Basile, did not result in any prohibiting information.

Mr. Haslam does not maintain any ATF issued variances. Investigator (b)(6) did not discover any circumstances during the inspection period which would require a variance.

4 - Acquisition & Disposition (A&D) Record - Inventory

A 100% physical inventory of firearms on-hand was conducted. A total of 36 firearms were physically verified in the licensee's inventory. There were (b)(3) open dispositions in the licensee's A&D Record. Of the (b)(3) open dispositions, there were (b)(3) - 112 P open dispositions in which no corresponding firearm was found in inventory. For the same

(b)(3) - 112 firearms in which no disposition information was recorded, the same was true in that the date acquired and from whom the firearms were acquired was not recorded.

The licensee was given one week (6/1/2017) and instructed to research all records and complete both the acquisitions and dispositions as required by regulation.

The licensee stated he was unable to account for the (b)(3) - 112 firearms and they were subsequently placed on a Theft/Loss Report which was submitted by the licensee on June 1, 2017 via the US Postal Service. The Theft/Loss submission was assigned ATF (b)(3) - 112 Public Law 55-125 Stat 552. The licensee also notified the Fremont County Sheriff's office and notified that agency of the missing firearms. See Fremont County Sheriff's Office case number: SO-C17-03361. On June 12, 2017, Investigator (b)(6) confirmed that the Fremont County Sheriff's Office case number as well as the ATF number was documented in the disposition section for the (b)(3) - 112 unaccounted firearms. The licensee was cited for violating 27 CFR 478.125(e) in (b)(3) instances. **See ATF Form 5030.5 – Report of Violations #2, Worksheet 2 – 4473 (2016 edition) and Exhibit #1.**

Investigator (b)(6) traced 10 firearms through the licensee's A&D records from acquisition to disposition and found no discrepancies. Investigator (b)(6) did not discover any evidence of obliterated serial numbers or possession of any illegal firearms by the licensee, for the inspection period.

The licensee's standard operating procedures with respect to the A&D Record are as follows:

- Firearm arrives, firearm make, model, serial number and caliber is verified to the invoice.
- Firearm is then logged in to the A&D book with all required information documented.
- After Firearm is sold or disposed of, the firearm is logged out of the A&D book with all required information.
- Full inventories will be completed once a calendar year.

Investigator (b)(6) found no illegal firearms or firearms with obliterated serial numbers.

5 - ATF Forms 4473 – NICS & Other Dispositions

For the inspection period, Mr. Haslam completed (b)(3) ATF Forms 4473. Investigator (b)(6) reviewed 100% of these forms. No violations were discovered.

According to the FFL Audit Report, Mr. Haslam was not associated with any denied responses for the inspection period.

Investigator (b)(6) compared five NICS transaction numbers to the FFL Audit Log, Violent Crime Analysis Branch (VCAB) report, and completed ATF Forms 4473 and found no discrepancies.

6 - Multiple Sales

According to the Violent Crimes Analysis Branch (VCAB), the licensee was not associated with any multiple sales transactions. Investigator (b)(6) review of ATF Forms 4473 completed during the inspection period revealed (b)(6) multiple sales that the licensee failed to timely submit ATF Form 3310.4, Report of Multiple Handgun Sales, involving (b)(3) firearms. The licensee was cited for violating 27 CFR 478.126a. Investigator (b)(6) conducted a query of ETRACE and confirmed that the licensee completed and submitted ATF Forms 3310.4 on May 24, 2017

(b)(3) - 112 Public Law 55 125 Stat 552 on May 25, 2017 (b)(3) - 112 Public Law 55 125 Stat 552. See ATF Form 5030.5 – Report of Violations #1, Worksheet 2 – 4473 (2016 edition) and Exhibit #2.

7 - Suspicious/Prohibited Purchasers

Investigator (b)(6) reviewed the licensee's A&D Record and denied ATF Forms 4473 for possible firearm trafficker patterns such as (b)(7)(E)

8 - Trace Activity

According to the VCAB, Mr. Haslam was not associated with any firearms trace requests in the last 12 months.

Investigator (b)(6) did not conduct a secondary market analysis as all firearms in inventory were brand new.

9 - NFA/Importer/Collector/Manufacturer

Mr. Haslam does not deal in NFA firearms, is not an Importer, Collector, or Manufacturer of firearms.

10 - Referrals

Investigator (b)(6) did not generate any referrals as a result of this inspection.

No other noteworthy information was obtained during the inspection.

12 - Closing Actions

On June 1, 2017, Investigator (b)(6) conducted a closing conference with Owner and Responsible Person, Lloyd D. Haslam. The report of violations was reviewed with and signed by Mr. Haslam, signifying his understanding of each violation, and corrective action required, and the time period in which those actions were to be taken. Investigator Basile reviewed the Acknowledgment of Federal Firearms Regulations with Mr. McGee and obtained his signature signifying his understanding of its contents. **See Exhibit #3.** Finally, Investigator (b)(6) provided the licensee with ATF reference materials, including the ATF Federal Firearms Licensee Quick Reference, Best Practices Guide, and the Important Notice regarding the selling of firearms after revocation, expiration, or surrender of an FFL, as further means for the licensee to remain in compliance with Federal firearms law and regulations.

13 - Violations

1. **27 CFR 478.126a**

Nature of Violation: The licensee failed to prepare or timely submit ATF Form 3310.4, Report of Multiple Handgun Sales on (b)(3) - 112 Public Law forms involving (b)(3) - 112 Public firearms.

Licensee's Response: The licensee stated he was unaware that an extra form was required.

Corrective Action: The licensee was instructed to prepare and submit ATF Form 3310.4, Report of Multiple Handgun Sales, immediately. Investigator (b)(6) confirmed that the licensee submitted the Report of Multiple Handgun Sales on May 24 and 25, 2017. Additionally, the licensee was educated on the circumstances that require the completion of ATF Form 3310.4, Report of Multiple Handgun Sales.

2. **27 CFR 478.125(e)**

Nature of Violation: The licensee failed to maintain an accurate Acquisition and Disposition Record. Specifically, there were (b)(3) - 112 Public Law instances in which a firearm was acquired on an unknown date and from whom the firearms were received and the same (b)(3) - 112 Public Law firearms were disposed of with no disposition information recorded in the required records. Of the (b)(3) - 112 Public Law instances in which the acquisition and disposition information was not recorded, all (b)(3) - 112 Public Law were not accounted for and placed on a Theft/Loss Report.
