





All violations were fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) IO Investigator(s). #### 1 - Introduction

### **Inspection Profile:**

On March 01, 2017, Industry Operations Investigator (IOI) (6) with Mr. Alton Edward Voigt Jr. at the business premises of Lindalton Company d.b.a. Rockport Tackle Town (here on after referred solely as Rockport Tackle Town), located at 3010 Hwy 35 N., Rockport, Texas 78382 – Aransas County (GPS: 28.05934, -97.04075). The purpose of the meeting was to conduct a Southwest Border DE firearms inspection on a Type 01 – Dealer in Firearms Other that Destructive Devices, Federal Firearms Licensee. Mr. Alton Edward Voigt Jr., Owner of Rockport Tackle Town, was identified by his valid State of (b) (6) driver license, (b) (6) showing a date of birth of and an expiration date of (b) (6) (Exhibit 1). A computerized criminal history was conducted on Mr. Voigt with negative results. The inspection period covered March 01, 2016 through March 01, 2017. Onsite end date was March 23, 2017. No other Federal, State, and/or local agencies participated in the course of the compliance inspection. No advances notice was given.

### **Business Profile:**

Rockport Tackle Town is a retail store that sells general hunting and fishing merchandise, groceries, and provides various services to the general public. Rockport Tackle Town is licensed as a Type 01 – Dealer in Firearms Other that Destructive Devices, Federal Firearms Licensee. The license was originally issued on April 16, 2015 and is the only ATF license possessed by the company at this location. Business is conducted from a commercial storefront located in Rockport, Texas. The premises are owned by Altinda LLC which is owned by Mr. Voigt and his wife. A query of Aransas County Appraisal District website confirmed that property is owned by Altinda LLC (Exhibit 2). The licensee also sells ammunition for both handguns and long guns, firearm accessories, cleaning supplies, and secure gun storage and safety devices. During the period of inspection, the licensee acquired (b) (4) firearms and disposed of (b) (4) firearms. Rockport Tackle Town's main suppliers are (b) (4) Rockport Tackle Town does have a website but they do not sell firearms on-line. The licensee does not sell NFA firearms, provide gunsmith services, or conduct business at gun shows. There is no off-site storage of firearms. No other business is conducted from the building.

#### **Ownership and Control:**

Lindalton Company d.b.a. Rockport Tackle Town is registered in the State of Texas as a Domestic For-Profit Corporation which was registered with the Texas Secretary of State, Filing Number 800322009, with an original date of filing of March 23, 2004 (Exhibit 3). Lindalton Company has acquired an assumed name certificate, #7207, to conduct business as Rockport Tackle Town which was filed with The County of Aransas in The State of Texas on August 23, 2007 (Exhibit 4). Query of Texas Secretary of State website showed the following management structure for Lindalton Company (Exhibit 5):

Alton Edward Voigt – President Linda Burell Voigt – Vice President

A query of the Federal Licensing System (FLS) lists Mr. Voigt and Ms. Voigt as Responsible Person under this license. As per Mr. Voigt no changes in control or in corporate structure have been made since the original issuance of the Federal Firearms License. The information corresponds with information on file with ATF's Federal Licensing System. No hidden ownership was suspected.

A query of the State of Texas Secretary of State online database shows s sales tax permit (b)(3) - 26 USC 6103 -7 (Exhibit 6). Lindalton Company maintains an active status regarding its franchise tax (b)(3) - 26 USC 6103 which is filed under Texas SOS File Number 800322009 (Exhibit 7).

#### Variance:

Rockport Tackle Town has no approved variances and none were requested during the course of the inspection.

#### 2 - Recommendation

Viols WL ONLY and No Recall Inspection.

Due to the McAllen Area Office being on a one year inspection rotation, no recall inspection recommended since licensee will be inspected next year again.

#### 4 - Acquisition & Disposition (A&D) Record - Inventory

Rockport Tackle Town maintains two handwritten bound A&D books. Rockport Tackle Town's A&D books were in the proper format and contained all of the required information under CFR 478.125(f). No discrepancies were found. During the inspection period Rockport Tackle Town acquired firearms and disposed of firearms during the same time frame. A review of the A&D records disclosed pen entries. A complete inventory was conducted and firearms were located at said time. Firearms were cross-referenced with A&D books. No discrepancies were found during the inventory. There were no firearms with obliterated serial numbers or other illegal firearms found in the licensee's inventory. There were no thefts or losses reported by the licensee during the period of inspection or discovered during the inspection.

The licensee's procedures for recording firearm acquisitions and dispositions and maintaining inventory were reviewed and found to be adequate. Any of the responsible persons on the licenses that's on duty is responsible for entering acquisition and disposition information in the A&D record. Firearms are entered into A&D record as soon as they arrive at the store and as soon as a firearms is sold they dispose of it.

#### 5 - ATF Forms 4473 - NICS & Other Dispositions

Rockport Tackle Town executed ATF Form 4473 during the inspection period. All forms were examined and during the examination it was determined that Rockport Tackle Town failed to comply with 27 CFR 478.21(a) on forms, 27 CFR 478.102(c) on (b) (6) instance, 27 CFR 478.124(c)(1) on (b) (6) forms, 27 CFR 478.124(c)(3)(i) on (b) (6) forms, 27 CFR 478.124(c)(3)(iv) on (b) (6) forms, 27 CFR 478.124(c)(4) on (b) (6) forms and 27 CFR 478.124(c)(5) on (b) (6) forms. No sales were made to law enforcement officers. A query submitted for the FFL Audit Log reported 15 proceed response for the last 60 days and 7 denied transaction for the last 5 years for a total of 22 NTN transactions. NTN transactions was verified and authenticated.

The licensee's procedures for recording firearm acquisitions and dispositions and maintaining inventory were reviewed. Any of the responsible persons on the licenses that's on duty is responsible for completing and reviewing the forms, verifying the identity of his customers, and conducting NICS background checks via telephone. The licensee is aware of the multiple sale reporting requirements for handguns and certain rifles and ensures to complete and submit a report immediately.

### 6 - Multiple Sales

A query of eTrace online database indicated that Rockport Tackle Town reported multiple sales involving firearms during the inspection period. No unreported multiple sales were identified during the course of the inspection.

### 7 - Suspicious/Prohibited Purchasers

A total of four possible prohibited purchasers were identified during the inspection. A computerized criminal history was conducted on such individuals with negative results for prohibited factors.

#### 8 - Trace Activity

An eTrace query disclosed that the licensee was associated with race requests in the last 12 months. (b)(3) - 112 Public Law 55 125 Stat 552

#### 9 - NFA/Importer/Collector/Manufacturer

Rockport Tackle Town does not deal in NFA nor manufacture, import or collect firearms.

#### 10 - Referrals

There were no referrals generated as a result of the inspection.

#### 11 - Other

At time of inspection Rockport Tackle Town was compliant with 27 CFR 478.91 by having his license posted on the premises covered by the license. Rockport Tackle Town is compliant with 27 CFR 478.103 by having a Youth Handgun Safety Act sign posted. All handguns transferred with a child safety lock. Rockport Tackle Town was

#### 12 - Closing Actions


On March 23, 2017, a closing conference was held at the business premises by IOI (b) (6) present was Mrs. Linda Burrell Voigt, Co-Owner and Responsible Person for Rockport Tackle Town. Mrs. Linda Burrell Voigt was identified by her valid State of (b) (6) driver license (b) (6) showing a date of birth of (b) (6) and an expiration date of (b) (6) (Exhibit 8). A computerized criminal history was conducted on Mrs. Voigt with negative results. During the closing conference a total of violations of the Gun Control Act (GCA) was cited. A copy of ATF Form 5030.5-Report of Violations, with original signatures, was provided to Mrs. Voigt for his review. Mrs. Voigt acknowledged receiving explanations of violations, by signing and dating the form. Mrs. Voigt was instructed on his responsibilities as Owner of a business with a Federal Firearms Licensee to adhere and comply with all laws and regulations pertaining to the commerce of firearms and the conduct of business as regulated by the Gun Control Act (GCA). Mrs. Voigt was advised that continued noncompliance with the prescribed regulations can be considered willful violations, which could result in adverse actions, to include revocation or renewal denial of license. 


