IOI (b)(6) reviewed the records on August 10, and 11, 2016 and conducted the inspection on those days with the assistance of Mr. (b)(6) , General Manager, and (b) (6) Manager. The closing conference was conducted on August 29, 2016 with Mr. Michael "Mike" Dwayne Hicks, President and Responsible Person, at an additional 19th Hole Pawn FFL store premises located at 1520 South Fort Hood Street in Killeen, Texas. No other Federal, state, or local agencies participated in the inspection.

The period of review was from August 10, 2015, to August 10, 2016. There were no missing firearms or suspicious purchasers. There were no referrals generated as a result of the inspection.

Inspection Profile:

On August 10, 11, and 29, 2016, Industry Operations Investigator (IOI) (b)(6) conducted a firearms compliance inspection for the Federal Firearms Licensee (FFL) L O and H Ventures, LTD d.b.a. 19th Hole Pawn Shop (hereafter referred to as 19th Hole Pawn). IOI (b)(6) reviewed the records on August 10 and 11, 2016 and conducted the inspection on those days with the assistance of (b)(6) General Manager, and (b)(6) Manager. The closing conference was conducted on August 29, 2016 with Mr. Michael "Mike" Dwayne Hicks, President and Responsible Person, at an additional 19th Hole Pawn store premises located at 1520 South Fort Hood Street in Killeen, Texas. Mr. Hicks was identified by his Texas Driver's License. No other Federal, state, or local agencies participated in the inspection.

The period of review was from August 10, 2015, to August 10, 2016. There were no missing firearms or suspicious purchasers. There were no referrals generated as a result of the inspection.

The following violations were cited: 27 CFR 478.124(c)(1), 27 CFR 478.21(a), 27 CFR 478.124 (c)(3)(i), 27 CFR 478.124 (c)(3)(iv), and 27 CFR 478.99(c).

Business Profile:

19th Hole Pawn is part of a chain of pawn shops holding additional FFLs in Killeen (5-74-38687), Lampasas (5-74-02266), and Anson, Texas (5-75-10884). 19th Hole Pawn sells and offers loans on jewelry, electronics, tools, sporting goods, firearms, and other similar items. The business operates on a full-time basis during the hours of Monday through Friday, 9:00 a.m. to 7:00 p.m., Saturday, 10 a.m. to 6:00 p.m., and closed on Sunday. 19th Hole Pawn has been operating with this FFL since April 1998.

19th Hole Pawn deals in both used percent) and new percent) firearms with handguns and long guns accounting for an equal portion of the business. 19th Hole Pawn acquires the used firearms from pawn lapses and purchases from customers. The new firearms are acquired from other 19th Hole Pawn stores (mainly the Killeen, Texas location). There were higher firearms acquired and by disposed during the inspection period.

19th Hole Pawn also facilitates internet transfers in which a customer purchases a firearm on the internet and has the firearm shipped to the premises for the completion of an ATF Form 4473 and a National Instant Criminal Background Check System (NICS) check, if applicable. The pawn service consists of percent of the business with retail sales accounting for percent and internet transfers the remaining percent. 19th Hole Pawn has not facilitated special orders on a regular basis but would do so if requested by a customer.

19th Hole Pawn does offer accessories such as holsters and magazines on a limited basis but does not sell ammunition. 19th Hole Pawn not conduct business at gun shows and does not offer any repair services.

The clientele consists of the general public from the local area. 19th Hole Pawn has outside signage and also relies on word-of-mouth advertising. 19th Hole Pawn does not have a dedicated website but does a Facebook presence on the internet.

The premises located at 557 West Veterans Memorial Boulevard in Harker Heights, Texas is an urban commercial property owned by L O & H, LTD. IOI (b)(6) queried the Bell County Appraisal District website which reflects this information (EXHIBIT 1). IOI (b)(6) contacted the City of Harker Heights zoning office by telephone and spoke to (b)(6). City Planner. Mr. (b)(6) stated the premises are zoned for retail use and there are no restrictions. Mr. Hicks is aware of ATF's right of entry to inspect the inventory, records, and the premises.

The premises consists of only a front entrance, which is lockable and has security bars. There is an in-house security system which features door and motion sensors. There is a camera system which features indoor and outdoor cameras connected to a digital video record on premises. There are also panic buttons located at the sales counters. The handguns for sale are displayed in a locked display case in the front area of the store. The long guns are displayed in a rotating locked case next to the handguns. The firearms in pawn are stored in a gun vault located in the rear area of the store which is only accessed by employees. The gun vault is constructed of concrete reinforced with rebar with a safe door at the entrance. Mr. Smith, Ms. Rios, and one other employee are the only ones who have access to the gun vault. There is no offsite storage of firearms.

There are no other businesses operating from the premises. The Type 02 Pawn Dealer FFL is appropriate for the business. No additional ATF licenses or permits are required.

Ownership and Control:

L O & H Ventures, LTD is operating as a Domestic Limited Partnership with L O & H Management, LLC as the General Partner. IOI (b)(6) queried the Texas Secretary of State (SOS) website which reflects this information (EXHIBIT 2). IOI Sadler (b)(6) from the website a copy of the Articles of Organization of L O & H Management, LLC, which originally reflects the members as Mr. Hicks, Ms. Paula Lohse, and (b)(6) . A current printout from the SOS website now only reflects Mr. Hicks (President/Director) and Ms. Lohse (Vice President/Director), which was updated August 6, 2015. Mr. Hicks stated (b)(6) left the entity in 2015 and provided a copy of paperwork reflecting the buyout of (b)(6) interest in the business and a copy of the Application for Employer Identification Number, (b)(6) (EXHIBIT 3).

The SOS website reflected a filing of the assumed name, 19th Hole Pawn, dated July 27, 2016 and submitted by Mr. Smith (EXHIBIT 4). The assumed name filing document only reflects Lampasas County. IOI (b)(6) requested Mr. Smith update the SOS information to reflect the assumed name being filed in Bell County and any other counties the assumed name was being used to conduct business. Mr. Smith verbally acknowledged he understood the request. Mr. Smith provided a copy of the document reflecting the assumed name has been filed in Bell County, which is valid until September 15, 2026 (EXHIBIT 5).

The Federal Licensing System report only reflects Mr. Hicks as a Responsible Person. Ms. Lohse, (b)(6) and Mr. Smith are all reflected as "deactivated". Mr. Hicks stated (b)(6) the only Responsible Person who should have been deactivated when she left the business and there was no intention for Mr. Smith or Ms. Lohse to be deactivated as Responsible Persons. Mr. Hicks stated he was not aware prior to the inspection that Mr. Smith and Ms. Lohse had been deactivated and requested Mr. Smith and Ms. Lohse be activated as Responsible Persons.

IOI (b)(6) queried the Texas Office of the Comptroller website which reflects as "active" account, #17428710481 for L O & H Ventures, LTD (EXHIBIT 6). The website did not reflect any Officers/Director information. IOI (b)(6) queried the Office of Consumer Credit website which reflected the license, #7293335, is "active" (EXHIBIT 7). IOI (b)(6) also verified the original FFL, Texas Sales and Use Tax Permit, and pawnshop license in person.

4 - Acquisition & Disposition (A&D) Record - Inventory

IOI (b)(6) conducted a 100 percent inventory and there were 107 firearms in inventory and open entries reflected by the computerized Acquisition and Disposition (A&D) record. The firearm identifying information, to include the serial number, reflected by each physical firearm was compared to the open entries and there were no discrepancies.

The standard operating procedures are as follows:

19th Hole Pawn utilizes a computerized record generated by the software called Third Charm. The record is backed up daily to a hard drive located on site in the gun vault.

(b)(6) Mr. Smith, and two other employees are eligible to make entries into the A&D record, which occur at the time a firearm is acquired or disposed. The firearm identifying information entered into the A&D record is taken from the physical firearm.

An inventory count is conducted once a month and a full inventory, in which the firearm is compared to the A&D record, is conducted twice a year. There were no thefts or losses reported during the inspection period or as a result of the inspection.

5 - ATF Forms 4473 - NICS & Other Dispositions


There were ATF Forms 4473 on file and reviewed for the inspection period. The standard operating procedures are as follows:

Mr. Smith, **(b)(6)**, and one other employee are qualified to complete transactions with the customers requiring the completion of an ATF Form 4473. Once the form is completed, a NICS check, if applicable, is conducted by the initial employee. 19th Hole Pawn also accepts the Texas Concealed Handgun License or the new Texas License to Carry permit as an exception to the NICS check. The ATF Forms are reviewed twice at the time of the transfer and again at the end of the month. The ATF Forms 4473 are filed chronologically and any ATF Forms 4473 reflecting a NICS "proceed" response were filed separately from the ATF Forms 4473 reflecting a "denied" response. The ATF Forms 4473 also reflect a loan number as a form serial number, which can be cross-checked with the A&D record.

IOI (b)(6) requested an FFL Audit Report which reflected 22 "proceed" NICS responses. The report also reflected 21 "denied" responses for the last five years (seven within the inspection period). IOI (b)(6) compared all NICS responses discussed above to the ATF Forms 4473 and there were no discrepancies.

Following a review of the ATF Forms 4473, the following violations were cited:

IOI (b)(6) compared the Multiple Sales Report to the Trace History Report and there were no discrepancies. There were no multiple sales transactions discovered that should have been reported.

7 - Suspicious/Prohibited Purchasers

The identifying information for one Responsible Person (Mr. Hicks) along with seven random customers and 15 firearms were queried in the NCIC and Etrace databases and there were no prohibiting hits. 19th Hole Pawn participates in the Leads Online program with the Harker Heights Police Department in which the firearms and merchandise acquired by the store are reported to the police department. There were no suspicious purchasers discovered during the inspection.

8 - Trace Activity

There were no traces reflected by the Trace History Report for the inspection period and no open traces from any other period.

9 - NFA/Importer/Collector/Manufacturer

19th Hole Pawn does not deal in National Firearms Act firearms nor conduct business as an importer, collector, or manufacturer.

10 - Referrals

There were no referrals generated as a result of the inspection.

11 - Other

IOI (b)(6) verified the Youth Handgun Safety Act poster was displayed and the notices are available for distribution. Mr. Hicks has not attended any recent ATF seminars.

12 - Closing Actions

A closing conference was held on August 29, 2016, and IOI (b)(6) reviewed the Acknowledgement of Federal Firearms Regulations and the ATF Form 5030.5 Report of Violations with Mr. Hicks on that day. Both signed the Report of Violations and Acknowledgement of Federal Firearms Regulations on that day and Mr. Hicks was provided a copy of both (EXHIBIT 13).

The following topics were also discussed in length: inventory requirements; NICS requirements; A&D book; multiple sales of both handguns and rifles meeting the specified requirement; sales to non-immigrant aliens; sales to military and police; sales to legal aliens; internet sales; transfers to out-of-state residents; transfers to other FFLs; ATF Form 4473; straw purchases and gun locks.
