Business Profile:

The licensee is in the business of selling new and used handguns and long guns, gun accessories, ammunition and NFA weapons. During the past (12) months, licensee acquired (b)(4) firearms; (b)(4) hand guns, (b)(4) long guns. Licensee disposed of (b)(4) firearms. The business inventory consist of (b)(4) new firearms and (b)(4) weapons. The main suppliers used by the licensee are (b)(4)

(b)(4) The licensee does not participate in gun shows. Licensee does conduct internet sales through gunbroker.com and has a website (mmguns.com). Licensee does not have any other ATF license's but holds a current SOT stamp as an NFA dealer.

Licensee is compliant with local and state zoning requirements.

Ownership and Control:

Business is listed as an LLC, with Michael Almstedt listed as member. Responsible persons are correctly shown in FLS. At the time of the inspection, investigator did not suspect any form of hidden ownership with current business operations.

Variance:

No active variances on file. No activity conducted that requires a variance.

4 - Acquisition & Disposition (A&D) Record - Inventory

A FFL History Query was obtained. There were () successful firearm trace requests for the past 12 months. A secondary market analysis was conducted on (10) used firearms located in the licensee's inventory. NCIC/TECS checks were conducted; no derogatory information.

9 - <u>NFA/Importer/Collector/Manufacturer</u>

The licensee has a current SOT stamp as an NFA dealer; (7) NFA weapons in inventory; no discrepancies. No importing and no manufacturing.

10 - Referrals

No referrals generated.

11 - <u>Other</u>

Deconfliction was conducted by the Lead IOI (b)(6) (b) through NFORCE with negative results.

Licensee's response: The licensee stated they could not find the ATF F 4473 for the missing firearm. The buyer was contacted and provided a picture of the box of the missing firearm but not the firearm. One of the firearms that did not have a disposition, (Manf: S&W, Model: SD9VE, S/N: (b)(6) Type: 9mm), was actually returned to

the customer the same day it was acquired but the licensee did not put the disposition in the A&D book. The firearm is now in the custody of St. Louis County PD (exhibit 4).



The licensee was instructed to complete ATF F 3310.11, ATF Theft/Loss Report for the missing firearm. The licensee was also instructed to record the dispositions and acquisitions into the A&D book and to make corrections to incorrect entries.
