



1 - Introduction

Inspection Profile:

A scheduled compliance inspection was conducted by IOI (b)(6) on 08/03/16 at the business premises of Federal Firearms Licensee (FFL) Donald H.Weyhrauch who has possesses an FFL type 01 – Dealer of Firearms since 1982. A previous attempt to inspect at the business address was unsuccessful. The inspection period was from approximately 08/03/15 to 08/03/16. Interviewed and assisting throughout inspection was sole proprietor and responsible person Donald H. Weyhrauch.

Business Profile:

The licensee maintains a firearms business at his residence, in an attached garage. The licensee's low volume "hobby" business is to conduct internet transfer and special order of firearms for friends and acquaintances, mostly to police officers in his community. The firearms are predominantly new firearms. The licensee does maintain a small inventory for retail sale. He does not participate in gun shows or qualified events - banquets that sponsor firearms raffles.

Ownership and Control:

There has been no change to ownership or control of the business. Donald H.Weyhrauch is sole proprietor and sole responsible person.

Variance:

There are no variances associated with this license.

2 - Recommendation

Though these violations would merit a recommendation of "violations, Warning Conference with Warning Letter, and recall inspection", however because this is the licensee's first compliance inspection, I am submitting an alternate recommendation: "violations, Warning Letter only, and recall inspection".

3 - Inspection History

There is no previous compliance history associated with this licensee.

A complete physical inventory was conducted of all firearms on the business premises. There were 18 firearms in inventory. The following discrepancies were discovered:

- There were firearms found in inventory with no A&D record entry.
- There was firearm disposed with no in the A&D disposition record entry.

• There were firearms with erroneous or missing pieces of A&D information. These discrepancies were cited in the attached Report of Violations and noted below.

5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee had no completed Form 4473 on file for the exact inspection period, but that was dated was examined for errors and omissions, this being the licensee's first inspection.
