

#### 1 - Introduction

### **Inspection Profile:**

Investigator, (b)(6) conducted a DE Onsite Firearms (Dealer) Inspection of the federally licensed (Type 01) firearms business, owned by Luter's Supply Company Inc. The inspection began on December 29, 2015 with the closing conference held on December 31, 2015.

During the inspection the following individual was interviewed in person and identified himself by means of a valid Mississippi driver's license as;

Mr. Maxwell Joseph Luter w/m (b)(6) (Vice-President) MS DL(b)(6) expires 07-23-2023

Mr. Luter answered questions, provided requested information, and assisted with the completion of the inspection. The required records were examined for the one year period of December 29, 2014 to December 29, 2015.

Advance notification was not given for this inspection.

### **Business Profile:**

Between December 29, 2014 and December 29, 2015, the licensee acquired approximately firearms and disposed of approximately firearms. Of the firearms acquired and disposed approximately (b)(4) were long guns and approximately (b)(4) were hand guns. All of the items in inventory are new firearms, this dealer does not deal in secondary market firearms. The licensee's main suppliers of new firearms are (b)(4)

Luter's Supply Company Inc. is not a wholesaler; they do not conduct business at gun shows. There are no offsite storage locations. The business does not engage in internet advertising for the sale of firearms. In addition to firearms, Luter's Supply Company Inc. sells: bathtubs, showers and Jacuzzis. Luter's Supply Company Inc. does not operate any other business from the business premise. Business is conducted from a store front shop owned by the licensee.

The business premise is located in an urban business district inside the city limits of Tylertown Mississippi. There were no safety risks observed. Luter's Supply Company Inc. acquired their original FFL for this business on 07-18-1981.

There are no other ATF licenses or permits held or required by Luter's Supply Company Inc. All required local and state tax licenses were valid at the time of this inspection. The business is in compliance with all local zoning ordinances and the premises are not located within a school zone.

### **Ownership and Control:**

There have been no changes in ownership or control of the business since the original application was filed. A query conducted using the search engine on the Mississippi Secretary of State website revealed Luter's Supply Company Inc. was a properly registered corporation in good standing. FLS properly lists Mr. Maxwell Joseph Luter (Vice-President) and his father, Mr. Emmette Davis Luter (President) as the only two responsible persons for this license.

### 4 - Acquisition & Disposition (A&D) Record - Inventory

Luter's Supply Company Inc. maintains one hand written acquisition and disposition book. The records are maintained in the proper format and all of the proper headings, columns, manufacturers, models, serial numbers, importers etc. are utilized. All acquisitions and dispositions are recorded in the A & D book the same day the acquisition or disposition is made and a full firearm inventory is made every year. The licensee had not filed any theft/loss reports during this inspection period, one theft/loss report was filed as a result of this inspection for two missing firearms.

Full inventory verification was conducted during this inspection. The serial numbers on the firearms in inventory were cross referenced with the information recorded in the A & D book for firearms. There were 22 firearms in the physical inventory and goen entries in the A & D book. Twenty five firearms were checked from acquisition through disposition without discrepancy and no trafficking issues discovered. The licensee was cited for the following A & D violation;

### 5 - ATF Forms 4473 - NICS & Other Dispositions

For the period of 10/28/2015 to 12/28/2015, the FFL Audit Log showed one proceed response and for the 12 month period of this inspection no denied responses. The one response were verified by ATF Form 4473 review.

For the 12 month period of this inspection, there were ATF Forms 4473 on file that documented completed transfers to non-licensees. These forms were filed chronologically. A second review of all completed ATF Forms 4473 is made before this licensee transfers any firearm. All ATF Forms 4473 were reviewed with no violations being found or cited.

All transfers from licensee to licensee were conducted properly and no sales to law enforcement officers were documented during this inspection period.

#### 6 - Multiple Sales

According to the information received from the Violent Crime Analysis Branch, Luter's Supply Company Inc. reported no multiple sales in the last 12 months. This Investigator did not discover any unreported multiple sales.

#### 7 - Suspicious/Prohibited Purchasers

There were no possible traffickers, straw purchasers, prohibited persons, or any other suspicious purchasers identified during this inspection. NCIC checks were run on the two responsible persons, these checks did not develop any hits or prohibiting convictions for referral.

There were no individual firearm purchasers who's initial NICS response was delayed and no resolution was ever provided according to box 21e on the 4473s during this inspection period.

### 8 - Trace Activity

According to the information received from the Violent Crime Analysis Branch, Luter's Supply Company Inc. was not the final dealer for any firearms traced between December 2014 and December 2015. There were no unsuccessful traces attributed to the licensee in the last 12 months. No trace violations were cited.

This licensee only deals in new firearms and no secondary market firearms were acquired or disposed of by this licensee.

#### 9 - NFA/Importer/Collector/Manufacturer

This Type 01 FFL licensee is not an NFA/SOT Holder, Importer, Collector or Manufacturer.

#### 10 - Referrals

No referrals were made as a result of this inspection.

#### 11 - Other

The licensee was in compliance with the Youth Handgun Safety Act (poster and notice) and secure gun storage/safety devices were available in the business

### 12 - Closing Actions

The closing conference was conducted on December 31, 2015. Mr. Maxwell Joseph Luter (Vice-President) was in attendance. A copy of the violation cited was given to Mr. Luter and explained in great detail. Mr. Luter signed the violation and was given the opportunity to provide a response for the violation (see violation section for licensee's response). This Investigator reviewed the Acknowledgement of Federal Firearms Regulations and the notice of selling firearms after revocation, expiration or surrender of an FFL in great detail with Mr. Luter. Mr. Luter signed the acknowledgement form and a copy was provided to him as required. Mr. Luter was given ATF contact information, information concerning secure gun storage and safety device requirements, example copies of all required ATF forms and instructions on how to visit the ATF website for further education and information.

Mr. Luter advised he had never attended any ATF training classes but has visited the ATF web-site for education and information.
