

1 - Introduction

Inspection Profile:

On February 13, 2017, Industry Operations Investigator (IOI) (b)(6) Senior Industry Operations Investigator (SIOI) (b)(6), Industry Operation Investigator (IOI) (b)(6) and Industry Operations Intelligence Specialist (b)(6) visited the business premise of River City Firearms for the purpose of conducting a compliance inspection. River City Firearms holds a Type 01 Dealer in Firearms Other Than Destructive Devices 4-61-04531 with an expiration date of January 1, 2018.

The business is a corporation in which Derrick Meyers is listed as president/responsible person and Tamara Meyers is listed as responsible person in FLS. IOI (b)(6) discussed with Mr. Meyers that he would need to submit an ATF Form 7 Application for Federal Firearms License since he had changed his entity. Mr. Meyers had formed his corporation in October 21, 2015. Derrick Meyer's identity was verified by Indiana Driver's License #(b)(6) Mr. Meyers was interviewed and the on-site inspection began. The inspection period is February 13, 2016 to March 17, 2017. Advance notice was not provided.

Business Profile:

River City Firearms conducts retail sales of firearms, holsters and ammunition. Mr. Meyers estimated % of firearm transfers were new guns. The business premise is located in urban area at 2915 Preston Highway. The licensee operates from a commercial storefront located in a suburban area in Jefferson County, Kentucky. The licensee holds a Type 01 Dealer in Firearms Other Than Destructive Devices, which is appropriate for the type of business activity conducted. River City Firearms inventory mainly consists of (0)(4) new firearms and (0)(4) used firearms.

The licensee had 1,053 firearms in inventory. The licensee acquired approximately (b)(4) firearms in the past 12 months. The licensee transferred approximately (b)(4) firearms in the past 12 months. River City Firearms inventory consists of approximately (b)(4) handguns and approximately (b)(4) long guns. Mr. Meyers stated that his principal suppliers are (b) (4) s maintains an email address and a website <u>www.rcfguns.com</u>. River City Firearms conducted one internet sale during the inspection period. Mr. Meyers stated that River City Firearms

mainly sells to family, friends and other Federal Firearm Dealers. River City Firearms does not participate in gun shows.

River City Firearms operates with four employees that conduct firearm sales. Hours of Operation are currently listed as Monday – Thursday 10am-6pm. Friday 10am-5pm and Saturday 10am-2pm. Closed on Sunday.

Ownership and Control:

As previously stated, River City Firearms is a corporation in which Derrick Meyers is listed as president. IOI (b)(6) stated to Mr. Meyers that he would need to apply for a new license since he had formed River City Firearms as a corporation instead of a sole proprietorship. Mr. Meyers stated that he was not aware that he needed to apply for a new license. On February 14, 2017, Mr. Meyers applied for his new license. River City Firearms is listed with Kentucky Secretary of State, active and in good standing. Hidden ownership is not suspected. (Exhibit 1)

Variance:

The licensee does not hold any variances regarding their Type 01 FFL. No variance requests were submitted as a result of this inspection.

2 - <u>Recommendation</u>

The current inspection disclosed nine violations of the Gun Control Act, which warrants a recommendation of a Warning Letter, due to failure to file multiple sales reports when legally required on cocasions. IOI(b)(6) recommends a Warning Letter. No recall requested.

4 - Acquisition & Disposition (A&D) Record - Inventory

The licensee maintains a bound book for the A & D record which appears to contain all of the required information. The licensee stated that they conducted an inventory every

6 months for a comparison to the A & D record to ensure accuracy. The licensee stated all A & D entries are typically made by the close of business. The current inspection disclosed that there were A & D entries, not made in a timely/accurate manner. The FFL did use a tag system to keep track of the entries in the A & D record.

At the time of inspection, there were 1,053 firearms in physical inventory and there were first firearms on hand according to the licensee's A & D records. A 100% inventory was conducted on the firearms, which disclosed A & D errors. The error rate for failing to timely and/or correctly record acquisitions is 0%. The error rate for failing to timely and/or correctly record dispositions is 0%.

There were ATF 4473s during the inspection period. (Worksheet 1 – Inventory and A & D Review Worksheet and Report of Violations)

After the final reconciliation, the following violations of 27 CFR 478.125(e) regarding the inventory and A & D record were reported on the Report of Violations; Licensee failed to record a firearm disposition in the A & D record in the first instances. (Exhibit 2 – Photos of A & D Record Errors for Violation of CFR 478.125(e))

5 - ATF Forms 4473 - NICS & Other Dispositions

There were **MATE** ATF Forms 4473 on file for the inspection period. All ATF Forms 4473 on file were reviewed. Each sales clerk is responsible for the proper completion of ATF Forms 4473 at the time of the transaction. The licensee maintains their ATF F 4473s in chronological order. The licensee maintains the denials separately. Overall, the error rate for proper completion of the ATF F 4473 was 1.4% during the inspection period. The licensee's procedures concerning the ATF F 4473 need to show improvement. IOI (b)(6) recommended the licensee set up a review procedure for the ATF F 4473 to ensure proper completion in the future. These violations included the following:




