



#### 1 - Introduction

#### **Inspection Profile:**

This is a report of an unannounced compliance inspection of the operations of Benjamin Ray Shirley dba Haywood Shooting Supply conducted by IOI(b)(6) (b)(6) and(b)(6) on August 26, 2015. This full compliance inspection is being conducted in conjunction with an Amended Application inspection (775045-2015-0314). IOI(b)(6) interviewed Benjamin Ray Shirley (KY DL (b)(6) Owner/Responsible Person.

#### **Business Profile:**

The licensee has held this license since September of 2011. The licensee sells firearms and firearm accessories. All firearms are stored at this location and no offsite storage is used. The licensee has acquired  ${}^{(b)(4)}$  firearms in the past 12 months. The licensee has disposed of approximately ${}^{(b)(4)}$  firearms in the past 12 months. The licensee stated that  ${}^{(b)(4)}$  of its business is retail sales. The licensee stated that roughly  ${}^{(b)(4)}$  of its business is long guns and  ${}^{(b)(4)}$  is handguns of which  ${}^{(b)(4)}$  are new firearms and  ${}^{(b)(4)}$  are used. The primary suppliers are  ${}^{(b)(4)}$ . The licensee is not a wholesaler. No other businesses are conducted by the licensee or from the business premises.

The licensee's business premises is a commercial store front located in rural section of Barren County south of south of Glasgow KY. The licensee does sell firearms via the internet using www.gunsinternational.com. At this time the licensee does not have their own web site. The licensee does not conduct business at gun shows. The licensee's business premises is in compliance with state and local laws including zoning.

### **Ownership and Control:**

The licensee is a Sole Proprietor with Benjamin Shirley as Owner/Responsible Person and Larry Shirley as Responsible Person. The licensee wants to add John Shirley as a responsible persons.

#### 4 - Acquisition & Disposition (A&D) Record - Inventory

A full inventory was conducted of the licensee's firearms. The licensee had 342 firearms in inventory and open dispositions in the A&D Records. During the comparison of the physical inventory to the A&D Records, the following discrepancy was discovered. In the instance a firearm was in physical inventory but had a disposition recorded indicating a transfer. The firearm was logged out by mistake by the licensee.

With the exception of the discrepancy listed above the records were accurate, in the proper format and the entries were made timely. No thefts or loss occurred during the inspection period. No illegal firearms or obliterated serial numbers were discovered. Fifteen firearms were traced through the licensee's records from acquisition to disposition without discovering any discrepancies. The licensee stated that all acquisitions and dispositions are recorded at the time of the transaction and an inventory is conducted quarterly.

#### 5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee had "denied" ATF Form 4473 on file for the past 12 months. With the exception of the previously discussed A&D Record discrepancy the licensee is properly documenting firearms transferred to other licensees. The licensee did not make any transfers to law enforcement for official duty. A verification of the FFL audit log was conducted during the inspection without uncovering any discrepancies. Reference violations 1, 2, 3, 4 and 7 ATF Form 5030.5, Report of Violations, Worksheet 2, and Exhibit 2.

#### 6 – <u>Multiple Sales</u>

The Violent Crime Analysis Branch FFL Master Query indicated that the licensee reported multiple sales during the inspection period (last 12 months). The licensee's records showed that the licensee failed to report multiple sales during the last 12 months. On this occasion, the licensee sold two or more handguns to the same individual within five days, without completing ATF Forms 3310.4. After being instructed to do so, the licensee completed and submitted the ATF Forms 3310.4, Report of Multiple Sale or Other Disposition of Pistols and Revolvers. Copies of the ATF Forms 3310.4 are attached as Exhibit 3. Reference violation 7 ATF Form 5030.5, Report of Violations, Worksheet 2, Exhibit 2 and Exhibit 3.

#### 7 - Suspicious/Prohibited Purchasers

A background check was conducted on two suspicious purchasers without discovering any prohibiting information. The suspicious purchasers failed to answer item 111. A background check was conducted on two responsible persons without receiving any prohibiting information.

#### 8 - Trace Activity

The licensee was not contacted for a trace request in the last 12 months. Queries were conducted on six used firearms without receiving any hits.

#### 6. **27 CFR 478.99(a)**

#### Nature of Violation:

In **the set of the set** 

#### Licensee's Response:

Mr. Shirley states that he was unware of the law for Illinois to have a 24 hour waiting period. As a result of the inspection he will now double check state laws prior to transferring a long gun to an out of state resident.

#### **Corrective Action:**

The licensee will only transfer long guns to out of state residents where it does not violate state law.

#### 7. **27 CFR 478.21(a)**

#### Nature of Violation:

Failure to record all required information in items 31, 32, 33, and 35 of ATF Forms 4473. Item 31, Trade/Corporate Name and Address of Transferor, is blank on form. Item 32, Federal Firearms License Number, is blank form. Item 33, Transferor's/Seller's Name, is blank on two forms. Item 35, Transferor's/Seller's Title, is blank on forms.

Mr. Shirley stated that he did not notice these things. As a result of the inspection Mr. Shirley stated that a second employee is now checking each forms prior to transferring the firearm.

#### **Corrective Action:**

Ensure that the seller prints their name, signs their name, records their title and dates the ATF Form 4473 when transferring a firearm. Ensure that the seller adds the Trade/Corporate Name and Address as well as the Federal Firearms License Number prior to transfer.

#### 8. 27 CFR 478.125(e)

#### Nature of Violation:

Failure to maintain complete and accurate Acquisition and Disposition (A&D) Records. In sistance a firearm was in physical inventory but had a disposition recorded indicating a transfer. The firearm was logged out by mistake.

#### Licensee's Response:

Mr. Shirley stated this was just an oversight. An employee mistakenly logged the rifle out, realized the mistake and logged out the correct rifle but forgot to remove the incorrect disposition. He continued to say that all transactions in the A& D record are now being double checked.

#### **Corrective Action:**

Ensure to timely and accurately record the acquisition and disposition of all firearms. **Reference:**
