## 1 - Introduction

## **Inspection Profile:**

Industry Operations Investigator (IOI) (b) (6) conducted a full firearms compliance inspection beginning  $6/16/\overline{2016}$  at the above business premises of Type 01/Dealer Federal Firearm Licensee Roy Eicher d/b/a Hunters Den of Ohio. The review of records and inventory concluded on 7/8/2016. Advanced notification was not provided. Responsible person Roy Eicher and store employee (b)(6) were interviewed during the course of the inspection at the licensed business premises, and licensee gave record/inventory access to IOI (b)(6) during the course of the compliance inspection. The inspection covered the period of 6/16/2015-6/16/2016. The scope of the inspection was a Firearms Disposition Emphasis Inspection. IOI (b)(6) confirmed the identity of Roy , expires  $\frac{2}{9}$ 2020) by viewing a valid state of Ohio Eicher (OH DL (b) (6) Drivers License. No other federal, state, or local agencies participated in the investigation.

## **Business Profile:**

The licensed business premises is a storefront located within Pierce Township, Clermont County, Ohio. IOI(b)(6) contacted Zoning Officer(b)(6) of Pierce Township (950 Locust Corner Road Cincinnati, OH 45245(b)(6) (b)(6)) and confirmed the business premises meets all zoning requirements.

The licensee mainly uses the FFL to buy and sell new and used handguns and long guns to the general public in Clermont County, Ohio. Licensee also provides transfer services to the public. This store location retails firearms, firearms accessories, ammunition, and other sporting goods supplies and equipment. No other business operations are conducted from the FFL location. The licensee does conduct business at gun shows, primarily Bill Goodman's in Sharonville, Ohio. (b)(4)

) are the primary suppliers. The licensee does not conduct internet sales. The licensee advertises by word of mouth and business cards. There is no off-site storage of firearms. A Type 01/Dealer Federal Firearms License remains appropriate for the business.

During the course of the inspection, it was discovered that the licensee acquired approximately (b)(4) firearms and transferred approximately (b)(4) firearms during the inspection period. At the time of inspection, the licensee had an inventory of 162 firearms. Approximately (b)(4) of sales are used firearms.

## 4 - Acquisition & Disposition (A&D) Record - Inventory

In order to check the accuracy of the licensee's bound book record to present inventory, IOI(b)(6) conducted an inventory by comparing the firearms in inventory at the licensed premises to the open dispositions in the bound book. There were dispositions in the licensee's bound book record and 162 firearms in inventory. The open disposition for an (b)(3) - 112 Public Law 55 125 Stat 552

could not be reconciled, and the firearm was considered missing from inventory. The licensee submitted an ATF Form 3310.11 Theft/Loss Report on 7/8/2016. See **Exhibit 1** and reference ATF Incident

The licensee was cited a violation (Violation 6) under Title 27 CFR 478.125(e) for failure to properly record the acquisition and/or disposition into the bound book record occasions. In addition to the missing firearm, there were five open dispositions in the bound book which were reconciled after review of available records.

## 5 - ATF Forms 4473 - NICS & Other Dispositions

ATF Form 4473 transactions completed by the licensee in the previous 12 months. After reviewing the licensee's ATF Form 4473s and verifying the NICS Transaction Numbers from the last two months through use of the NICS FFL audit log, no fraudulent use of NICS was found. There were 11 denials within the past 12 months. The NICS FFL audit log is attached as **Exhibit 2**. No sales to law enforcement officers were found. During the inspection of the licensee's ATF Forms 4473, 5 violations were found regarding Federal Firearms Regulations as described below.

There were ATF Form 4473s containing errors, accounting for five violations:

Violation #1 – ATF Forms 4473 contained errors in boxes 24 and 25 resulting in violation of 27 CFR 478.21(a).

Violation #2 – ATF Forms 4473 contained errors in boxes 11c, 11j, 11l, and/or 17 resulting in violation of 27 CFR 478.124(c)(1).

Violation #3 – ATF Forms 4473 contained errors recording NICS contact information in boxes 21a and/or 21d resulting in violation of 27 CFR 478.124(c)(3)(iv).

Violation #4 — unreported multiple sales were found on ATF Forms 4473 resulting in violation of 27 CFR 478.126a.

Violation #5 ATF Forms 4473 contained a "Yes" answer to a prohibited person question(s) in item 11 and the firearm was subsequently transferred resulting in violation of 27 CFR 478.99(c).

#### 6 - Multiple Sales

There were multiple sale transactions involving firearms reported by the licensee over the course of the last 12 months. After reviewing all ATF Form 4473 transactions completed by the licensee in the previous 12 months, IO (b)(6) discovered that the licensee failed to complete ATF Form 3310.4 (Report of Multiple Sale or Other Disposition of Pistols and Revolvers) occasions involving firearms. The licensee was cited a violation under Title 27 CFR 478.126a. A copy of the ATF Form 4473 transactions are attached in Exhibit 3; also see Worksheet 2 (2012 Edition) and reference Violation 4. IOI (b)(6) verified all multiple sales were properly completed by licensee via ATF Form 3310.4. See Exhibit 4.

Licensee is compliant with Youth Handgun Safety Act and provides secure gun storage/safety devices where applicable.

#### 12 - Closing Actions

A closing conference was held on 7/8/2016 with responsible person Roy Eicher regarding the findings of the compliance inspection. The licensee was reminded of the Gun Control Act requirements for maintaining a Federal Firearms License. IOI(b)(6) reviewed the Report of Violations with licensee, concluding with the signing of the Report of Violations. An overview concerning Federal Firearms Rules and Regulations was then given to the licensee, concluding with the signing of the Acknowledgement of Federal Firearms Regulations by Roy Eicher. 


