REVIEW COMMENTS AND RECOMMENDATION

Concur with alternate recommendation of Warning Letter with No Recall in lieu of a Warning Conference. FFL was maintaining computerized A&D Records but due to the computer crashing all records were lost. Clearly the FFL did not meet the requirements for backing up the computer program but the FFL was able to fully recreate a manual A&D Record utilizing invoices and ATF F 4473s. Because the FFL was diligent in recreating an accurate A&D Record book and was thorough in maintaining invoices, etc. the FFL was able to accurately and completely recreate the entire book. Also, the FFL is now aware of the requirements of maintaining computerized records and now will maintain the records manually to ensure no future loss of records.

All violations were fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), Industry Operations Investigator (b)(6), during the closing conference held at your licensed premises on November 08, 2016. You indicated that you understood the requirements of the firearms laws and regulations and that corrective action would be taken to eliminate future violations.

1 - Introduction

Inspection Profile:

An onsite compliance inspection was conducted on October 27, 2016 at the above licensed premise. It was discovered that there was not a completed Acquisition and Disposition Record. When IOI (b)(3) Pub law 112-55 returned to finish the inspection on Oct. 28, 2016, RP Charidy Butcher (b)(3) Pub law 112-55 125 Stat. 552 and IOI (b)(3) Pub law 112-55 could not finish the inspection. A return visit was made on Nov 8, 2016 to conclude the inspection, issue a Report of Violations and hold the closing conference. Owner, Bryan Butcher and RP Charidy Butcher were interviewed by IOI (b)(3) Pub law 112-55 125 Stat. 552. Advance notice was given due to limited hours of operation. The period of inspection was 11/27/2015 through 11/27/2016. One violation was disclosed.

Business Profile:

The business is a high volume dealer who transfers approximately (b)(4) firearms per year. There were (b)(4) acquisitions and (b)(4) dispositions in the last 12 months. Transfers have been (b)(4)% new firearms of which (b)(4)% are long guns and (b)(4)% hand guns. The licensee did not attend gun shows or perform gunsmithing. The licensee operates from the basement of a home owned by the licensee outside the city limits of Atwood, IL in Douglas County. The entire basement has been made into a gun shop with a separate entrance from the home. There are no zoning restrictions that would prohibit the licensee from operating his firearms business from his home. GPS co-ordinates were entered in N-SPECT.

Ownership and Control:

The license is individually owned by Bryan Butcher with his wife Charidy as a Responsible Person. This was accurately reflected in N-SPECT.

Variance:

Licensee has no variance on file.

2 - Recommendation

Report of Violation, Warning Letter, No Recall Inspection.

This is an alternate recommendation. The one violation was able to be corrected and no other violations were disclosed. Future compliance is assured.

4 - Acquisition & Disposition (A&D) Record – Inventory

The physical inventory was taken on October 27, 2016 and consisted of 15 firearms. There was no completed A & D Record. Charidy Butcher stated that they had been keeping a computerized Bound Book but that the computer had crashed and the record had been lost. She had started to re-create the A & D Record using invoices and ATF Forms 4473. The inventory could not be reconciled until the Bound Book was completely recreated. IOI (b)(6) worked with Charidy the remainder of the day creating the Bound Book. When IOI (b)(6) returned the following day, to complete the BB and finish the inspection, Charidy thought she was having a heart attack and left to go to the emergency room. IOI (b)(6) also left. Charidy recreated the A & D Record the following week. IOI (b)(6) returned on Nov. 8, 2016 to finish the inspection. The inventory was reconciled. There were no missing firearms. Future compliance assured.

The entire Acquisition and Disposition Record was recreated from commercial invoices and ATF Forms 4473. It was explained to the licensee what was required to keep an electronic A & D Record and was given the Regulatory Fact Sheet explaining the regulations. The licensee stated that a hard copy of the Bound Book would be kept in the future.

The licensee was cited for:

Violation of 27 CFR 478.125(e) was cited. This was a not repeat violation. Refer to #13 Violations.

5 - ATF Forms 4473 – NICS & Other Dispositions

A review of (b)(6) ATF Forms 4473 from the last twelve months revealed no violations.

6 – Multiple Sales

A Trace/Multiple Sales Query revealed no multiple sales. A review of all ATF Forms 4473 revealed no unreported multiple sales.

7 – Suspicious/Prohibited Purchasers

There were no suspicious/prohibited purchasers.

8 – Trace Activity

A Trace/Multiple Sale query revealed there had been 0 successful traces in the last 3 years. The average time to crime was 17 months.

One used firearm in inventory and 4 used firearms that had been transferred were run for traces. There were no hits on the firearms.

9 - NFA/Importer/Collector/Manufacturer

Licensee does not deal in NFA firearms or manufacture firearms. Licensee does not hold a collector's license.

10 - Referrals

No referrals were generated as a result of the compliance inspection.

11 - Other

No other significant information to report.

12 - Closing Actions

A formal closing conference was held with the RP, Charidy Butcher on Nov. 8, 2016. All regulatory requirements were discussed with the licensee, including secure gun storage, safety devices, and required records, conduct of business, straw purchases and miscellaneous provisions. An ATF Firearms Newsletter, Youth Handgun Poster and pamphlets, Theft/Loss Report, Multiple Sales Report and ATF Phone List was provided to the licensee. The Acknowledgment of Federal Firearms Regulations was

also reviewed and signed and dated by Charidy Butcher (Exhibit No. 1).

The loss of the computerized A & D Record was discussed in detail with the licensee. The Licensee was able to recreate the entire Acquisition and Disposition Record from commercial invoices and ATF Forms 4473. It was explained to the licensee what was required to keep an electronic A & D Record and was given the Regulatory Fact Sheet explaining the regulations. The licensee stated that a hard copy of the Bound Book would be kept in the future.

No entries are missing. It was explained to the licensee what was required to keep an electronic A & D Record and was given the Regulatory Fact Sheet explaining the regulations. The licensee stated that a hard copy of the Bound Book would be kept in the future.
