1. 27 CFR 478.126a: **Repeat Violation**.

Investigator (b)(6) thoroughly explained the reporting requirements associated with the Multiple Sale of Pistols and Revolvers to unlicensed individuals and instructed the licensee regarding the completion and submission of the form.

Mr. Miller said that he thought the form was not needed anymore because in 2013 he received Multiple Sales forms he mailed back undelivered. FFL showed the returned forms to IOI (b)(6) for confirmation.

FFL stated he will endeavor to comply with this requirement in the future.
