#### 1 - Introduction

#### **Inspection Profile:**

On 3.25.2016, ATF Industry Operations Investigator (b)(6) initiated an on-site compliance inspection on Type 01, Federal Firearms Licensee (FFL) YG Pals Enterprises LLC d/b/a Back River Arms. The inclusive dates of the inspection were 3.25.2015- 3.25.2016. Investigator (b)(6) only contact during the inspection was Owner and Responsible Person, Mr. Jonathan Catlett. Due to the evening business hours, Investigator (b)(6) received approval from the Area Supervisor to schedule an appointment with the FFL.

The scope of this inspection is to conduct a recall inspection on this 01 FFL who received a Report of Violations with a recommendation of recall by the 2014 compliance inspection. Also, to verify that the FFL is compliant with all ATF laws and regulations and that prior violations are not being repeated.

## **Business Profile:**

Back River Arms operates from a small, leased, commercial premises located in suburban Poquoson. Back River Arms retails new and used hand guns and long guns to the general public, friends and relatives, law enforcement, and other dealers. The licensee also sells ammunition, and some firearms accessories such as holsters. The licensee consigns firearms and transfers firearms to/from other FFLs. The licensee does not gunsmith and is not an NFA dealer.

During the inspection period the licensee acquired long guns, and receivers. The licensee disposed firearms; handguns, long guns, and receivers. In inventory were firearms, of which were new firearms.

Investigator (b)(6) verified that the business holds a Type 01 FFL which is appropriate for the type of business activity. The licensee's FFL originated 7.2.2013 and expires 8.1.2016. The licensee vends at Hampton Va. gun shows. The licensee's primary wholesale vendors are (b) (4). The licensee sells firearms on the internet via gunbroker.com. The licensee has the required State and Local licensee and permits and does not maintain off-site storage. The Federal Licensing System, License Registration Report now incorrectly lists as responsible persons. Mr. Jonathan Wade Catlett is actively engaged in the business. Mr. Catlett has no employees.

#### 2 - Recommendation

#### 4 - Acquisition & Disposition (A&D) Record - Inventory

On 3.25.2016, the licensee's manual sales and repair A&D Records revealed 28 open entries. Investigator (b)(6) completed a 100% inventory by firearm nomenclature and compared it against the A&D Record. The inventory consisted of 28 firearms. The A&D Record is in the proper format with entry incorrectly made as noted below.

By comparison of Investigator (b)(6) inventory against the A&D Record revealed firearm that was not accurately acquired into the A&D Record (Worksheet 1, ROV, and Violation 7). Investigator (b)(6) directed the licensee to make an immediate correction into the A&D Record.

# (b)(3) 112 Public Law 55 125 STAT 552

Investigator (b)(6) determined the licensee has no segregation of function or division of duties. The licensee has no written, sound system of practices, or policies demonstrated by a consistent application of formal or informal procedures to ensure the accuracy of the record keeping system. As a single person operation, the licensee is responsible for ensuring timely A&D Record entries, taking inventory, and ensuring the accuracy of the A&D book.

Mr. Catlett reported that a periodic inventory is not accomplished. Investigator (b)(6) encouraged the licensee to take a numbers count inventory every 6 months and compare the number with the open entry numbers.

Investigator (b)(6) traced the month of February and March 2016 Forms 4473 through the A&D book by comparing all of the Forms 4473 data to the A&D book and vice-versa; discrepancy as noted above.

The licensee did not file a theft/loss report during the past year or as a result of this inspection.

#### 5 - ATF Forms 4473 – NICS & Other Dispositions

During the reporting period, the licensee executed ATF Forms 4473 denied form). Investigator (b)(6) reviewed 100% of the Fs 4473 for errors. Investigator (b)(6) determined forms were in error (21%) with instances (Worksheet 2, ROV, and Violations 1-6). The licensee files Fs 4473 numerically.

Investigator (b)(6) identified Form 4473 with a "blank" answer in response to Section A, question 11c (Have you ever been convicted of a felony...) Investigator (b)(6) completed a criminal history check on the individual with negative results (Worksheet 2, ROV, and Violation 2).

There is no segregation of function or division of duties in processing and reviewing Fs 4473. The licensee is the only person reviewing the forms. The licensee has no sound system of practices or policies demonstrated by a consistent application of formal or informal procedures to ensure the accuracy of the Forms 4473. The forms are reviewed a second time by the licensee before filing.

Investigator (b)(6) contacted the Virginia State Police for the Firearms Transaction Program Statement Inquiries for the months of February and March 2016. Investigator (b)(6) cross-checked 10 transactions with no discrepancies.

The licensee correctly transferred firearms to other FFLs and uses FFL eZCheck.

#### 6 - Multiple Sales

The Crime Gun Analysis Branch FFL Master Query listed zero (0) multiple sales during the inspection period. Investigator (b)(6) discovered unreported multiple sales, involving firearms. Investigator (b)(6) directed the licensee to complete an ATF Form 3310.4, Report of Multiple Handgun Sale and fax it to the appropriate agency (Worksheet 2, ROV, and Violation 7).

## 7 - Suspicious/Prohibited Purchasers

Investigator (b)(6) requested an analysis of firearms traces, theft or loss reports and multiple sale information from the Violent Crimes Analysis Branch. Investigator (b)(6) analyzed the trace history of the licensee for the past three years.

Investigator (b) (6) examined the licensee's records to determine if trafficking or straw purchase indicators were present. After analyzing the data, Investigator (b)(6) comprised a list of individuals and checked the individual's criminal history r NCIC.NLETS to determine any prohibiting factors which may prevent them from possessing a firearm. Investigator (b)(6) determined there were no indicators of illegal transfers, trafficking or nexus to previous traces or Intel.



#### 12 - Closing Actions

On 4.8.2016 Investigator (b)(6) held a Closing Conference with Mr. Jonathan Catlett. Investigator (b)(6) summarized each item on the Acknowledgement of Federal Firearms Regulations to the licensee's satisfaction and answered all questions. Mr. Catlett signed the Acknowledgement verifying the information was explained and received a signed copy for his files (Exhibit 1).

Investigator (b)(6) issued a Report of Violations (ROV) to Mr. Catlett on 4.8.2016. Investigator (b)(6) discussed the violations and explained all violations found during this investigation. Investigator (b)(6) explained why they were violations, how to correct the violations and how to keep proper records in the future to avoid the violation from reoccurring. Mr. Catlett signed the ROV verifying that Investigator (b)(6) explained it to him. The licensee stated that he understood the ROV. Investigator (b)(6) provided Mr. Catlett a copy of the ROV.
