1 - Introduction

Inspection Profile:

On July 25, 26, 27, & 29, 2016, Industry Operations Investigators (IOI's) (b) (6) (b) (6) firearms & Explosives (ATF), conducted an unannounced DE compliance investigation of Federal Firearms Licensee (FFL) Frank Karas D/b/a Frank's Guns. FFL and Owner, Frank Karas (NYSDL #(b) (6) was present and interviewed during this inspection. This inspection was concluded on August 19, 2016 due to IOI (b) (6) vacation.

The inspection period covered was from July 25, 2015 through July 25, 2016. The scope of the inspection was to conduct a DE Compliance and follow up on a straw purchase.

The closing conference was conducted and a Report of Violations was issued on August 19, 2016. The licensee was cited for the following violation:

Business Profile:

Frank Karas, D/b/a Frank's Guns has maintained a Type 01 Dealer in Federal Firearms License since 1981. This is the fourth compliance inspection for this licensee.

A review of the acquisition and disposition (A&D) records and ATF Forms 4473 on file revealed that during the last 12 months the licensee had acquired approximately (b) (4) firearms and disposed of approximately (b) (4) firearms. The licensee does not sell any firearms wholesale. The licensee sells at two gun shows a year both located in Syracuse, NY.

The licensee maintains all firearms available for sale in several different gun safes as well as gun racks and counters, in addition to two other rooms located on the residential business premises. The licensee was in compliance with applicable state, city and county zoning laws and ordinances. There was no off-

site storage.

Additionally, IOI (b) (6) verified that the licensee had the required New York State Dealer in Firearms License, (#DLR-63) as required by state law. (See Exhibit 13.)

Ownership and Control:

Frank Karas, D/b/a Frank's Guns has maintained a Type 01 Dealer in Federal Firearms License since 1981. IOI (b) (6) queried the Federal Licensing System and determined that Mr. Karas is the sole Owner/ Responsible person for this license in his name. (Exhibit 11.)

The inspection did not reveal any changes in ownership or any indication of hidden ownership. IOI (b) (6) determined that this licensee is actively engaged in the business and that the license is valid until May 1, 2017. (Exhibit 12.) Additionally, Frank's Guns is registered as a business with the New York State Department of Taxation and Finance under ID# (0)(3) = 26 USC 6103. (Exhibit 10.) IOI (b) (6) ran a CCH check on Mr. Karas and no hits were discovered. (Exhibit 14.)

Variance:

The licensee does not have any variances nor does require one at this time.

2 - <u>Recommendation</u>

IOI (b) (6) recommends Violations, Warning Letter Only and no Recall Inspection.

4 - Acquisition & Disposition (A&D) Record - Inventory

At the time of the compliance inspection the licensee was maintaining 1142 firearms in reviewed the Acquisition & Disposition inventory. IOI's (b) (6) (A&D) Record. There were 1142 firearms in inventory, and there were point of the second secon entries in the A&D record. There were no discrepancies in the inventory.

5 - ATF Forms 4473 - NICS & Other Dispositions

There were ATF Forms 4473 on file for the period of investigation. The licensee last conducted a Firearms disposition in August of 2016. There was one denied transaction during the inspection period. There were zero NICS discrepancies identified. There were 93 NICS Checks conducted utilizing the FFL Audit Report Log. No discrepancies were noted. IOI (b) (6) verified that the licensee was maintaining the one denial as required in a separate folder.

6 – Multiple Sales

multiple handgun sale reports for the investigation period. IOI There were (b) (6) identified unreported multiple handgun sales involving handguns that were discovered while reviewing ATF Forms 4473. IOI (b) (6) assisted Mr. Karas on July 26, 2016 in completing and submitting the required multiple sale forms to the required authorities. The forms contained information on pistols that were transferred during the inspection period. Through a review of the ATF Forms 4473, IOI (b) (6) verified that the licensee had not completed these ATF Forms 3310.4 as required and identified these **mathematical set of the set of t** ATF Form 3310.4 as required. As a result of this information, an ATF Form 5030.5, Report of Violations was generated and given to this licensee. (Reference Worksheet 2 and ATF Form 5030.5, Report of Violations.)

11 - <u>Other</u>

IOI (b) (6) observed that the licensee had the Youth Handgun Safety Act (YHSA) poster displayed at the licensed premises and will be providing handgun purchasers with the required YHSA notice pamphlets. The licensee understands the requirements of the Child Safety Lock Act of 2005. All handguns purchased are provided with locks.

Additionally, IOI (b) (6) verified with Syracuse Criminal Enforcement ATF Special Agent (S/A) (b) (6) that there was no ongoing investigation regarding the suspected straw purchase. Agent (b) (6) said that there was no active investigation and that there was only an initial interview and that the case was closed.

12 - Closing Actions

A closing conference was conducted on August 19, 2016. IOI's (b) (6) and licensee Frank Karas were present at the closing conference. The licensee was cited for one violation. The Acknowledgement of Federal Firearms Regulations was reviewed with Mr. Karas. The Acknowledgement was signed by Mr. Karas during the closing conference. (See Exhibit 1.)

Licensee's Response: Licensee indicated that they had attempted to send the Multiple Sales via fax and were given a busy signal. Licensee did not attempt to follow through after the initial busy signal was given.


