1 - Introduction

Inspection Profile:

On November 17, 2015 Investigators (IOIs) (b)(6) and (b)(6) of the Bureau of Alcohol, Tobacco, Firearms and Explosives (BATF) began a recall compliance inspection at the premise of Del Sports Inc. The onsite inspection lasted three days (November 17, 18 and 19th). The inspection period covered November 17, 2014 – November 16, 2015. The investigators completed a full inventory of firearms and review of all required records.

During the inspection the President David Budin and (b)(6)were present and interviewed by the investigators. On November 19, 2015 at the conclusion of the onsite inspection the investigators conducted a closing conference with David Budin and (b)(6) at which time the investigator also issued David Budin a Report of Violations.

Business Profile:

The licensee operates a retail shop in the village of Margaretville. The licensee sells firearms and accessories and provides basic gunsmithing services. The premise is owned by David Budin and (b)(6) and therefore no landlord verification was required. Zoning approval was verified by IOI (b)(6) in a past inspection and is documented in the area office file.

During the inspection period the licensee acquired (5)(4) and in the same time frame (5)(4) firearms were disposed of. Approximately (5)(4) of all firearm acquisitions and dispositions were of used firearms. Del Sports Inc.'s conducts 100% of their business activity from their licensed premise, they do not participate in gun shows. The licensee also facilitates transfers of firearms for those individuals who purchase via the internet or who must comply with the New York Safe Act. The licensee acquires firearms from the following wholesalers: (b)(4)

The licensee has the following New York State licenses required for handguns:

Dealers License No. D794, expires 5/31/2018 Gunsmith License No.237, expires 5/31/2018

The current Type-01 Dealer in Firearms Other Than Destructive Devices is the appropriate type to cover the business activities.

Ownership and Control:

The business entity is a corporation owned and operated by David Budin. On 11/12/2015 Investigator (b)(6) verified the corporation remains active by querying New York Division of Corporations website. The corporation operates under Employee Identification Number of (b)(3) 2605C6103.

No other responsible persons / hidden ownership disclosed as a result of this inspection.

IOI(b)(6) ran a Criminal history query of David Budin which resulted in no hits.

Variance:

The investigator found no need for a variance during this inspection. The investigator did however reminded the licensees of their requirement to request and obtain a variance if they had any activity that was not in conformity with the federal firearms regulations

4 - Acquisition & Disposition (A&D) Record - Inventory

Investigators (b)(6) and (b)(6) completed a full comparison of firearms in inventory to Del Sports Inc.'s disposition records (A&D books). The investigators found that the corporation had open entries and 298 firearms in its physical inventory.

IOI (b)(6) cited the licensee for failure in instances to properly account for firearms in their A&D records, per 27 CFR 478.125(e) as follows:

- Licensee failed to record the required acquisition ^{(b)(3)} Pub law 112-55 125 Stat. 552
 received on March 22, 2014 for repair.

During the investigators' first review of the A&D book the disposition entry was open. During the reconciliation by the licensee he believed that the firearm had been reported missing during his 2013 inspection) and recorded that information as the disposition. When the investigators reviewed the 2013 theft/loss report they discovered that the firearm reported was the same Make and model but the serial number was , not a match to the missing firearm. A search of the licensee's ATF 4473s by IOI (b) (6) found an ATF , which was used to sell both Form 4473 numbered and dated found missing during this inspection (serial #) as well o)(3) Pub law 112-55-125 S the licensee had reported as missing during his 2013 inspection as). IOI (b)(6) directed the licensee to correct the entry for (serial # in his A&D record as well as contact ATF to have his the missing 2013 Theft/Loss Report amended. The licensee made the correction to his A&D record and faxed a letter to ATF to have his 2013 Theft/Loss Report amended. (Attachment -Signed ROV Exhibit 1 Copy of ATF Form 4473 dated)

Licensee failed to record the disposition in the required acquisition and disposition book of (b)(3) Pub law 112-55 125 Stat. 552
 Neither the firearm nor any documentation was located during the inspection and the firearm was reported missing to both the local police and ATF via ATF Form 3310.11.
 (Attachment -Signed ROV, Exhibit 4 Copy of 2015 ATF Theft/Loss Report and Worksheet 1)

During the investigators' interview of David Budin he was asked by the investigators about Del Sports Inc.'s standard operating procedures as it relates to their A&D records. David Budin stated to the investigators that he and (b)(6) are the only people that makes entries into their A&D records.

The FFL maintains a separate A&D book for his gunsmith activities, the investigators

reviewed both of the licensee's A&D record books and found that they had been entering all the required information when they did make entries into their A&D records.

5 - ATF Forms 4473 - NICS & Other Dispositions

Del Sports Inc. had completed ATF Forms 4473s during the inspection period. Investigators (b)(6) and (b)(6) reviewed all forms. During the investigators' review of the ATF Form 4473s the investigator found that the licensee files it's ATF Form 4473s chronologically and they maintain a separate file for cancel, voids and denied transactions as required. At the conclusion of the investigators' review the investigators discovered:

- Licensee failed in instances to follow instructions on ATF form 4473 prior to an over the counter firearm transfer to a non-licensee. More specifically on ^{[D](3) PUD law 112-55 125 Stat. 552} dated February 8, 2015 and ^{[D](3) PUD law 112-55 125 Stat. 552} dated March 27, 2015 question 11(a) was answered "yes" indicating the purchaser was not the actual buyer of the firearm. The investigator cited the licensee, per 27 CFR 478.21(a) See Violations #13 below.
 (Exhibit 5 Copy of (b)(3) PUD law 112-55 125 Stat. 552, Attachment Signed ROV & Worksheet 2)
- Licensee in test instance proceeded with a firearm transfer when the purchaser answered "Yes" to prohibiting questions 11b thru 11l on the purchaser, dated February 8, 2015. The investigator cited the licensee, per 27 CFR 478.99(c), see Violations #13 below.

- Licensee failed in instances to obtain a completed ATF F 4473 certifying the transferee is not prohibited from possessing a firearm in or affecting commerce as follows:



IOI (b)(6) cited the licensee, per 27 CFR 478.124 (c)(1), see Violations below. (Exhibit 7 Copy of (b)(3) Pub law 112-55 125 Stat. 552, Attachment Signed ROV & Worksheet 2) Investigator (b)(6) requested and obtained an FFL Audit Report prior to the onsite inspection. The investigator compared the report to the licensee's ATF Form 4473s and found no discrepancies. In total 74 NICS transaction numbers (NTNs) consisting of 60 proceeds, 1 open and 14 Denied transactions were verified by Investigator (b)(6). (Exhibit 8 Copy of FLS Audit Report)

Del Sports maintains certified copies of licenses for dealer to dealer transfers. During the investigators interview with David Budin they reminded him of the proper procedure for transferring a firearm to law enforcement for "official use".

During the investigators' interview of David Budin he was asked by the investigators about Del Sports Inc.'s standard operating procedures as it relates to their ATF Form 4473s. David stated to the investigators that he and his mother try to review the forms each day but often they get too overwhelmed with customers. IOI (b)(6) explained that they needed to ensure the forms are reviewed timely and thoroughly prior to being filed. David stated that they would start a new procedure to ensure at least two people review the form before the firearm is booked out and the form is filed.

6 – <u>Multiple Sales</u>

Per the Violent Crimes Analysis Branch Report the licensee had no report of multiple sales. A review of the licensee's records by Investigators (b)(6) and (b)(6) disclosed that the licensee had no unreported multiple sales.

7 - Suspicious/Prohibited Purchasers

Investigator (b)(6) ran NCIC and eTrace queries on firearm purchasers resulting in and no positive hits.

8 - Trace Activity

The investigator requested a trace report which disclosed the licensee had trace requests during the inspection period. The licensee was able to successfully trace of the request. IOI (b)(6) questioned David Budin why he was unable to complete the remaining traces. The licensee stated that the shop was flooded in 2012 and a large number of his records were destroyed. (Exhibit 9 Copy of Trace Report)

During the period of this inspection the investigator found that the licensee had acquisitions. In the same inspection period the investigator found that the licensee had dispositions.

Investigator (b)(6) completed a query of eight firearms in NCIC which resulted in no hits.

9 - <u>NFA/Importer/Collector/Manufacturer</u>

Licensee does not conduct NFA, importer or collecting activity under this license.

10 - Referrals

The investigator found no information that required a referral to be generated.

11 - <u>Other</u>

During this inspection the investigators found that David Budin had a severe degenerative vision issue. The medical issues causes his vision to be very limited and therefore he depends on (b)(6), to maintain most of his records. During this inspection the investigators observed on numerous occasions David requesting his mother assistance to read documents. From the beginning and throughout the entirety of this inspection, including the closing conference, David Budin's mother was present and involved. (b)(6) provide IOI (b)(6) her New York State Driver's license as proof of her identity (b)(6)

12 - Closing Actions

On November 19, 2015 Investigators (b)(6) and (b)(6) held a closing conference with David Budin. The investigators reviewed the firearms regulations line-byline with the licensee per the Acknowledgement of Federal Firearms Regulations form. At the conclusion of the review David Budin certified receipt by signing the Acknowledgement of Federal Firearms Regulations form. (Exhibit 10 Signed Acknowledgment)

At the conclusion of the review of the Federal Firearms Regulations IOI (b)(6) issued the Report of violations to the licensee. The investigator explained each violation and backup documentation to the licensee at that time. Once all violations were reviewed David Budin signed the ROV as proof of his receipt. (Attachment Signed Report of Violations)

13 - Violations

Licensee's Response

David Budin stated that he had thought he had kept his records up-to-date and accurate.

Corrective Action

Licensee entered the ^{(b)(3)} Pub law 112-55 125 Stat. 552 into his repair A&D book.

Licensee reported the ^{(b)(3)} Pub law 112-55 125 Stat. 552</sup> missing, via ATF inventory theft/loss report form number 3310.11, to ATF and to the Delaware County Sheriff's Department.

Licensee entered disposition information per ATF F 4473 dated August 31, 2012 for the ⁽⁶⁾⁽³⁾ Pub law 112-55 125 Stat. 552 into the acquisition and disposition record.

Further the IOIs reminded the licensee to make timely and accurate entries as required by 27 CFR 125(e) in the acquisition and disposition records on all firearms transactions conducted.


Corrective Action
