



1 - Introduction

Inspection Profile:

On August 26, 2016, ATF Industry Operations Investigator (b)(6) conducted a Southwest Border inspection at the business premises of Dwyte Fray Palmer d.b.a. Buck's Pawn Shop. Investigator (b)(6) interviewed Mr. Gene Lawson, manager. Mr. Lawson identified himself with his Oklahoma driver's license (OKDL: (b)(6). The period covered by this inspection was the previous 12 months for ATF Forms 4473 and the entire firearm inventory. Investigator (b)(6) held the inspection closeout with Mr. Lawson on September 6, 2016. No advance notice was given prior to the inspection and no other Federal/State/local agencies participated in this inspection.

Business Profile:

Dwyte Fray Palmer d.b.a. Buck's Pawn Shop holds a Type 02-Dealer, Including Pawnbroker, in Federal Firearms Other Than Destructive Devices license to buy and sell new and used long guns and handguns. Mr. Lawson described the business as a pawn shop which sells firearms, electronics, and Indian artifacts.

Buck's Pawn Shop acquired^{(b)(4)} firearms^{(b)(4)} handguns and ^{(b)(4)} long guns) and disposed (b)(4) firearms^{(b)(4)} handguns and ^{(b)(4)} long guns) during the previous 12 months.

Mr. Lawson stated ^{(b)(4)} percent of firearms transferred are used. Mr. Lawson stated the primary supplier of firearms are from customers that lost firearms in pawn and from trade-ins.

Mr. Lawson stated they do not sell firearms over the internet.

Mr. Lawson stated Buck's Pawn Shop does not have off-site storage and does not conduct business at gun shows.

Buck's Pawn Shop files their taxes under Mr. Palmer's social security number.

Mr. Lawson stated no other businesses operate on the licensed premises.

The business premises are located in a commercial setting.

The licensee has held its current license since 2003.

A query of the Oklahoma Office of Consumer Credit Commissioner shows that Buck's Pawn Shop holds an active Oklahoma Lending License (5)(5)=25 USC 6103 (Exhibit 1).

Buck's Pawn Shop operates under Oklahoma Sales and Use Tax Permit #STS

Ownership and Control:

Mr. Lawson stated that Buck's Pawn Shop is structured as a sole proprietorship and Mr. Palmer is the sole owner. Based on the statements made by Mr. Lawson, Investigator (b) (6) does not suspect hidden ownership.

Mr. Palmer and Mr. Lawson are the only persons listed as responsible person and based on the statements made by Mr. Lawson, Investigator (b)(6) believes all responsible persons are correctly reflected in FLS.

A query of the Comanche County Assessor records shows the property owner as Dwyte Palmer (**Exhibit 2**).

Investigator (b)(6) did not review any documents or observe any activities and the licensee did not make any statements during the inspection that indicated the possibility of hidden ownership.

4 - Acquisition & Disposition (A&D) Record - Inventory

Investigator (b)(6) conducted a full inventory and found open dispositions and 126 firearms in inventory. There were inventory discrepancies found as a result of the inspection which included firearms that had the incorrect serial number, firearm with a disposition recorded, but the firearm was located in inventory, and firearms did not have the disposition recorded **Report of Violations 5**, Worksheet 1 Inventory, **A&D and Exhibit 3**.

Mr. Lawson advised Investigator (b)(6) at the beginning of the inspection that he had not recorded disposition information from the previous week due to he was on vacation and he is the only one that records the information. Investigator (b)(6) reviewed the forms he handed her and discovered that he had not entered any dispositions since the beginning of July. Mr. Lawson stated he knew that he hadn't entered dispositions in a while, but hadn't realized that he was that far behind.

Investigator (b)(6) compared 25 disposition entries to the corresponding ATF Forms 4473 and found no discrepancies.

The licensee did not complete an ATF Form 3310.11 (theft/loss) during the previous 12 months and did not complete one as a result of this inspection.

The A&D Book is in the proper format and while reviewing the A& D Book, Investigator(b)(6) found no suspicious purchasers, shippers, or licensees.

Investigator(b)(6) discovered no firearms with obliterated serial numbers or unregistered NFA firearms.

Investigator Paulek did not identify any trafficking issues as a result of the A&D Book review.

The licensee has adequate security measures in place. Mr. Lawson stated they have a monitored alarm system, bars on the windows, and the rear door is locked and barred.

5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee had ATF Forms 4473 on file for the inspection period. Investigator (b)(6) reviewed all ATF Forms 4473. Review of the forms resulted in the following violations: form violated 478.21(a), forms violated 478.124(c)(3)(iv). form violated 478.124(c)(1), and form violated 478.124(c)(5) Report of Violations 1-4, Worksheet 2 and Exhibits 4.

6 - Multiple Sales

The VCAB query disclosed multiple handgun sales during the previous 12 months. The investigator discovered no unreported multiple handgun sales during this inspection.

7 - Suspicious/Prohibited Purchasers

Investigator (b)(6) did not discover any suspicious or prohibited purchasers during the inspection.

8 - Trace Activity

Investigator (b)(6) requested an FFL History Report from the Violent Crime Analysis Branch (VCAB) resulting in zero traces in the past 12 months.

This licensee had no firearm traces to Mexico.

9 - NFA/Importer/Collector/Manufacturer

Mr. Lawson stated they do not import, collect, manufacture firearms or deal in NFA firearms.

10 - Referrals

There were no referrals made from information received during this inspection.

11 - Other

This licensee had no Special attention Flags in FLS that would indicate that this FFL was under a current ATF criminal enforcement investigation at the time of the inspection.
