#### 1 - Introduction

#### **Inspection Profile:**

On September 19, 2016, Investigator (IOI) (b)(6) began to conduct a full Compliance Firearms Inspection for B&B Guns & Ammo, Limited Liability Company (LLC). Lance Wade Wolfe, Member, identified by Texas Driver's License (b)(6) was interviewed during the opening conference for the inspection period of September 19, 2015, through September 27, 2016.

Advanced notification was not given for this inspection.

#### **Business Profile:**

The commercial, urban, retail business sells new and used firearms, pawns/redeems firearms, sells ammunition, and transfers firearms for other dealers. Hunting and archery supplies are sold by the business. There is an indoor archery range on the premises. The licensee sells ammunition reloading supplies, but does not manufacture ammunition. There are no other storage locations.

Approximately(b)(4) firearms were acquired and (b)(4) firearms were disposed in the last 12 months. Lance Wolfe estimated that approximately <sup>[D)(4)</sup> percent of the firearms are used and approximately <sup>[D)(4)</sup> percent are pawned transactions.

## The primary suppliers are (b)(4)

(b)(4) dealers, and individuals with no sales made at gun shows during this inspection period; although, a few gun shows were attended prior to the last 12 months and may be again in the future.

The internet website, <u>bnbguns.com</u>, advertises firearms.

There is no other business on the premises, no other business is conducted by the licensee, and no other ATF license is held by the licensee.

This business was in compliance with State and local laws and met all zoning requirements with no off-site storage.

The original ATF license was issued on October 10, 2014. This license replaced the partnership, Lance Wade and (b)(6), 5-75-441-02-8C-04537. Records/license were sent to the Out-of-Business Records Center.

### **Ownership and Control:**

There were no unreported changes to this LLC. The Secretary of State (SOS) lists the business as 'active'.

The application inspection reported (b)(6) was a Member of the LLC; however, only Lance, Jeremy, and Landon Wolfe were listed with the SOS. Lance Wolfe stated he and (b)(6) own<sup>(b)(4)</sup> percent and Jeremy and Landon Wolfe each own<sup>(b)(4)</sup> percent of the LLC. He added he would check the SOS information to be certain it was correct.

B&B Pawn & Trading is listed with the SOS as the Assumed Name until 2024. Mr. Wolfe did not wish to add the tradename to the ATF license.

The Federal Licensing System (FLS) has all information listed correctly.

### Variance:

There is no variance and none was requested.

## 2 - <u>Recommendation</u>

Violations, WL ONLY, and Recall Inspection

The following is a justification in support of an alternate recommendation for a Warning Letter.

SIGNIFICANT FINDINGS

The following violation warrants a Warning Conference:

## 27 CFR 478.124(a)

Failure of the licensee to obtain/execute at least one ATF Form 4473. (*The background investigation of the individual/firearms had no prohibiting factors disclosed.*)

JUSTIFICATIONS FOR ALTERNATE RECOMMENDATION

- 1. This was the licensee's first compliance inspection.
- Lance a(b)(6) Wolfe admitted the two pawned firearms were disposed without executing an ATF Form 4473. Mr. Wolfe called and asked the known customet(b)(6) to bring the firearms back to the store to verify the serial numbers and to complete an ATF Form 4472. The licensees explained the mistake occurred because (b)(6) was in the store and asked to pay the remaining loan on the two pawned firearms. When (b)(6) came to redeem the firearms, the loan was already paid, thus the ATF Form 4473 was forgotten. (b)(6) received a NICS first response of 'proceed'.
- 3. During the inspection the licensee had errors on ATF Forms 4473.
- 4. A check system will be in place to ensure compliance to all regulations.

### 4 - Acquisition & Disposition (A&D) Record - Inventory

A full inventory was conducted and compared to the Acquisition and Disposition (A&D) record. There were <u>959</u> firearms in the inventory, which did not correspond with the open entries in the A&D. (959 not logged out, not logged in, *Displayed in the Inventory* of the Inventory of the Inventory

Every firearm was compared from the physical inventory to the A&D and from the A&D to the physical inventory with discrepancies disclosed. See Section 13.

heft/loss reports were submitted during the inspection period on April 26, 2016, for the firearm which was recovered, and on May 02, 2016, for the firearms. A theft/loss report,  $\binom{(b)(3)-112 \text{ Public Law 55 125 Stat 552}}{(b)(3)-112 \text{ Public Law 55 125 Stat 552}}$  firearms was submitted as a result of this inspection. (Total report loss firearms for the last 12 months.) See Section 13.

The A&D was in the proper format, yet all entries were not timely made. See Section 13.

A sample of approximately disposition entries in the A&D record were verified by comparing them to the corresponding ATF Forms 4473 for each entry. Each entry contained all of the required information; no discrepancies were disclosed.

There were no trafficking issues relating to acquisitions and dispositions of firearms as directed by guidelines and special instructions, but acquisitions and dispositions were timely entered. See Section 13.

No obliterated serial numbers or illegal firearms were discovered.

The licensee explained the standard operating procedures relevant to the A&D and inventory include entries are timely made into the A&D not later than the close of the next business day as required for acquisitions and within seven days as required for dispositions; however, this inspection revealed acquisition/disposition errors. See Section 13.

The licensee stated he performed a total gun to book inventory when the LLC began and again in May 2016 which resulted in a theft/loss report for lost firearms.

### 5 - ATF Forms 4473 - NICS & Other Dispositions

There were chronologically filed ATF Forms 4473 on file for the last 12 months which were all reviewed. Discrepancies were disclosed. See Section 13.

The licensee properly transferred firearms to other licensees. There were no sales to law enforcement officers according to 27 CFR 478.134.

There were <u>94</u> accurately documented NICS transaction numbers reported on the FFL Audit Log which were verified during the examination of the ATF Forms 4473.

ATF Forms 4473 are executed by Lance, (b)(6) Levi Wolfe or a trained employee. The ATF Forms 4473 are not double checked. No templates are used. NICS is contacted for all redemptions and sales unless a Texas Handgun License (HL), License To Carry (LTC), or another Federal Firearm License (FFL) is offered as identification.

There were five separately filed denials for the inspection period. Each denial was organized by purchasers' names/addresses and researched to ensure a straw purchase did not occur.

During the closing conference, IOI (b)(6) strongly suggested the denial folder be readily available in order to compare names/addresses/firearms with future purchases. It was also recommended that a tag be placed on a firearm associated with a denied sale to alert the sales person to check the denial folder.

IOI (b)(6) suggested ATF Forms 4473 for redeemed pawned firearms not be filed separately.

#### 6 – <u>Multiple Sales</u>

There were multiple sales involving firearms reported during the inspection period on the Violent Crime Analysis Branch FFL Mastery Query.

The names of the multiple purchasers shown on the FFL Mastery Query were run through e-Trace to determine if additional multiple purchases were made from other dealers or other traces were associated with those persons. One suspicious purchaser (b)(6) was disclosed. See Referral.

There were unreported multiple sales identified during the inspection involving firearms. The ATF Form 3310.4 was completed and submitted during the inspection. See Section 13.

The licensee had received and understood ATF Forms 3310.12, Report of Multiple Sale or Other Disposition of Certain Rifles for two or more semi-automatic rifles capable of accepting a detachable magazine and with a caliber greater than .22 (including .223/5.56 caliber).

#### 7 - Suspicious/Prohibited Purchasers

A suspicious purchaser(b)(6) was identified during the last 12 months. See Referral.

There were no prohibiting factors disclosed concerning <u>87</u> computerized criminal history checks for persons. There was no open or closed case in NFORCE for the Responsible Persons (RPs) on the license. The names and Social Security numbers were also queried in FLS to ensure the RPs had not been associated with a revoked license.

#### 8 - Trace Activity

There was successful trace reported by the Violent Crime Analysis Branch for the last 12 months. The individual involved in the trace was queried through e-Trace. No noteworthy findings were disclosed; therefore, a Referral was not generated.

There were 25 used firearms traced through the secondary market and disposed by this licensee which were investigated. None were traced, reported as suspect, or reported stolen.

The computerized criminal history checks resulted in no hits for <u>98</u> firearms.

#### 9 - NFA/Importer/Collector/Manufacturer

This licensee holds a Type 02 license and is not an importer, collector, or manufacturer, but is a Special Occupational Taxpayer for NFA weapons.

The NFA records contained all of the required information, were accurate, and were timely recorded. *(There were NFA weapons in the current inventory.)* 

While comparing the licensee's inventory and records with the National Firearm Registration and Transfer Record, **Mathematical Science** iscrepancy was disclosed. The Firearms Inspection Worknote and ATF Form 3 for NFA Inventory Discrepancies were forwarded to the NFA Branch for the correction. **Exhibit 10** 

IOI (b)(6) suggested the licensee file copies of the Forms and ATF Forms 4473 for every NFA weapon in a notebook with plastic sleeves in order to maintain all required information in one location.

## 10 - Referrals

A referral was generated concerning a suspicious purchaser identified as possibly selling without a license.



Included with this Referral were ATF Form 4473, NLETS Report, Licensee's A&D Records, eTrace Lead Reports, and Firearms Trace Summaries.

#### 11 - Other

This licensee was in compliance with the Youth Handgun Safety Act poster and notice, had gun locks available for sale to the public, and was in compliance with age restriction requirements.

IOI(b)(6) asked the licensee if unregulated exploding targets were sold on the premises. They were; therefore, the public safety advisory from the National Explosives Task Force regarding exploding targets was provided for future

### 13 - Violations

### 1. **27 CFR 478.21a**

**Nature of violation:** Failure of the licensee to obtain all information called for on at least ATF Forms 4473 as indicated by the headings on the forms and the instructions on or pertaining to the forms. (Items '11a' and 25)

The background investigations for the individuals/firearms had no prohibiting factors disclosed.

**Licensee's response:** The licensee stated they had not been double checking the ATF Forms 4473, but would establish a system for the future.

**Corrective action:** The licensee was instructed to establish a check system to ensure all ATF Forms 4473 are correct as required.

(Items 1, 2, 11k, 11L, 13, 14,17)

**Corrective action:** The licensee was instructed to establish a check system to ensure all ATF Forms 4473 are correct as required and to be certain all transferees know the correct date.

**Licensee's response:** Lance Wolfe stated he missed seeing the answers to 11L and 12, but he understands he must provide documentation showing the exception for a nonimmigrant visa prohibition.

<u>Corrective action</u>: The licensee was instructed to be certain all aliens admitted to the United States under a Nonimmigrant Visa provide a type of documentation showing the exception to the nonimmigrant visa prohibition.

**Licensee's response:** The licensee stated he had recorded dates of births instead of expiration dates, but he would be more careful in the future.

<u>Corrective action</u>: The licensee was instructed to record all required information correctly on the ATF Forms 4473.

The background investigations for the individuals/firearms had no prohibiting factors disclosed. The purchaser who answered 'yes' to 11c received a NICS first response 'proceed'. The purchaser who answered 'yes' to 11f received a NICS second response 'proceed'.

**Licensee's response:** The licensee stated it was extremely clear how important it is to establish a more stringent check system.

<u>Corrective action</u>: The licensee was instructed to stop the transfer for any nonlicensee answering 'yes' to a prohibiting question on the ATF Form 4473. Worksheet 2, Exhibit 8

**Nature of violation:** Failure of the licensee to timely record at least entries in the A&D. (acquisitions: firearms; dispositions: firearms; missing: firearms) **Licensee's response:** The licensee stated the firearms were not placed in the proper location to record their acquisitions. He will be certain all employees understand incoming firearms must be placed in this location for proper entry into the A&D. The unrecorded dispositions were for a known customer ROV 10). **Corrective action:** The licensee was instructed to record acquisitions/dispositions timely as required by the end of the next business day for acquisitions and not later than seven days for dispositions. The A&D was corrected, and a Theft/Loss Report, was submitted.

#### 10. 27 CFR 478.124(a)

**Licensee's response:** Lance and Pattie Wolfe admitted the firearms were disposed without executing an ATF Form 4473. Although unadvised by IOI (b)(6) Mr. Wolfe called and asked the known customer (b)(6) to bring the firearms back to the store to verify the serial numbers and to complete an ATF Form 4473. The licensees explained the mistake occurred because (b)(6) was in the store and asked to pay the remaining loan on the two pawned firearms. When(b)(6) came to redeem the firearms, the loan was already paid, and the ATF Form 4473 was forgotten. (b)(6) received a NICS first response of 'proceed'.

<u>Corrective action</u>: The licensee was instructed to never transfer a firearm without executing an ATF Form 4473 at the time of the transaction. The A&D was corrected. Worksheet 2
