





1 - Introduction

Inspection Profile:

On September 30, 2015, Industry Operations Investigators (IOI) (b) (6) of the Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF), met in-person with James "Mark" Daniels, President and Responsible Person, at the above-referenced premises. The purpose of the visit was to conduct a Southwest Border Disposition Emphasis compliance inspection of a Type 01, Dealer in Firearms Other Than Destructive Devices Federal Firearms License. The period of inspection covered September 30, 2014 to October 1, 2015. The on-site inspection commenced on September 30, 2015 and was completed on October 6, 2015. The corrections to the A&D book were reviewed on October 6, 2015. No other Federal, State, or local agencies participated in the inspection. No advanced notification was provided prior to the inspection.

Business Profile:

Gary's Guns is in the business of conducting retail sales of new and used handguns and long guns to the general public. Mr. Daniels stated Gary's Guns was the name of the gun shop when they bought it many years ago. Mr. Daniels stated they kept the name. The licensee acquired approximately firearms ((b) (4)) and disposed of approximately(b) (4) firearms ((b) (4) during the inspection period. Specifically, the licensee acquired approximately firearms and disposed of approximately used firearms. The licensee also sells ammunition, reloading supplies, and firearm accessories. Primary suppliers of new firearms are (b) (4) . Secondary market supplies the used firearms. The licensee does not maintain a website. The licensee does not attend gun shows or provide gunsmith services. Mr. Daniels is also Treasurer of the Orange Gun Club and conducts gun club business on the licensed premises.

The licensee does not conduct any other business. There is no other business conducted on the premises. The licensee does not hold any other ATF licenses. The licensee does not hold any other applicable State or local firearms-related licenses. The licensee has held the current firearms license since April 1, 2013. The business premises and storage location are located in an urban commercial area. The property is owned by Mr. Daniels' father, George Daniels (Exhibit 1). There is no lease agreement. There are no off-site storage locations or zoning restrictions.

> The premises are wired with an internal security system. There are two entrances (front) into the building. Each entrance is secured by a metal gate. Only one entrance is being used. There is no gun safe. Long guns are stored in open gun racks. Handguns are stored in gun cases that cannot be locked. IOI (b) (6) recommended Mr. Daniels obtain locks to secure the gun cases and utilize a cable lock to secure the long guns. Records are stored in a file cabinet.

Ownership and Control:

The Gun Shop Inc. is organized as a domestic for profit corporation in the State of Texas where James Daniels is the President, Brenda Daniels is the Director, and George Daniels is the Director (Exhibit 2). They are the only corporate officers. George and Brenda Daniels are the only shareholders (Exhibit 3). Ms. Daniels stated she and George Daniels each have (b)(4) ownership in the corporation. Ms. Daniels stated James Daniels does not have any ownership in the corporation. Ms. Daniels stated she and George Daniels (ex-husband) formed the corporation specifically for the gun shop. Ms. Daniels stated they were married when the formed the corporation, but are now divorced. Ms. Daniels stated George Daniels was not involved in the firearms business. George Daniels currently lives in west Texas. Ms. Daniels stated the ownership of the corporation was not addressed in the divorce decree. Ms. Daniels stated the ownership still remains 50/50 between her and George Daniels. Ms. Daniels stated she will not change the division of ownership. IOI (b) (6) advised Ms. Daniels that George Daniels would have to be added as a responsible person because he owns half the corporation. IOI(b)(6) advised Ms. Daniels to have George Daniels send her two fingerprint cards and two passport photos. IOI(b)(6) then instructed Ms. Daniels to forward the information to the Federal Firearms Licensing Center.

IOI (b) (6) queried George Daniels in NCIC confirming that no prohibiting factors exist.

There have been no unreported changes in ownership and no hidden ownership was suspected. James Daniels conducts all business operations. The responsible persons are not correctly shown. The license registration report received from Federal Licensing System (FLS) lists James Daniels, Brenda Daniels, and (b)(6) as responsible persons. Mr. Daniels stated he does not know (b)(6) $\overline{IOI}(b)(6)$ contacted (b)(6)who stated she has never been a responsible person on a firearms license in Vidor, TX. IOI(b)(6)will advised the licensing center to remove (b) (6) responsible person.

> The licensee maintains an active Texas Sales and Use Tax Permit (Exhibit 4). The Franchise Tax status is active with the Texas Comptroller's Office (Exhibit 5). The Gun Shop Inc. has not registered the assumed name of Gary's Guns with the Texas Secretary of State. The assumed name is no longer active with the Orange County Clerk's Office. IOI (b) (6) instructed Mr. Daniels to register the name with the Texas Secretary of State and county clerk's office. On October 7, 2015, the licensee registered the assumed name with the county clerk's office for a period not to exceed 10 years (Exhibit 6).

The Federal Firearms Licensing Center should note the following update:

1. Change James Daniels' title to President and his phone number to (b)(6)

2. James Daniel's email should be updated to (b)(6)

3. Remove (b)(6) as a Responsible Person.

4. Add EIN

There are no variances maintained and none were requested as a result of this inspection.

2 - Recommendation

The inspection warrants Violations, Warning Conference, Warning Letter and Recall Inspection. However, this was the licensee's first compliance inspection. The licensee was cited for 33 (12.9%) A&D Bound Book and Inventory Violations. IOI (6) recommends Violations, Warning Letter Only and Recall Inspection.

4 - Acquisition & Disposition (A&D) Record - Inventory

There were 174 firearms in the full gun to book inventory at the time of inspection. The open entries. The licensee maintains one A&D book. manual A&D book reflected A review of the A&D book disclosed the following:

disposition of firearms in the record instances involving firearms), which is a violation of 27 CFR 478.125(e) (Violation 6, Exhibit 7, Worksheet 1).

The A&D book is in the proper format, all required information was not accurate and the entries are not timely made. IOI(b)(6) traced firearms from acquisition through disposition by comparing the ATF Form 4473 to the A&D book. No discrepancies were found. There was no discovery of obliterated serial numbers or illegal firearms during the inspection. No trafficking indicators were found. The licensee did not submit a theft or loss report during the inspection period or as a result of this inspection.

Licensee's operating procedure in regards to the A&D book was evaluated. Mr. Daniels is responsible for making gun sales. Mr. Daniels records all acquisition and disposition information into the A&D book. Acquisition and disposition entries are recorded into the A&D book on the same day or following morning firearms are acquired or sold. Gun counts are conducted annually and every month. IOI (b) (6) recommended Mr. Daniels conduct full gun to book inventories at least once a vear.

5 - ATF Forms 4473 - NICS & Other Dispositions
There were ATF Forms 4473 on file for the last 12 months. IOI (b)(6) reviewed all forms. FFL Audit report revealed 15 NICS Transaction Numbers (NTN) within the last 60 days. There were five denials for the last five years. All were accounted for and separated from the proceeds. There were no sales to law enforcement. Transfers to other licensees were documented properly. There were no trafficking issues relating to purchasers of firearms.

There were discrepancies found with completing the ATF Forms 4473. The licensee was cited for the following violations:

27 CFR 478.21(a) - forms (Violation 1, Exhibit 8, Worksheet 2).

27 CFR 478.124(c)(1) – forms (Violation 2, Exhibit 9, Worksheet 2).

forms (Violation 3, Exhibit 10, Worksheet 2). 27 CFR 478.124(c)(3)(i) -

27 CFR 478. 124(c)(3)(iv) – forms (Violation 4, Exhibit 11, Worksheet 2).

27 CFR 478.124(c)(5) - forms (Violation 5, Exhibit 12, Worksheet 2).

Licensee's operating procedure in regards to the ATF Forms 4473 was evaluated. Mr. Daniels executes all forms. Mr. Daniels reviews the form while the customer is present and reviews it again the following day. The form is then permanently filed in the filing cabinet. Forms are filed numerically.

6 - Multiple Sales

The Violent Crime Analysis Branch (VCAB) revealed four reports of multiple handgun sales within the last 12 months. No multiple rifle sales were reported by the VCAB. No unreported multiple handgun or rifle sales were discovered during the inspection period.

7 - Suspicious/Prohibited Purchasers

No suspicious/prohibited purchasers were identified during the inspection. IOI **(b)(6)** conducted background checks on seven individual purchasers with valid Texas Concealed Handgun Licenses or no NICS resolutions. No disabling factors were revealed. No referrals were made.

8 - Trace Activity

The VCAB revealed successful firearm traces to this licensee within the last 12 months. There were no unsuccessful traces. There were used firearms acquired and used firearms disposed of during the inspection period. Secondary market analysis was conducted on 15 used firearms. No discrepancies were found.

9 - NFA/Importer/Collector/Manufacturer

The licensee does not engage in the importing, collecting, or manufacturing of firearms. No NFA firearms are being sold by the licensee.

10 - Referrals

No referrals were generated as a result of this inspection.

11 - Other

The Youth Handgun Safety poster and Federal Firearms License were available for review. A query of FLS revealed an inaccurate list of the responsible persons associated with this license. The license registration report incorrectly lists as a responsible person. (b)(6) will be removed as a responsible person. George Daniels will be added as a responsible person. IOI (b)(6) queried two active responsible persons (James and Brenda Daniels) in NCIC and N-FORCE confirming that no prohibiting factors exist.

12 - Closing Actions

On October 6, 2015, IOI (b)(6) conducted a closing conference with Mr. Daniels (President). The results of the inspection were disclosed. Each item on the Acknowledgement of Federal Firearms Regulations was reviewed and a signed copy was obtained on October 6, 2015 (Exhibit 13).

A review of the report of violations was conducted. IOI(b)(6) provided Mr. Daniels with a signed copy of the report of violations issued for his records. All questions posed by Mr. Daniels were answered and IOI(b)(6) provided a current ATF phone list and business card. Mr. Daniels was instructed to contact IOI(b)(6) or any investigator in the Houston Area Office should questions arise in the future. A signed copy of the Important Notice was obtained from Mr. Daniels (Exhibit 14). Mr. Daniels has not previously attended an ATF seminar.

13 - Violations

1. **27 CFR 478.21(a)**

Nature of Violation:

27 CFR 478.21(a) - Failure to obtain and/or furnish all information required in each ATF Form 4473 as indicated by the headings on the form and the instructions on or pertaining to on forms.



Licensee's Response:

Mr. Daniels stated the errors occurred due to carelessness.

Corrective Action:

In the future, the licensee will ensure the proper completion of ATF Forms 4473 prior to the transfer of a firearm.

2. **27 CFR 478.124(c)(1)**

Nature of Violation:

Failure to obtain a properly completed ATF Form 4473, Section A, prior to making an over-the-counter transfer of a firearm to a non-licensee, who is a resident of the State in which the licensee's premises are located on forms.



Licensee's Response:

Mr. Daniels stated the errors occurred due to carelessness.

Corrective Action:

In the future, the licensee will ensure the proper completion of ATF Forms 4473 prior to the transfer of a firearm.

3. **27 CFR 478.124(c)(3)(i)**

Nature of Violation:

Failure to verify the identity of the transferee and note on the ATF Form 4473 the type of identification used on forms.

In the future, the licensee will ensure the proper completion of ATF Forms 4473 prior to the transfer of a firearm.

Licensee's Response:

Mr. Daniels stated the errors occurred due to carelessness.

Corrective Action:

In the future, the licensee will ensure the proper completion of ATF Forms 4473 prior to the transfer of a firearm.

Licensee's Response:

Mr. Daniels stated the errors occurred due to carelessness.

Corrective Action:

In the future, the licensee will ensure the proper completion of ATF Forms 4473 prior to the transfer of a firearm.

6. **27 CFR 478.125(e)**

Nature of Violation:

Failure to enter into a record each receipt and every disposition of individual firearms in instances. (See Addendum #1)

Licensee's Response:

The licensee will correct all cited errors. IOI(b)(6) verified the corrections on October 6, 2015.
