REVIEW COMMENTS AND RECOMMENDATION

ALTERNATE RECOMMENATION: WARNING LETTER with Recall.

Inspection meets the standard for Warning Conference under the Adverse Action Policy. The licensee was cited for failing to complete/submit reports of multiple handgun sales in the adverse involving infinearms. Section 6.d.7. Additional violations include the failure to timely record disposition information for 5% of entries in the A&D record (WL at 6.c.2); the transfer of a firearm in the time of transfer (i.e., "Yes" to Block 11b) (WL at 6.c.4); the failure to contact NICS where the licensee accepted of a non qualifying State permit (FL CCW) (WL at 6.c.9); and general Form 4473 violations not rising to the level of adverse action.

JUSTIFICATION FOR ALTERNATE: This is the licensee's first inspection since obtaining a FFL in 1979. The licensee does not "sell" handguns – rather it transfers handguns as an in-state transfer dealer. The licensee acquires/disposes 500 firearms annually and had 510 forms on file. It successfully completed firearms traces in the previous 12 months. Firearms sold are primarily sporting rifles and shotguns. The licensee was receptive to the correct ve action and showed a strong interest in staying compliant.



1 - Introduction

Inspection Profile:

From 10/27 to 10/29/15 ATF IO Investigator (b) (6) conducted a compliance inspection at the licensed premises of Bluestem Farm & Ranch Supply, Inc. ("licensee"). Advanced notification of the inspection was not provided.

The primary contacts during the inspection were Vice President/Responsible Person – Ann BRUNER (Identified by KS DL #(b)(6)) and Store Manager – Bruce BURENHEIDE (Identified by KS DL (b)(6)).

Queries of N-Force conducted on 10/26/15 disclosed no ATF investigations, open or closed, involving Ann BRUNER. The licensee was the subject of an ATF investigation (779015-07-0179), involving the burglary theft of firearms on 7/3/07 (F20070001654). The case is closed and was not federally prosecuted (Exhibit #1).

Special instructions accompanying the inspection assignment were "Conduct DE-Compliance inspection in FY 2016. Licensee has never been inspected and averages over 1,000 dispositions annually. Licensee self-reported a possible straw purchase for 8/10/2015 to duty IOI (b) (6) - referral generated."

The scope of the inspection was one year, from 10/28/2014 to 10/27/2015.


Business Profile:

The licensee operates a retail Hardware and Farm supply business from a storefront building within the city limits of Emporia, KS. They are affiliated with the Ace Hardware franchise. They do not currently store any firearms away from the licensed premises.

The licensee has held this Type 01 License since 1979 and it appears to be the correct type of license for the business being conducted. The licensee does not hold any other ATF Licenses or permits.

The licensee sells both new and used long guns and with the primary focus on hunting type shotguns and rifles. They do not sell handguns. They also serve as an "internet transfer" dealer charging \$20 a transaction. Approximate source

The licensee stated they do not accept firearms on consignment or pawn firearms. They do accept shotguns and rifles on trade, which accounts for their used inventory.

The licensee stated they did not attend any gunshows during the inspection period. They were the transfer dealer at the annual Emporia National Wild Turkey Federation Banquet held on 6/6/15

The licensee does not engage in gunsmithing activities. They do sell firearm ammunition.

The licensee is a factory direct dealer with (b) (4). The licensee's primary wholesale suppliers of new firearms are Davidsons and the JSC Family of licensees.

During the last 12 months, the licensee has acquired ^{(b)(2)} and transferred approximately ^{(b)(2)} firearms.

Ownership and Control:

The licensee is a corporation formed in Kansas in 1965. It is currently in good standing with the state (Exhibit #2).

Ann BRUNER currently owns^{(b)(4)} of the corporate stock. Her husband and President of the company Kenneth BRUNER owns the remaining^{(b)(4)}. Both are actively involved in the day to day operations of the business.

Bruce BURENHEIDE is responsible for purchasing the licensee's firearms and is the primary firearms record keeper.

It was suggested the licensee add both Kenneth BRUNER and Bruce BURENHEIDE as Responsible People on the license. They were provided instructions and the necessary documents to do this at the closing conference on 11/13/15.

Criminal history queries of Ann and Kenneth BRUNER and Bruce BURENHEIDE on 11/6/15 did not disclose any prohibiting information.

No signs of hidden ownership were disclosed.

3 - Inspection History

This was the licensee's first compliance inspection.

The license was issued in 1979.

4 - Acquisition & Disposition (A&D) Record – Inventory

The licensee maintains a hand written A & D Record. The record meets the formatting requirements of 27 CFR 478.125(e) and dates back beyond the required 20 year retention period.

With the assistance of Store Employee -(b)(6), a complete physical inventory of all firearms was taken. A total of 388 firearms were inventoried.

The licensee's A & D Record was compared to the physical inventory and the following discrepancies were disclosed (Worksheet #1):

- 1. firearms did not have disposition entries in the Record, but were not in inventory. Further investigation disclosed none had been transferred in the last seven (7) days.
- 2. **Example 1** firearms were in inventory without having an acquisition entry in the Record

The A & D Record was only examined for the required 20 year retention period (i.e. acquisitions from 10/28/95 to 10/27/2015).

A violation of 27 CFR 478.125(e) was cited on ATF Form 5030.5 (Violation #1). The licensee subsequently determined the disposition for solution of the missing firearms and the correcting entries were made in the Record. A disposition could not be determined for the missing firearms and they were reported missing on ATF F 3310.11 on 11/19/15

The licensee was reminded of the requirements prescribed by 27 CFR 478.125a and Industry Circular 72-30 related to personal firearms on the premises.

All firearms examined were properly identified according to 27 CFR 478.92 standards. No firearms with obliterated serial numbers or illegal firearms were examined.

The licensee did not file any Theft/Loss Reports during the inspection period. No evidence of any unreported thefts or losses was discovered.

STANDARD OPERATING PROCEDURES:

The licensee stated they take periodic inventories of all firearms. This inventory is compared to a computerized inventory report and not to the A & D Record.

The licensee stated that firearms are removed from all packaging and examined for serial number accuracy upon receipt.

All firearms on display are kept in locked gun cabinets. All back-stock firearms are kept in locked metal cages.

The licensee has an extensive alarm and security system.

5 - ATF Forms 4473 - NICS & Other Dispositions

The licensee files their ATF Forms 4473 chronologically by transaction serial number. They have forms on file beyond the required 20 year retention period.

The licensee had on file 510 ATF Forms 4473 for the inspection period. A review of the forms resulted in the following violations being cited on ATF F 5030.5:

<u>27 CFR 478.99(c)(1)</u> - Transfer of a firearm to an individual while having reasonable cause to believe the individual was prohibited from receiving the firearm. (b)(3) 112 Public Law 55 125 STAT 552

- <u>27 CFR 478.21(a)</u> Failure to follow the instructions pertaining to ATF Form 4473. Questions #31 and #32 were not properly completed on forms examined during the inspection (Violation #7; Worksheet #2; Exhibits #3, 5, 7, 8 and 11).

The licensee makes occasional sales/transfers to other FFLs. These transfers were made in accordance with 27 CFR 478.94.

The licensee did not transfer any firearms to Law Enforcement Officers under the provisions of 27 CFR 478.134 during the inspection period.

An FFL Audit Log was obtained from the FBI covering the non-denied status date range of 8/20/15 to 10/19/15 (Exhibit #9). During the period, the licensee conducted 48 NICS checks. A comparison of the log to the licensee's forms did not disclose any violations.

The licensee also had six (6) NICS denials during the inspection period. They are filing their NICS denials and other ATF Forms 4473, where the firearm is not transferred, separate from their other forms as required by 27 CFR 478.129(b).

STANDARD OPERATING PROCEDURES:

There were no prescribed internal controls in place to ensure the ATF Form 4473 was properly completed prior to transferring a firearm.

The licensee conducts their NICS checks by both the telephone and via the internet.

6 - Multiple Sales

Prior to the inspection, a Firearm Trace History Report was obtained from The ATF Violent Crimes Analysis Branch (Exhibit #10). The Report showed the licensee filed nine (9) Multiple Handgun Sale Reports (ATF 3310.4) during the inspection period.

The inspection disclosed an additional occasions where the licensee transferred handguns to an individual in a single transaction and failed to file a Multiple Handgun Sale Report (Worksheet #2; Exhibit #11).

A violation of 27 CFR 478.126a was cited on ATF Form 5030.5 (Violation #6). The licensee submitted all the required reports prior to the closing conference.

7 - Suspicious/Prohibited Purchasers

Of the **MICS** denials that occurred during the inspection period (**Exhibit #9**), **Solution** of the firearms were still in the licensee's inventory, and **Mittener** of the firearms were transferred to individuals sharing no common characteristics (e.g. last name, address) with the denied individual. The remaining firearm related to a denied transaction was transferred on 8/13/15 to a potential straw purchaser. The licensee determined a straw purchase may have occurred and contacted ATF on 8/18/15 to report the transaction. A Referral of Information was prepared by ATF IO Investigator **(b)(6)** and forwarded to The ATF Kansas City Field Intelligence Group (**Exhibit** #12). IOI(**b)(6)** confirmed the group is investigating the referral on 11/23/15 (**b)(6)**.

The licensee had a "Don't Lie for the Other Guy" poster on display near their firearm cabinets.

8 - Trace Activity

Prior to the inspection, a Firearm Trace History Report was obtained from The ATF Violent Crimes Analysis Branch (Exhibit #10). The Report showed the licensee successfully provided all required information on the firearm traces which they were contacted about during the inspection period.

The licensee did not engage in NFA, Importer, Collector or Manufacturing activities during the inspection period.

10 - <u>Referrals</u>

No referrals were prepared.

11 - Other

The licensee does not sell exploding targets. They were provided a copy of The National Explosives Task Force – Public Service Advisory, dated 5/29/15.

The licensee had the required written notification to purchasers of handguns sign (ATF I 5300.1) on display. They were reminded to provide the required written notification (ATF I 5300.2) to recipients of handguns.

12 - Closing Actions

A closing conference was held with Ann BRUNER and Bruce BURENHEIDE on 11/13/15. The attached ATF Form 5030.5 was issued and the violations discussed.

Applicable regulations were discussed with the licensee and the licensee signed an Acknowledgement of Regulations at the conclusion of the inspection (Exhibit #14).

Failure to maintain an accurate Firearms Acquisition and Disposition Record. The inspection disclosed in firearms in the Record that did not have a disposition entry and were not in inventory and interest firearms that were in inventory that did not have an acquisition entry in the Record.

Licensee's Response:

The licensee stated they planned to take more inventories and review their Record more often to ensure their inventory is accurately reflected in the Record

Corrective Action:

Determine dispositions of missing firearms and make correcting entries in the record. If dispositions cannot be determined, report firearms missing on ATF F 3310.11. Establish internal controls to ensure Record is maintained timely and accurately.

Nature of Violation:

Failure to contact NICS prior to the transfer of a firearm. On 10/3/15, the licensee accepted a Concealed Carry License issued by the State of Florida as an exempted alternative to NICS. Only valid permits issued from the state where the transfer is to take place are qualified exemptions to NICS.

Licensee's Response:

The licensee stated that they mistakenly thought that since the Florida conceal carry permit was recognized in Kansas that it was a suitable alternative to conducting a NICS check.

Corrective Action:

Accept only valid Conceal Carry Permits issued by Kansas as exempted alternatives to contacting NICS.

Failure to properly identify an individual on ATF Form 4473 prior to transferring them a firearm. On ATF Forms 4473 examined, the licensee failed to record any identification information in Item #20a of the Form and on forms examined the licensee failed to record proper alternate documentation in Item #20b of the Form when the transferee's driver's license did not show their current residence address.

Licensee's Response:

The licensee stated they knew that the driver's license or conceal carry license information needed to be recorded in Item #20 even if the conceal carry license was recorded in Item #23. The fact that the information was not recorded on the forms and supplemental information was not obtained was a training issue with some of their associates.

Corrective Action:

Ensure the identity of the firearm transferee is verified and the type of identification used is noted in Item #20a of ATF Form 4473. If the identification document does not show the transferee's current residence address, examine and document in Item #20b of the Form the alternative government identification (as defined in 27 CFR 478.11) provided to confirm their current residence address.

The licensee did not know how this was missed, but said they will double-check all forms before filing to ensure the Multiple Sale Report is submitted if required.

Corrective Action:

Establish internal controls to ensure ATF Form 3310.4 is completed and submitted when required. All missing forms were completed and submitted before the closing conference was held with the licensee.

Establish internal controls to ensure Questions #31 and #32 are properly completed on each ATF Form 4473. Complete Items #31 and #32 on the forms examined.
