1 - Introduction

Inspection Profile:

On 01/03/17, IOI (b)(6) initiated a compliance inspection being conducted of Federal Firearms Licensee (FFL) The Gun Shop LLC which has possessed an FFL type 07 – Manufacturer of Firearms since 2013. Inspection was concluded on 03/20/17 with a closing conference. The inspection period was from 01/03/16 to 01/03/17. Identified and interviewed throughout this inspection and during the closing conference was LLC member and responsible person Todd Ogren, and Office Manager (b)(6), who is the main record keeper.

Business Profile:

This licensed firearms business is a commercial retail storefront that sells new and used long guns and handguns, ammunition and firearm accessories. They also offer gunsmithing, internet transfers and special order services. The licensee also attends gun shows within the state. The licensee will occasionally manufacture (custom AR assembly) firearms for customer order, and also to put out for display firearms they have assembled for sale.

In addition to firearms for sale, the licensee is a Special Occupational Taxpayer (SOT) which offers a variety of suppressors and NFA items for sale.

Ownership and Control:

There has been no change to ownership or control of this business to report.

Variance:

There are no variances associated with this FFL.

2 - Recommendation

“Violations, warning conference with warning letter, and recall inspection”.

3 - Inspection History

There is no previous compliance inspection history.

A complete physical inventory was conducted of all firearms on the business premises. There were 499 firearms in inventory, and there were (b)(3)-(b)(7) open entries in the A&D record, with (b)(3) discrepancies discovered. These violations are noted below and on the attached Report of Violations.

There were approximately (b)(4) acquisitions and dispositions during the inspection period, which would have included gunsmithing firearms.

5 - ATF Forms 4473 – NICS & Other Dispositions

The licensee had approximately (b)(3)-(b)(7) completed Forms 4473 on file for the inspection period. All forms on file were examined for errors and omissions. There were (b)(3)-(b)(7) forms that were discovered to have errors or omissions. These violations are noted below and on the attached Report of Violations.

A check of a sample of NICS transaction numbers (NTN) was made using a current FFL Audit Report, with no discrepancies found.

Forms 4473 with a “denied” or “cancelled” status are being properly retained.

6 – Multiple Sales

The licensee reported (b)(3) multiple sales ((b)(3) firearms) during the inspection period. There were (b)(3) transactions ((b)(3) firearms) discovered during inspection that were not reported to the ATF Tracing Center on F3310.4 - Report of Multiple Sale or other Disposition of Pistols or Revolvers. These violations are noted below and on the attached Report of Violations.

7 – Suspicious/Prohibited Purchasers

There were no suspicious or prohibited purchasers discovered during inspection.

8 – Trace Activity

There were (b)(3) firearm traces associated with the licensee during the inspection period. These traces had been completed by ATF Tracing Center to a purchaser using the records of the licensee. There were no unresolved traces associated with this licensee.

9 - NFA/Importer/Collector/Manufacturer

The licensee is a Special Occupational Taxpayer (SOT) at the (b)(3) - 26 USC 6103

are (b)(3) NFA firearms associated with this licensee. No discrepancies were discovered during inspection.

The licensee possesses an FFL type 07 – manufacturer of firearms other than destructive devices, and occasionally builds (assembles) an AR per customer request or for purposes of display for sale on the business premises. A firearm built for display and sale at the shop was discovered in inventory. This firearm did not have the required manufacturing markings: name, city, and state etched or stamped into the firearm. This violation is noted below and on the attached Report of Violations. The licensee is compliant and has submitted all AFMER ATF F 5300.11 to ATF for every year since the issuance of their FFL.

10 - Referrals

A referral was made to the (b)(6), Chief, Department of State, because the licensee appears to fall under the requirement to register with ITAR as a “manufacturer of firearms other than destructive devices”. See the attached referral.

11 - Other

Nothing to report.

12 - Closing Actions

On 03/20/17 a Report of Violations was issued, and along with the “Acknowledgement of Federal Firearms Regulations” checklist, both were reviewed with Responsible Person Todd Ogren and Office Manager (b)(6). Special attention was given to:

- Form 4473 errors and omissions.
- A&D record errors and omissions.
- Manufacturing of firearms: manufacturing recordkeeping, the markings requirements, and availability marking variances online.

Discussion about the use of the practice of double checking for errors and omissions with a second person was important in reducing these discrepancies. All other questions posed by the licensee pertaining to the firearms business recordkeeping and conduct of business were answered. Milwaukee II Field Office contact information was also provided at this time.

Response: The licensee did not know why or how these violations occurred. There was no system of double checking to ensure these sales were reported as required.

Corrective action: The licensee will complete and transmit the missing forms to the ATF Tracing Center as required, and ensure all such future firearms transactions are properly reported using F3310.4.

7. 27CFR478.123(a) Records - In [REDACTED] instances the licensee failed to record or to record correctly required information in the ACQUISITION & DISPOSITION RECORD as required for a type 07 licensee.

Response: Responsible person Todd Ogren noted that earlier in 2016, there was a switch to a computerized system from a hardcopy A&D record that integrated inventory, sales order, A&D record system. He noted that there may have been insufficient training and oversight in the initiation of this new system which resulted in many errors and omissions as discovered during inspection.

Corrective action: Licensee will correct the discovered errors and omissions. The licensee shall ensure the A&D record is complete and accurate when firearms are received and after they are transferred.
