1 - Introduction

Inspection Profile:

On May 8, 2017, Industry Operations Investigators (IOI's) (b)(6) and (b)(6) conducted a recall inspection on the business premises of Mock and Sons Enterprises Inc. d/b/a Ron's Guns. The inspection period was from May 8, 2016 to May 8, 2017. Mr. Ronald Leon Mock, Co-Owner/President (Louisiana Driver's License # (b)(6) Expiration Date: 12/14/18), and Mr. Eugene Arnold Mock, Co-Owner/Treasurer (Louisiana Driver's License # (b)(6) Expiration Date: 7/2/22), were positively identified by their valid Louisiana Driver's License, interviewed, and assisted during the inspection. Advanced notification was not given.

Business Profile:

Mock and Sons Enterprises Inc. d/b/a Ron's Guns operates as a pawnbroker selling retail new and used handguns and long guns. The business premises are located at 2917 Old Minden Road, Suite C in an urban/commercial area just south of I-20 in Bossier City, LA. During the past twelve (12) months, the licensee acquired (b)(3) - 112 Public Law 55 125 Stat 552 firearms and disposed of approximately (b)(3) - 112 Public Law 55 125 Stat 552 firearms. New guns are acquired primarily through (b)(3) - 112 Public Law 55 125 Stat 552. Mock & Sons Enterprises Inc. has approximately (b)(3) - 112 Public Law 55 125 Stat 552 percent handguns and (b)(3) - 112 Public Law 55 125 Stat 552 long guns. The licensee does not conduct business at gun shows. The licensee does not conduct internet sales however, the business has a website www.rons-guns.com. The licensee is in compliance with, and has all necessary state, local licenses and zoning requirements. The licensee has held an FFL since June 3, 2003. The licensee has no off-site storage.

Ownership and Control:

According to the Louisiana Secretary of State website, Mock & Sons Enterprises Inc. is in good standings and listed as active. Mr. Ronald Leon Mock and Eugene Arnold Mock are both listed as Officers of the corporation. Mr. Ronald Mock and Mr. Eugene Mock are the only responsible persons listed in FLS. There has been no changes in ownership or control of the business and hidden ownership is not suspected.

4 - Acquisition & Disposition (A&D) Record - Inventory

The Acquisition and Disposition (A&D) record contained (b)(3) - 112 Public Law 55 125 Stat 552 open dispositions. The physical inventory revealed nineteen hundred and seventy-six (1,976) firearms. The rest of the bound record contained all required information and was being maintained in the proper format. Entries appear to be made in a timely manner. There were no theft or losses to report during the inspection period or as a result of this inspection. No illegal firearms, or firearms with obliterated serial numbers, were discovered. No trafficking indicators were disclosed during the inspection. The licensee has five employees who are responsible for making entries into the A&D Record, which is entered upon receipt per the licensee's standard operating procedures. **See Worksheet #1.**

5 - ATF Forms 4473 – NICS & Other Dispositions

There were (b)(3) - 112 Public Law 55 125 Stat 552 ATF Forms 4473 on file for the past twelve (12) months. There were (b)(3) - 112 Public Law 55 125 Stat 552 denied forms on file for the past twelve (12) months. Transfers to other licensees were being conducted properly. There were no sales to law enforcement officers. The FFL Audit Log contained three hundred and thirty-eight (338) NICS Transaction Numbers, which were confirmed for accuracy. A review of (b)(3) - 112 Public Law 55 125 Stat 552 forms on file revealed five (5) violations. **See Section 13 Violations, Report of Violations #1-5, Exhibits #1-15, and Worksheet #2.**

6 - Multiple Sales

According to the Violent Crime Analysis Branch (VCAB), there were (b)(3) - 112 Public Law 55 125 Stat 552 multiple handgun sales reports completed involving (b)(3) - 112 Public Law 55 125 Stat 552 handguns during the inspection period. There were no unreported multiple sales discovered during the inspection.

7 - Suspicious/Prohibited Purchasers

The Licensee conducted a transfer to an individual who answered "yes" on ATF Form 4473 questions 11b through 11f. The licensee also transferred a firearm to an individual with a Louisiana Concealed Carry Permit that was issued before March 9, 2015. A

8 - Trace Activity

According to the Violent Crime Analysis Branch (VCAB) report for Mock & Sons Enterprises Inc., there were (b)(3)- 112 Public Law 55-125 Stat 552 successful traces associated with the licensee in the past twelve (12) months. There were no unsuccessful traces. A secondary market analysis of sixty-eight (68) firearms was conducted resulting in zero (0) hits in Open Fox and E-Trace.

10 - Referrals

No referrals were generated as a result of this inspection

11 - Other

Mock and Sons Enterprises Inc. did have an ATF I 5300.1 displayed in the business informing customers of youth handgun safety. Youth Handgun Safety Act Notice, ATF I 5300.2 was provided for all handgun sales.

Secure gun storage and safety devices were available to customers and all firearms in inventory were in a secure location at all times.

IOI (b)(6) conducted a NCIC check in Open Fox on the Responsible Persons with no prohibiting information being disclosed.

12 - Closing Actions

A closing conference was held with Mr. Ronald Leon Mock, Co-Owner/President and Mr. Eugene Arnold Mock, Co-Owner/Treasurer, on May 16, 2017. The firearms regulations were thoroughly reviewed utilizing the Acknowledgement of Federal Firearms Regulations (**Exhibit #16**). (b)(6) also went thoroughly through the Report of Violations (ROV) with Mr. Ronald Mock and Eugene Mock explaining the violations and corrective actions. Investigator (b)(6) also reminded the licensee that whenever a firearm is transferred after a "Delayed" response from NICS, the licensee is required to wait three (3) business days and mark the "No resolution was provided within 3 business days" box and have the transferee sign and date Section C of the ATF Form 4473.
