1 - Introduction

Inspection Profile:

On March 1, 2016 Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator (IOI) (b)(6) began a compliance inspection on federal firearms licensee (FFL) Gemco Coins & Jewelry, LLC doing business as (dba) Gemco Coins Jewelry & Pawn. The inspection period covered March 1, 2015 through March 1, 2016. The inspection dates were March 1 through March 8, 2016. IOI (b)(6) interviewed Greg Martin, Owner, whose identity was verified via State of Ohio driver's license. No advanced notification was provided. No other agencies collaborated on this inspection. Assisting with this inspection at times were IOI(b)(6)

This inspection was conducted concurrently with an inspection on Gemco Coins & Jewelry, LLC's Type 06 Manufacturer of Ammunition license. Reference Unique Identifier (UI) # 773015-2016-0316 for further information regarding that inspection.

Note that FFL is a client of FFL Guard. Reference Section 11 (Other) of this report for further information.

Business Profile:

Gemco Coins & Jewelry, LLC operates primarily as a firearms store as well as a pawn shop. The store sells new and used firearms; and pawns and redeems firearms as well. Primary suppliers for firearms are (b)(4) (b)(4), and the general public. At the time of the inspection 613 firearms were in inventory (30% long guns, 70% handguns). Approximately 43% of inventory were used firearms. Over the course of the past twelve months Gemco Coins & Jewelry, LLC acquired (b)(4) firearms and disposed (b)(4) firearms (approximately^{(b)(4)} handguns,^{(b)(4)} long guns). Approximately^{(b)(4)} of all transactions are pawn redemptions with the rest as retail sales. Licensee has held FFL since 2013. Firearms are also sold through the Gunbroker website; these transactions consist (b)(4) of all total sales. No sales are made at gun shows. The licensee holds the appropriate State of Ohio vendor's license for the reporting of sales tax and the appropriate State of Ohio pawnbroker's license (PB.100636.000). Premises is located in Prairie Township, Franklin County, Ohio. According to Dana Scott, Prairie Township Zoning Clerk, the premises is located in a commercial area and has no zoning

ordinances. There is no off-site storage.

Ownership and Control:

The business entity is listed as a limited liability company (LLC) and is active in the State of Ohio. The Federal Licensing System (FLS) currently exhibits the FFL as a corporation: Gemco Coins & Jewelry, Inc. This is incorrect; FLS should be updated to reflect actual business entity. Greg Martin is the owner and sole responsible person. IOI (b)(6) detected no signs of hidden ownership.

Variance:

Licensee holds no variances and requested none.

2 - <u>Recommendation</u>

Recommend warning conference with recall inspection. IOI (b)(6) disclosed 10 violations, including instances of not filing multiple handgun sale reports timely or at all, and in instances of transferring firearms after the National Instant Criminal Background Check System (NICS) transaction number (NTN) had expired. With regard to the second violation, some of these NTNs had been expired for nearly a year. These were due to FFL conducting NICS pre-checks on pawns and not conducting a new NICS check upon redemption.

Due to extensive violations, $IOI_{(b)(6)}^{(b)(6)}$ recommends warning conference to ensure future compliance.

3 - Inspection History

4 - Acquisition & Disposition (A&D) Record - Inventory

A&D record is in bound book format with four (4) books currently maintained. Open dispositions totaled entries. A full inventory was conducted of 613 firearms with discrepancies. Inventory disclosed that firearms were in inventory and were either not entered into A&D record or were erroneously disposed. An additional firearm was not logged out prior to inspection, but was reconciled with the pawn ticket.

While reviewing A&D record, (b)(6) disclosed entries in the book that had

According to Martin, all firearms are logged in and out at the same day as the acquisition or disposition. Inventories were conducted once a year, however, Martin has stepped that up to every three (3) months.

There have been with traces for this FFL since previous inspection through February 20, 2016 with the past 12 months. Though no thefts/losses have been reported in the past 12 months, firearm was reported stolen prior to that date. Further, a firearm was reported as missing inventory to ATF the day IOI(b)(6) arrived.

IOIs reviewed all ATF Forms 4473 on hand within the past 12 months forms total). Out of the forms reviewed, IOI (b)(6) disclosed orms with errors. These violations included:

- Not ensuring form is completed as prescribed by regulation;
- Not ensuring transferee fills out form completely/accurately in Section A;
- Not properly acquiring/recording identification document (ID) information in Section B of form;
- Not completely/accurately recording National Instant Criminal Background

Check System (NICS) information in Section B of form;

- Not recording firearm information in Section D of form;
- Not accurately certifying firearm transfer in Section D of form.

Greg Martin disclosed the store uses NICS pre-checks for pawns. During ATF Form 4473 review, IOIs disclosed that Martin only ran the initial pre-check and did not conduct another NICS check when the firearm was redeemed. IOIs only cited for those forms where the NICS check was expired when the transfer occurred (over 30 days). IOI (b)(6) carefully instructed Martin on proper procedure for conducting NICS pre-checks; that all redemptions require another NICS check regardless of when the initial check was conducted. Martin disclosed he would halt using the NICS pre-checks unless an individual was concerned about failing the check. Further, IOI (b)(6) disclosed that if an individual who failed a NICS pre-check for a pawn, the FFL was required to report this information to the local law enforcement agency. Martin reported any denials for NICS pre-checks to the Franklin County Sheriff shortly thereafter.

A NICS audit log check disclosed 297 NICS responses for this FFL within the scope of this inspection (19 denied, 264 proceed, 14 delayed/open) with discrepancy; a form where a NICS check was conducted but not retained was found.

Martin disclosed that the store, since January 2016, has had a second person review forms and then he reviews the weeks' worth of forms prior to filing. Forms are filed by month (chronological).

IOI (b)(6) also reminded Martin of requirements for transfers to Armed Forces members; to ensure only those stationed in Ohio with Permanent Change of Station (PCS) orders and a valid military ID could be transferred a firearm. Further, IOI (b)(6) exhibited the entry on the ATF Form 4473 regarding having the form filled out on behalf of a non-licensee if they cannot read or write.



7 - Suspicious/Prohibited Purchasers

Though FFL is not on the Ohio LEADS program, Marin disclosed that all used guns' invoices are sent to the Franklin County Sheriff to ensure if firearms are stolen. IOIB (b)(6) did not run firearms through National Crime Information Center (NCIC) via OpenFox, but several secondary market firearms were run in E-Trace to determine if traces needed updated. IOI(b)(6) also ran all firearms involved Gun Envy, LLC or Great Machine, LLC in E-Trace in addition to those found in worknotes. Through this, IOI(b)(6) identified two (2) firearms in E-Trace that required notification to the National Tracing Center (NTC):

Gemco Coins & Jewelry, LLC holds a Class 03 SOT to deal in National Firearms Act (NFA) weapons. NFA Branch disclosed NFA firearms in FFL's inventory via National Firearm Registration and Transfer Record (NFRTR). Licensee maintains a separate A&D book for NFA; there open dispositions in A&D record. A full inventory was conducted and 15 NFA weapons were in inventory (all silencers). There was (b)(3)-26 USC 6105 in inventory but not on NFRTR; ATF Form 4 was approved.

Gemco Coins & Jewelry, LLC does not manufacture, import or collect firearms.

Federal firearms license posted at premises. Licensee was reminded to ensure Youth Handgun Safety Poster was also posted and notices are on hand for distribution. IOI Byrd also discussed using the "SKU" number on firearms versus using the actual model and ensure the latter is written in the A&D record.

IOI^{(b)(6)} queried N-Force and notified Columbus I Field Office prior to initiation of compliance inspection, no active or pending ATF CE inquiries or investigations.

is or was suspected on Martin or his FFL.

According to Martin, Grimes offered to use the Type 06 FFL to manufacture ammunition at his location at 5050 Nike Drive, Suites A&B, Hilliard, Ohio 43026 under his company Great Machine, LLC. This never came to fruition.

IOI (b)(6) attempted this inspection first on March 1, 2016. At this time, IOI (b)(6) reviewed A&D record and interviewed Martin about some preliminary inspection items. IOI (b)(6) began to question Martin about Eric Grimes, during which a voice came from the speaker phone in the office stating that they wished to "get an attorney on the line." IOI (b)(6) asked who was on the phone, Martin stated "FFL Guard." IOI (b)(6) asked if FFL Guard had been on the line the entire conversation, Martin disclosed it had "just been for the last few minutes as we talked about this." At no point had Martin disclosed FFL Guard was on the phone. At this point, IOI (b)(6) disclosed he would return tomorrow and left the premises, contacting Cincinnati II Area Supervisor (AS) (b)(6) later that day to apologize; he disclosed he had not meant to "ambush" IOI (b)(6). At this time, IOI (b)(6) disclosed to Martin that FFL Guard's presence was entirely the FFL's call, however, knowledge of their presence should be made aware to ATF when onsite. IOI (b)(6) returned the following day with IOI (b)(6), (b)(7)(C)

Once again, FFL Guard was

on the phone but this was made aware prior to the call being made. No issues arose.

12 - Closing Actions

IOI^{(b)(6)} held closing conference on March 25, 2016 with Greg Martin. Martin had FFL Guard on the phone as IOI^{(b)(6)} went through the violations. Martin signed and
