

On June 30, 2016 Industry Operations Investigator (IOI)(b)(6) traveled to 3420 US 601, Concord, NC 28025 to conduct a disposition emphasis investigation on Ideal Sportsman, Inc. The period covered was June 30, 2015 through June 30, 2016. The investigation commenced June 30, 2016 and concluded on July 15, 2016.

No prohibiting factors were disclosed. Violations were cited see paragraphs 5, 6, 9 and 13, ROV and applicable worksheets.

The business is a firearms retailer who sells firearms, both GCA and NFA as well as accessories. There are a small number of used guns sold the percentage is (b)(4) new and (b)(4) used.

Gunsmithing is also performed on premises. The Licensee is in the process of constructing additional space in the office for the gunsmith and additional offices for the President and Vice-President. The Licensee disposed (b)(4) firearms in the investigation period and acquired (b)(4) firearms in the same period. The Licensee is under (b)(3) - 112 Public Law 55 125 Stat 552 were reviewed.

## 4 - Acquisition & Disposition (A&D) Record - Inventory

A full inventory was conducted, and a printed firearms in stock list was checked against a printout of the active A&D record for the investigation period. There were 444 firearms in inventory which includes: 185 handguns, 175 long guns, 24 receivers and 60 suppressors. No discrepancies were noted.

Thirty-one (31) firearms were traced from acquisition through disposition from difference vendors (b)(4), with no discrepancies. There were no trafficking indicators or obliterated serial numbers uncovered during this investigation.

## 5 - ATF Forms 4473 - NICS & Other Dispositions
